Introduced by M. of A. ROZIC -- read once and referred to the Committee on Tourism, Parks, Arts and Sports Development

AN ACT to amend the general business law, in relation to the jurisdiction of the state athletic commission; and to amend the economic development law, in relation to the authorization of the department of economic development to give a preference to any tourist promotion agency that is promoting the sport of cricket

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Section 1004 of the general business law, as amended by a  
2 chapter of the laws of 2021 amending the general business law relat-  
3 ing to including the promotion and expansion of cricket in the state of  
4 New York to the jurisdiction of the state athletic commission, as  
5 proposed in legislative bills numbers S.146 and A.479, is amended to  
6 read as follows:

7 § 1004. Jurisdiction of the commission. [~~1.~~] The commission shall have  
8 and is hereby vested with the sole direction, management, control and  
9 jurisdiction over:

10 [~~(a)~~] 1. all authorized combative sports;

11 [~~(b)~~] 2. all licenses or permits granted by the commission to any and  
12 all persons or entities who participate in authorized combative sports;

13 [~~(c)~~] 3. all determinations regarding the authorization of amateur and  
14 professional sanctioning entities;

15 [~~(d)~~] 4. all gyms, clubs, training camps and other organizations that  
16 maintain training facilities to prepare persons for participation in  
17 authorized professional combative sports;

18 [~~(e)~~] 5. the promotion of professional wrestling exhibitions to the  
19 extent provided for in this article; and

20 [~~(f)~~] 6. all contracts directly related to the conduct of authorized  
21 professional combative sports in the state of New York.

22 [~~(g)~~] 7. All disclosures to the commission shall be deemed confiden-  
23 tial.

4 § 2. Subdivision (a) of section 161 of the economic development law,  
5 as amended by chapter 465 of the laws of 1981, is amended to read as  
6 follows:

7 (a) Encourage, facilitate and coordinate the planning and implementa-  
8 tion of programs to advertise, stimulate, promote and increase tourist  
9 travel, resort, vacation, culture and convention activities within the  
10 state and its regions with such flexibility as to bring about as effec-  
11 tive and economical a tourist promotion plan as possible. The department  
12 shall give a preference to any tourist promotion agency that is promot-  
13 ing the sport of cricket;

14 § 3. This act shall take effect on the same date and in the same  
15 manner as a chapter of the laws of 2021 amending the general business  
16 law relating to including the promotion and expansion of cricket in  
17 the state of New York to the jurisdiction of the state athletic  
18 commission, as proposed in legislative bills numbers S.146 and A.479;  
19 provided, however, that section two of this act shall take effect on the  
20 one hundred eightieth day after it shall have become a law.
