Introduced by M. of A. WOERNER -- read once and referred to the Committee on Health

AN ACT to amend the public health law, in relation to requiring every general hospital and nursing home to comply with Medicare and Medicaid conditions of participation for antimicrobial stewardship programs in health care facilities, including training requirements regarding antimicrobial resistance and infection prevention and control

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Section 2803-z of the public health law, as added by a  
2 chapter of the laws of 2021, amending the public health law relating to  
3 antimicrobial resistance prevention and education, as proposed in legis-  
4 lative bills numbers S. 2191 and A. 5847, is amended to read as follows:

5 § 2803-z. Antimicrobial resistance prevention and education. 1. Every  
6 general hospital and nursing home shall [~~establish and implement an~~  
7 ~~antimicrobial stewardship program that meets or exceeds~~] comply with and  
8 meet all applicable requirements of the federal Medicare and Medicaid  
9 conditions of participation for antimicrobial stewardship programs in  
10 health care facilities, including training requirements regarding anti-  
11 microbial resistance and infection prevention and control. Additionally,  
12 such program shall incorporate an ongoing process to measure the impact  
13 of the program, including review, at least annually, of antimicrobial  
14 utilization data with development of response plans for high or increas-  
15 ing utilization.
