The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. This act enacts into law major components of legislation which are necessary to implement the state fiscal plan for the 2022-2023 state fiscal year. Each component is wholly contained within a Part identified as Parts A through EE. The effective date for each particular provision contained within such Part is set forth in the last section of such Part. Any provision in any section contained within a Part, including the effective date of the Part, which makes a reference to a section "of this act", when used in connection with that particular component, shall be deemed to mean and refer to the corresponding section of the Part in which it is found. Section three of this act sets forth the general effective date of this act.

The effective date for each particular provision contained within such Subpart is set forth in the last section of such Subpart. Any provision in any section contained within a Subpart, including the effective date of the Subpart, which makes reference to a section "of this act", when used in connection with that particular component, shall be deemed to mean and refer to the corresponding section of the Subpart in which it is found. Section three of this act sets forth the general effective date of this act.

17 Section 1. Subdivision 1 of section 210-B of the tax law is amended by adding a new paragraph (a-1) to read as follows:

(a-1) For a taxpayer that is an eligible farmer, as defined in subdivision eleven of this section, the percentage to be used to compute the credit allowed under this subdivision shall be twenty percent for property described in subparagraph (i) of paragraph (b) of this subdivision that is principally used by the taxpayer in the production of goods by farming, agriculture, horticulture, floriculture or viticulture.

§ 2. Subsection (a) of section 606 of the tax law is amended by adding a new paragraph 1-a to read as follows:

(1-a) For a taxpayer that is an eligible farmer, as defined in subsection (n) of this section, the percentage to be used to compute the credit allowed under this subsection shall be twenty percent for property described in subparagraph (A) of paragraph two of this subsection that is principally used by the taxpayer in the production of goods by farming, agriculture, horticulture, floriculture or viticulture.

33 § 3. This act shall take effect immediately and apply to property 34 placed in service on or after April 1, 2022.

Section 1. Subsection (e) of section 42 of the tax law, as amended by section 1 of part FF of chapter 59 of the laws of 2021, is amended to read as follows:

For taxable years beginning on or after January first, two thousand twenty-one and before January first, two thousand [twenty-five] twenty-six, the amount of the credit allowed under this section shall be equal to the product of the total number of eligible farm employees and [six] twelve hundred dollars.

- § 2. Section 5 of part RR of chapter 60 of the laws of 2016 amending the tax law relating to creating a farm workforce retention credit, as amended by section 2 of part FF of chapter 59 of the laws of 2021, is amended to read as follows:

- (f) A taxpayer claiming the credit allowed under this section shall not be allowed to claim any other tax credit allowed under this chapter, except the credit allowed under section forty-two-a of this article, with respect to any eligible farm employee included in the total number of eligible farm employees used to determine the amount of the credit allowed under this section.

(a) Notwithstanding subdivision (f) of section forty-two of this article, a taxpayer that is a farm employer or an owner of a farm employer shall be eligible for a credit against the tax imposed under article nine-A or twenty-two of this chapter, pursuant to the provisions referenced in subdivision (h) of this section.

 - (2) Biodiesel means a minimum blend of eighty-five (85) percent biodiesel, defined as fuel manufactured from vegetable oils, animal fats, or other agricultural or other products or by-products, with petrodiesel fuel commonly used for heating systems.
- (3) Geothermal means a system that uses the ground or ground water as 44 a thermal energy source/sink to heat or cool a building or provide hot water within the building.
 - (d) The commissioner, in consultation with the New York state energy research and development authority, will develop an application process to certify the expenses necessary for the conversion and a taxpayer will not be eligible to claim the credit unless it has completed that application process and the application has been approved by the New York state energy research and development authority.
- 52 (e) Information sharing. The department, the department of environmental conservation and the New York state energy research and develop-53 ment authority shall be allowed and are directed to share and exchange 54 information regarding the information contained on the credit applica-55 tion for claiming the grade no. 6 heating oil conversion tax credit and 56

such information exchanged between the department, the department of environmental conservation and the New York state energy research and development authority shall not be subject to disclosure or inspection under the state's freedom of information law.

- 46 (f) Each of the following cities is authorized to preempt the taxes 47 imposed by the county in which it is located pursuant to the authority 48 of section twelve hundred ten of this article, to the extent of one-half 49 the maximum aggregate rate authorized under section twelve hundred ten 50 of this article, including the additional rate that the county in which 51 such city is located is authorized to impose: Auburn, in Cayuga county; 52 Cortland, in Cortland county; Gloversville and Johnstown, in Fulton county; Oneida, in Madison county; Oneonta, in Otsego county. As of the 53 54 date this subdivision takes effect, any such preemption by such a city in effect on such date shall continue in full force and effect until the 55 effective date of a local law, ordinance, or resolution adopted or

amended by the city to change such preemption. Any preemption by such a city pursuant to this subdivision that takes effect after the effective date of this subdivision shall be subject to the notice requirements in section twelve hundred twenty-three of this subpart and to the other requirements of this article.

Notwithstanding any contrary provision of law, (a) if 12 county of Oneida imposes sales and compensating use taxes at a rate which is one percent additional to the three percent rate authorized by 13 14 section twelve hundred ten of this article, as authorized by such 15 section, $\left[\frac{(a)}{a}\right]$ (i) where a city in such county imposes tax pursuant to authority of subdivision (a) of such section twelve hundred ten, 16 17 such county shall allocate, distribute and pay in cash quarterly to such city one-half of the net collections attributable to such additional one 18 19 percent rate of the county's taxes collected in such city's boundaries; 20 [(1) (ii) where a city in such county does not impose tax pursuant to 21 the authority of such subdivision (a) of such section twelve hundred 22 ten, such county shall allocate, distribute and pay in cash quarterly to such city not so imposing tax a portion of the net collections attribut-23 24 able to one-half of the county's additional one percent rate of tax 25 calculated on the basis of the ratio which such city's population bears the county's total population, such populations as determined in 26 27 accordance with the latest decennial federal census or special popu-28 lation census taken pursuant to section twenty of the general municipal law completed and published prior to the end of the quarter for which 29 30 the allocation is made, which special census must include the entire 31 area of the county; [and (e)] provided, however, that such county shall 32 dedicate the first one million five hundred thousand dollars of net 33 collections attributable to such additional one percent rate of tax received by such county after the county receives in the aggregate eigh-34 35 teen million five hundred thousand dollars of net collections from such 36 additional one percent rate of tax [imposed for any of the periods: 37 September first, two thousand twelve through August thirty-first, two thousand thirteen; September first, two thousand thirteen through August 38 39 thirty-first, two thousand fourteen; and September first, two thousand fourteen through August thirty-first, two thousand fifteen; September 40 first, two thousand fifteen through August thirty-first, two thousand 41 42 sixteen; and September first, two thousand sixteen through August thirty-first, two thousand seventeen; September first, two thousand seven-43 teen through August thirty-first, two thousand eighteen; September 44 45 first, two thousand eighteen through August thirty-first, two thousand 46 twenty; and September first, two thousand twenty through August thirty-47 first, two thousand twenty three, let an allocation on a per capita basis, utilizing figures from the latest decennial federal census or 48 49 special population census taken pursuant to section twenty of the gener-50 al municipal law, completed and published prior to the end of the year 51 for which such allocation is made, which special census must include the 52 entire area of such county, to be allocated and distributed among the 53 towns of Oneida county by appropriation of its board of legislators; provided, further, that nothing herein shall require such board of legislators to make any such appropriation until it has been notified by 55 56 any town by appropriate resolution and, in any case where there is a

village wholly or partly located within a town, a resolution of every such village, embodying the agreement of such town and village or villages upon the amount of such appropriation to be distributed to such village or villages out of the allocation to the town or towns in which it is located. (b) If the county of Oneida imposes sales and compensating use taxes at a rate which is one and three-quarters percent addi-tional to the three percent rate authorized by section twelve hundred ten of this article, as authorized pursuant to clause two of subpara-graph (i) of the opening paragraph of section twelve hundred ten of this article, net collections attributable to the additional three-quarters percent of such additional rate shall not be subject to any revenue distribution agreement entered into by the county and the cities in the county pursuant to the authority of subdivision (c) of section twelve hundred sixty-two of this part.

§ 9. The opening paragraph of section 1262-r of the tax law, as added by chapter 37 of the laws of 2006, is amended to read as follows:

- (2) Notwithstanding the provisions of subdivision (c) of section twelve hundred sixty-two of this part to the contrary, if the cities of Canandaigua and Geneva in the county of Ontario do not impose sales and compensating use taxes pursuant to the authority of section twelve hundred ten of this article and such cities and county enter into an agreement pursuant to the authority of subdivision (c) of section twelve hundred sixty-two of this part to be effective March first, two thousand six, such agreement may provide that:
- § 10. The tax law is amended by adding a new section 1262-v to read as follows:
- § 1262-v. Disposition of net collections from the additional rate of sales and compensating use tax in Clinton county. Notwithstanding any contrary provision of law, if the county of Clinton imposes the additional one percent rate of sales and compensating use taxes authorized pursuant to clause two of subparagraph (i) of the opening paragraph of section twelve hundred ten of this article, net collections from such additional rate shall be paid to the county and the county shall set aside such net collections and use them solely for county purposes. Such net collections shall not be subject to any revenue distribution agreement entered into by the county and the city in the county pursuant to the authority of subdivision (c) of section twelve hundred sixty-two of this part.

sales and compensating use taxes additional to the three percent rate authorized by section twelve hundred ten of this article as authorized by [section twelve hundred ten-E] clause two of subparagraph (i) of the opening paragraph of section twelve hundred ten of this article [for all 5 or any portion of the period beginning December first, two thousand seven and ending November thirtieth, two thousand twenty-three], the 7 county shall use all net collections [from such attributable to the additional one-quarter [of one pay 9 the county's expenses for the construction of additional correctional 10 facilities. Notwithstanding any provision of law to the contrary: (a) any reference in any section of this chapter or other law, or in any local law, ordinance, or resolution adopted pursuant to the authority of this article, to net collections or revenues from a tax imposed by a county or city pursuant to the authority of a clause, or to a subclause of a clause, of subparagraph (i) or (ii) of the opening paragraph of section twelve hundred ten of this article repealed by section one or two of a part of a chapter of the laws of two thousand twenty-two that added this section or pursuant to section twelve hundred ten-E of this article repealed by section five of such part shall be deemed to be a reference to net collections or revenues from a tax imposed by that county or city pursuant to the authority of the equivalent provision of clause two of subparagraph (i) or to subparagraph (ii) of the opening paragraph of such section twelve hundred ten as added by such section one or two of such part of a chapter of the laws of two thousand twenty-two; (b) any reference in this chapter or in any other law relating to the expiration of a provision concerning the distribution of revenue from the taxes authorized to be imposed by the opening paragraph of section twelve hundred ten of this article shall be disregarded, and such provision shall continue in effect unless later amended or repealed.

§ 13. This act shall take effect immediately.

Subdivision (c) of section 1101 of the tax law, as added by chapter 93 of the laws of 1965, paragraphs 2, 3, 4 and 6 as amended by section 2 and paragraph 8 as added by section 3 of part AA of chapter 57 of the laws of 2010, and paragraph 5 as amended by chapter 575 of the laws of 1965, is amended to read as follows:

- 49 (c) When used in this article for the purposes of the tax imposed 50 under subdivision (e) of section eleven hundred five of this article, 51 the following terms shall mean:
- 52 (1) Hotel. A building or portion of it which is regularly used and 53 kept open as such for the lodging of guests. The term "hotel" includes

an apartment hotel, a motel, boarding house or club, whether or not meals are served.

- (2) Occupancy. The use or possession, or the right to the use or possession, of any room in a hotel <u>or vacation rental</u>. "Right to the use or possession" includes the rights of a room remarketer as described in paragraph eight of this subdivision.
- (3) Occupant. A person who, for a consideration, uses, possesses, or has the right to use or possess, any room in a hotel <u>or vacation rental</u> under any lease, concession, permit, right of access, license to use or other agreement, or otherwise. "Right to use or possess" includes the rights of a room remarketer as described in paragraph eight of this subdivision.
- (4) Operator. Any person operating a hotel <u>or vacation rental</u>. Such term shall include a room remarketer and such room remarketer shall be deemed to operate a hotel, or portion thereof, with respect to which such person has the rights of a room remarketer.
- (5) Permanent resident. Any occupant of any room or rooms in a hotel <u>or vacation rental</u> for at least ninety consecutive days shall be considered a permanent resident with regard to the period of such occupancy.
- (6) Rent. The consideration received for occupancy, including any service or other charge or amount required to be paid as a condition for occupancy, valued in money, whether received in money or otherwise and whether received by the operator or a room remarketer or another person on behalf of either of them.
- (7) Room. Any room or rooms of any kind in any part or portion of a hotel <u>or vacation rental</u>, which is available for or let out for any purpose other than a place of assembly.
- (8) Room remarketer. A person who reserves, arranges for, conveys, or furnishes occupancy, whether directly or indirectly, to an occupant for rent in <u>a hotel for</u> an amount determined by the room remarketer, directly or indirectly, whether pursuant to a written or other agreement. Such person's ability or authority to reserve, arrange for, convey, or furnish occupancy, directly or indirectly, and to determine rent therefor, shall be the "rights of a room remarketer". A room remarketer is not a permanent resident with respect to a room for which such person has the rights of a room remarketer.
- (9) Vacation rental. A building or portion of it that is used for the lodging of guests. The term "vacation rental" includes a house, an apartment, a condominium, a cooperative unit, a cabin, a cottage, or a bungalow, or one or more rooms therein, where sleeping accommodations are provided for the lodging of paying occupants, the typical occupants are transients or travelers, and the relationship between the operator and occupant is not that of a landlord and tenant. It is not necessary that meals are served. A building or portion of a building may qualify as a vacation rental whether or not amenities, including but not limited to daily housekeeping services, concierge services, or linen services, are provided.
- (10) (i) Vacation rental marketplace provider. A person who, pursuant to an agreement with an operator, facilitates the occupancy of a vacation rental by such operator or operators. A person "facilitates the occupancy of a vacation rental" for purposes of this paragraph when the person meets both of the following conditions: (A) such person provides the forum in which, or by means of which, the sale of the occupancy takes place or the offer of such sale is accepted, including a shop, store, or booth, an internet website, catalog, or similar forum; and (B) such person or an affiliate of such person collects the rent paid by a

customer to an operator for the occupancy of a vacation rental, or contracts with a third party to collect such rent.

- (ii) For the purposes of this article, the term "vacation rental marketplace provider" shall not include a "room remarketer" as defined in paragraph eight of this subdivision. For purposes of this paragraph, persons are affiliated if one person has an ownership interest of more than five percent, whether direct or indirect, in another, or where an ownership interest of more than five percent, whether direct or indirect, is held in each of such persons by another person or by a group of other persons that are affiliated persons with respect to each other. The term "vacation rental marketplace provider" shall not include a "real estate broker" as licensed under article twelve-A of the real property law.
- § 2. Subdivision (a) of section 1104 of the tax law, as added by chapter 3 of the laws of 2004, is amended to read as follows:
- (a) Imposition. In addition to any other fee or tax imposed by this article or any other law, on and after April first, two thousand five, there is hereby imposed within the territorial limits of a city with a population of a million or more and there shall be paid a unit fee on every occupancy of a unit in a hotel <u>or vacation rental</u> in such city at the rate of one dollar and fifty cents per unit per day, except that such unit fee shall not be imposed upon (1) occupancy by a permanent resident or (2) where the rent per unit is not more than at the rate of two dollars per day.
- § 3. Paragraph 1 of subdivision (e) of section 1105 of the tax law, as amended by section 1 of part Q of chapter 59 of the laws of 2012, is amended to read as follows:
- (1) The rent for every occupancy of a room or rooms in a hotel <u>and vacation rental</u> in this state, except that the tax shall not be imposed upon (i) a permanent resident, or (ii) where the rent is not more than at the rate of two dollars per day.
- § 4. Subdivisions 1 and 2 of section 1131 of the tax law, subdivision 1 as amended by section 2 of part G of chapter 59 of the laws of 2019 and subdivision 2 as added by chapter 93 of the laws of 1965, are amended to read as follows:
- (1) "Persons required to collect tax" or "person required to collect any tax imposed by this article " shall include: every vendor of tangible personal property or services; every recipient of amusement charges; every operator of a hotel or vacation rental; every vacation rental marketplace provider with respect to the rent for every occupancy of a vacation rental it facilitates as described in paragraph ten of subdivision (c) of section eleven hundred one of this article; and every marketplace provider with respect to sales of tangible personal property facilitates as described in paragraph one of subdivision (e) of section eleven hundred one of this article. Said terms shall also include any officer, director or employee of a corporation or of a dissolved corporation, any employee of a partnership, any employee or manager of a limited liability company, or any employee of an individual proprietorship who as such officer, director, employee or manager is under a duty to act for such corporation, partnership, limited liability company or individual proprietorship in complying with any requirement of this article, or has so acted; and any member of a partnership or limited liability company. Provided, however, that any person who is a vendor solely by reason of clause (D) or (E) of subparagraph (i) of paragraph [48] eight of subdivision (b) of section eleven hundred one this article shall not be a "person required to collect any tax

imposed by this article" until twenty days after the date by which such person is required to file a certificate of registration pursuant to section eleven hundred thirty-four of this part. Such terms shall not include an operator of a vacation rental who rents out the operator's own property for three days or fewer in a calendar year and does not use a vacation rental marketplace provider to facilitate such rental.

- (2) "Customer" shall include: every purchaser of tangible personal property or services; every patron paying or liable for the payment of any amusement charge; and every occupant of a room or rooms in a hotel or vacation rental.
- § 5. Section 1132 of the tax law is amended by adding a new subdivision (m) to read as follows:

(m)(1) A vacation rental marketplace provider with respect to a sale for every occupancy of a vacation rental it facilitates: (A) shall have all the obligations and rights of a vendor under this article and article twenty-nine of this chapter and under any regulations adopted pursuant thereto, including, but not limited to, the duty to obtain a certificate of authority, to collect tax, file returns, remit tax, and the right to accept a certificate or other documentation from a customer substantiating an exemption or exclusion from tax, the right to receive the refund authorized by subdivision (e) of this section and the credit allowed by subdivision (f) of section eleven hundred thirty-seven of this part subject to the provisions of such subdivisions; and (B) shall keep such records and information and cooperate with the commissioner to ensure the proper collection and remittance of tax imposed, collected or required to be collected under this article and article twenty-nine of this chapter.

(2) An operator is relieved from the duty to collect tax in regard to a particular rent for the occupancy of a vacation rental subject to tax under subdivision (e) of section eleven hundred five of this article and shall not include the rent from such occupancy in its taxable sales for purposes of section eleven hundred thirty-six of this part if, in regard to such occupancy: (A) the operator of the vacation rental can show that such occupancy was facilitated by a vacation rental marketplace provider from whom such operator has received in good faith a properly completed certificate of collection in a form prescribed by the commissioner, certifying that the vacation rental marketplace provider is registered to collect sales tax and will collect sales tax on all taxable sales of occupancy of a vacation rental by the operator facilitated by the vacation rental marketplace provider, and with such other information as the commissioner may prescribe; and (B) any failure of the vacation rental marketplace provider to collect the proper amount of tax in regard to such sale was not the result of such operator providing the vacation rental marketplace provider with incorrect information. This provision shall be administered in a manner consistent with subparagraph (i) of paragraph one of subdivision (c) of this section as if a certificate of collection were a resale or exemption certificate for purposes of such subparagraph, including with regard to the completeness of such certificate of collection and the timing of its acceptance by the operator. Provided that, with regard to any sales of occupancy of a vacation rental by an operator that are facilitated by a vacation rental marketplace provider who is affiliated with such operator within the meaning of paragraph ten of subdivision (c) of section eleven hundred one of this article, the operator shall be deemed liable as a person under a duty to act for such vacation rental marketplace provider for purposes

of subdivision one of section eleven hundred thirty-one of this part.

- (3) The commissioner may, at his or her discretion: (A) develop a standard provision, or approve a provision developed by a vacation rental marketplace provider provider obligates itself to collect the tax on behalf of all operators for whom the vacation rental marketplace provider facilitates sales of occupancy of a vacation rental, with respect to all sales that it facilitates for such operators where the rental occurs in the state; and (B) provide by regulation or otherwise that the inclusion of such provision in the publicly-available agreement between the vacation rental marketplace provider and operator will have the same effect as an operator's acceptance of a certificate of collection from such vacation rental marketplace provider under paragraph two of this subdivision.
- § 6. Section 1133 of the tax law is amended by adding a new subdivision (g) to read as follows:
- (g) A vacation rental marketplace provider is relieved of liability under this section for failure to collect the correct amount of tax to the extent that the vacation rental marketplace provider can show that the error was due to incorrect or insufficient information given to the vacation rental marketplace provider by the operator. Provided, however, this subdivision shall not apply if the operator and vacation rental marketplace provider are affiliated within the meaning of paragraph ten of subdivision (c) of section eleven hundred one of this article.
- § 7. Subdivision (a) of section 1134 of the tax law is amended by adding a new paragraph 7 to read as follows:
- (7) An operator of a vacation rental, as defined in paragraph nine of subdivision (c) of section eleven hundred one of this article, is relieved of the requirement to register in paragraph one of this subdivision if its sales of occupancy are wholly facilitated by one or more vacation rental marketplace providers from whom the operator has received in good faith a certificate of collection that meets the requirements set forth in paragraph two of subdivision (m) of section eleven hundred thirty-two of this part.
- § 8. Paragraph 4 of subdivision (a) of section 1136 of the tax law, as amended by section 5 of part G of chapter 59 of the laws of 2019, is amended to read as follows:
- The return of a vendor of tangible personal property or services shall show such vendor's receipts from sales and the number of gallons of any motor fuel or diesel motor fuel sold and also the aggregate value of tangible personal property and services and number of gallons of such fuels sold by the vendor, the use of which is subject to tax under this article, and the amount of tax payable thereon pursuant to the provisions of section eleven hundred thirty-seven of this part. The return of a recipient of amusement charges shall show all such charges and the amount of tax thereon, and the return of an operator required to collect tax on rents shall show all rents received or charged and the amount of tax thereon. The return of a marketplace seller shall exclude the receipts from a sale of tangible personal property facilitated by a marketplace provider if, in regard to such sale: (A) the marketplace seller has timely received in good faith a properly completed certificate of collection from the marketplace provider or the marketplace provider has included a provision approved by the commissioner in the publicly-available agreement between the marketplace provider and the marketplace seller as described in subdivision one of section eleven hundred thirty-two of this part, and (B) the information provided by the marketplace seller to the marketplace provider about such tangible personal property is accurate. The return of an operator shall exclude

the rent from occupancy of a vacation rental facilitated by a vacation rental marketplace provider if, in regard to such sale: (A) the vacation rental operator has timely received in good faith a properly completed certificate of collection from the vacation rental marketplace provider or the vacation rental marketplace provider has included a provision approved by the commissioner in the publicly-available agreement between the vacation rental marketplace provider and the operator as described in subdivision (m) of section eleven hundred thirty-two of this part, and (B) the information provided by the operator to the vacation rental marketplace provider about such rent and such occupancy is accurate.

If such determination is identi-33 cal to or arises out of a previously issued determination of tax of the 34 corporation, dissolved corporation, partnership or individual proprie-35 torship for which such person is under a duty to act, an application 36 filed with the division of tax appeals on behalf of the corporation, 37 dissolved corporation, partnership or individual proprietorship shall be deemed to include any and all subsequently issued personal determi-39 nations and a separate application to the division of tax appeals for a hearing shall not be required. The [tax commission] commissioner may, 40 nevertheless, of [its] his or her own motion, redetermine such determi-41 nation of tax or liability for tax. Where the [tax commission] commis-42 43 sioner determines or redetermines that the amount of tax claimed to be 44 due from a vendor of tangible personal property or services, a recipient 45 of amusement charges, or an operator of a hotel or vacation rental is 46 erroneous or excessive in whole or in part, [it] he or she shall rede-47 termine the amount of tax properly due from any such person as a person 48 required to collect tax with respect to such vendor, recipient, or oper-49 ator, and if such amount is less than the amount of tax for which such person would have been liable in the absence of such determination or 50 51 redetermination, [it he or she shall reduce such liability accordingly. 52 Furthermore, the [tax commission] commissioner may, of [its] his or her own motion, abate on behalf of any such person, any part of the tax 53 determined to be erroneous or excessive whether or not such tax had become finally and irrevocably fixed with respect to such person but no 55 claim for abatement may be filed by any such person. The provisions of

this paragraph shall not be construed to limit in any manner the powers the attorney general under subdivision (a) of section eleven hundred forty-one of this part or the powers of the [tax commission] commissioner to issue a warrant under subdivision (b) of such section against any person whose liability has become finally and irrevocably fixed.

It shall be an affirmative 7 defense that such person performed the acts described in this subdivision without knowledge of such determination. Any person who violates a 9 provision of this subdivision, upon conviction, shall be subject to a 10 fine in any amount authorized by this article, but not less than five 11 hundred dollars, in addition to any other penalty provided by law.

In such cases, the enforcing officer shall not be obliged to obtain in personam jurisdiction over a personal representative of the decedent's estate; provided, however, that nothing contained herein shall be construed to relieve the enforcing officer of the obligation to cause a notice to be mailed to any persons whose interests in the property are reasonably ascertainable from the records of the surrogate of the county, as provided by subparagraph (i) of paragraph (a) of subdivision one of section eleven hundred twenty-five of this title.

- (e) Actions or proceedings that challenge the validity and accuracy of the appraisal model or discount rates established under this section may not be commenced against assessing units. Such challenges may only be brought by commencing an action against the commissioner in the third department of the appellate division of the supreme court in the manner provided by article seventy-eight of the civil practice law and rules.

- (2) Region two shall consist of Bronx, Kings, New York, Queens and Richmond counties[. No gaming facility shall be authorized in region two]; and

This right shall be incorporated into the license itself, vest upon the opening of a gaming facility in zone one or in the same region as the licensee and entitle the holder of such license to bring an action in the court of claims to recover the license fee paid pursuant to section one thousand three hundred fifteen of this [article] title in the event that any gaming facility license in excess of the number authorized by this section as of the effective date of this section is awarded within seven years from the date that the initial gaming facility license is awarded. This right to recover any such fee shall be

proportionate to the length of the respective period that is still remaining upon the vesting of such right.

Additionally, the right to bring an action in the court of claims to 4 recover the fee paid to the state on the twenty-fourth day of September, 5 two thousand ten, by the operator of a video lottery gaming facility in a city of more than one million shall vest with such operator upon the 7 opening of any gaming facility licensed by the commission in zone one within seven years from the date that the initial gaming facility 9 license is awarded; provided however that the amount recoverable shall 10 be limited to the pro rata amount of the time remaining until the end of 11 the seven year exclusivity period, proportionate to the period of time 12 between the date of opening of the video lottery facility until the 13 conclusion of the seven year period.

Requests for applications shall be handled in the same manner as provided for in section thirteen hundred twelve of this article for gaming licenses authorized but not awarded, provided however that any requests for applications for gaming facility licenses authorized but not awarded may be for gaming facility licenses in any region in zone one or in regions one, two and five in zone two.

- (j) mitigating potential impacts on host and nearby municipalities 14 15 which might result from the development or operation of the gaming facility; 16
- 17 (k) carefully considering local views and consulting with appropriate local governments; 18
- (1) operating in partnership with and promoting local hotels, restau-20 rants and retail facilities so that patrons experience the full diversi-21 fied regional tourism industry;
 - (m) establishing a fair and reasonable partnership with live entertainment venues that may be impacted by a gaming facility under which the gaming facility actively supports the mission and the operation of the impacted entertainment venues;
 - (n) implementing a workforce development plan that utilizes the existing labor force, including the estimated number of construction jobs a proposed gaming facility will generate, the development of workforce training programs that serve the unemployed and methods for accessing employment at the gaming facility;
- 31 (o) taking additional measures to address problem gambling including, 32 but not limited to, training of gaming employees to identify patrons 33 exhibiting problems with gambling;
- 34 (p) utilizing sustainable development principles including, but not 35 limited to:
- 36 (1) having new and renovation construction certified under the appro-37 priate certification category in the Leadership in Energy and Environmental Design Green Building Rating System created by the United States 38 Green Building Council; 39
 - (2) efforts to mitigate vehicle trips;

Section 1. Paragraph (a) of subdivision 1 of section 1003 of the racing, pari-mutuel wagering and breeding law, as amended by section 1 of part DD of chapter 59 of the laws of 2021, is amended to read as follows:

(a) Any racing association or corporation or regional off-track betting corporation, authorized to conduct pari-mutuel wagering under this chapter, desiring to display the simulcast of horse races on which pari-mutuel betting shall be permitted in the manner and subject to the conditions provided for in this article may apply to the commission for 54 a license so to do. Applications for licenses shall be in such form as

may be prescribed by the commission and shall contain such information or other material or evidence as the commission may require. No license shall be issued by the commission authorizing the simulcast transmission thoroughbred races from a track located in Suffolk county. The fee 4 5 for such licenses shall be five hundred dollars per simulcast facility and for account wagering licensees that do not operate either a simul-7 cast facility that is open to the public within the state of New York or a licensed racetrack within the state, twenty thousand dollars per year 9 payable by the licensee to the commission for deposit into the general 10 fund. Except as provided in this section, the commission shall not 11 approve any application to conduct simulcasting into individual or group 12 residences, homes or other areas for the purposes of or in connection with pari-mutuel wagering. The commission may approve simulcasting into 13 14 residences, homes or other areas to be conducted jointly by one or more 15 regional off-track betting corporations and one or more of the follow-16 a franchised corporation, thoroughbred racing corporation or a 17 harness racing corporation or association; provided (i) the simulcasting consists only of those races on which pari-mutuel betting is authorized 18 19 by this chapter at one or more simulcast facilities for each of the contracting off-track betting corporations which shall include wagers 20 21 made in accordance with section one thousand fifteen, one thousand 22 sixteen and one thousand seventeen of this article; provided further 23 that the contract provisions or other simulcast arrangements for such simulcast facility shall be no less favorable than those in effect on 24 25 January first, two thousand five; (ii) that each off-track betting 26 corporation having within its geographic boundaries such residences, 27 homes or other areas technically capable of receiving the simulcast 28 signal shall be a contracting party; (iii) the distribution of revenues 29 shall be subject to contractual agreement of the parties except that 30 statutory payments to non-contracting parties, if any, may not be reduced; provided, however, that nothing herein to the contrary shall 31 32 prevent a track from televising its races on an irregular basis primari-33 ly for promotional or marketing purposes as found by the commission. For 34 purposes of this paragraph, the provisions of section one thousand thirteen of this article shall not apply. Any agreement authorizing an 35 36 in-home simulcasting experiment commencing prior to May fifteenth, nine-37 teen hundred ninety-five, may, and all its terms, be extended until June 38 thirtieth, two thousand [twenty-two] twenty-three; provided, however, 39 that any party to such agreement may elect to terminate such agreement 40 upon conveying written notice to all other parties of such agreement at least forty-five days prior to the effective date of the termination, 41 42 via registered mail. (iii) Of the sums retained by a receiving track located in Westchester county on races received from a franchised corporation, for the period commencing January first, two thousand eight and continuing through June thirtieth, two thousand [twenty-two] twenty-three, the amount used

exclusively for purses to be awarded at races conducted by such receiving track shall be computed as follows: of the sums so retained, two and one-half percent of the total pools. Such amount shall be increased or decreased in the amount of fifty percent of the difference in total commissions determined by comparing the total commissions available after July twenty-first, nineteen hundred ninety-five to the total commissions that would have been available to such track prior to July twenty-first, nineteen hundred ninety-five.

3. The opening paragraph of subdivision 1 of section 1014 of the racing, pari-mutuel wagering and breeding law, as amended by section 3 of part DD of chapter 59 of the laws of 2021, is amended to read as follows:

The provisions of this section shall govern the simulcasting of races conducted at thoroughbred tracks located in another state or country on any day during which a franchised corporation is conducting a race meeting in Saratoga county at Saratoga thoroughbred racetrack until June thirtieth, two thousand [twenty-two] twenty-three and on any day regardless of whether or not a franchised corporation is conducting a race meeting in Saratoga county at Saratoga thoroughbred racetrack after June thirtieth, two thousand [twenty-two] twenty-three. On any day on which a franchised corporation has not scheduled a racing program but a 22 thoroughbred racing corporation located within the state is conducting racing, each off-track betting corporation branch office and each simul-23 casting facility licensed in accordance with section one thousand seven (that has entered into a written agreement with such facility's representative horsemen's organization, as approved by the commission), one thousand eight, or one thousand nine of this article shall be authorized to accept wagers and display the live simulcast signal from thoroughbred tracks located in another state or foreign country subject to the following provisions:

- § 4. Subdivision 1 of section 1015 of the racing, pari-mutuel wagering and breeding law, as amended by section 4 of part DD of chapter 59 the laws of 2021, is amended to read as follows:
- The provisions of this section shall govern the simulcasting of races conducted at harness tracks located in another state or country during the period July first, nineteen hundred ninety-four through June thirtieth, two thousand [twenty-two] twenty-three. This section shall supersede all inconsistent provisions of this chapter.
- § 5. The opening paragraph of subdivision 1 of section 1016 of the racing, pari-mutuel wagering and breeding law, as amended by section 5 of part DD of chapter 59 of the laws of 2021, is amended to read as follows:

The provisions of this section shall govern the simulcasting of races conducted at thoroughbred tracks located in another state or country on any day during which a franchised corporation is not conducting a race meeting in Saratoga county at Saratoga thoroughbred racetrack until June thirtieth, two thousand [twenty-two] twenty-three. Every off-track betting corporation branch office and every simulcasting facility licensed in accordance with section one thousand seven that have entered into a written agreement with such facility's representative horsemen's organization as approved by the commission, one thousand eight or one thousand nine of this article shall be authorized to accept wagers and display the live full-card simulcast signal of thoroughbred tracks (which may include quarter horse or mixed meetings provided that all such wagering on such races shall be construed to be thoroughbred races) 55 located in another state or foreign country, subject to the following provisions; provided, however, no such written agreement shall be required of a franchised corporation licensed in accordance with section one thousand seven of this article:

§ 6. The opening paragraph of section 1018 of the racing, pari-mutuel wagering and breeding law, as amended by section 6 of part DD of chapter 59 of the laws of 2021, is amended to read as follows:

7 Notwithstanding any other provision of this chapter, for the period 8 July twenty-fifth, two thousand one through September eighth, two thousand [twenty-one] twenty-two, when a franchised corporation is conduct-9 10 ing a race meeting within the state at Saratoga Race Course, every off-11 track betting corporation branch office and every simulcasting facility 12 licensed in accordance with section one thousand seven (that has entered into a written agreement with such facility's representative horsemen's 13 14 organization as approved by the commission), one thousand eight or one 15 thousand nine of this article shall be authorized to accept wagers and display the live simulcast signal from thoroughbred tracks located in 16 17 another state, provided that such facility shall accept wagers on races run at all in-state thoroughbred tracks which are conducting racing 18 19 programs subject to the following provisions; provided, however, no such 20 written agreement shall be required of a franchised corporation licensed 21 in accordance with section one thousand seven of this article.

- Section 32 of chapter 281 of the laws of 1994, amending the racing, pari-mutuel wagering and breeding law and other laws relating to simulcasting, as amended by section 7 of part DD of chapter 59 of the laws of 2021, is amended to read as follows:
- 32. This act shall take effect immediately and the pari-mutuel tax reductions in section six of this act shall expire and be deemed repealed on July 1, [2022] 2023; provided, however, that nothing contained herein shall be deemed to affect the application, qualificaexpiration, or repeal of any provision of law amended by any section of this act, and such provisions shall be applied or qualified shall expire or be deemed repealed in the same manner, to the same extent and on the same date as the case may be as otherwise provided by law; provided further, however, that sections twenty-three and twentyfive of this act shall remain in full force and effect only until May 1, 1997 and at such time shall be deemed to be repealed.
- § 8. Section 54 of chapter 346 of the laws of amending the 1990, racing, pari-mutuel wagering and breeding law and other laws relating to simulcasting and the imposition of certain taxes, as amended by section 8 of part DD of chapter 59 of the laws of 2021, is amended to read as follows:
- 54. This act shall take effect immediately; provided, however, S sections three through twelve of this act shall take effect on January 1, 1991, and section 1013 of the racing, pari-mutuel wagering and breeding law, as added by section thirty-eight of this act, shall expire and be deemed repealed on July 1, [2022] 2023; and section eighteen of this act shall take effect on July 1, 2008 and sections fifty-one and fiftytwo of this act shall take effect as of the same date as chapter 772 of the laws of 1989 took effect.
- § 9. Paragraph (a) of subdivision 1 of section 238 of the racing, pari-mutuel wagering and breeding law, as amended by section 9 of part DD of chapter 59 of the laws of 2021, is amended to read as follows:
- The franchised corporation authorized under this chapter to conduct pari-mutuel betting at a race meeting or races run thereat shall distribute all sums deposited in any pari-mutuel pool to the holders of 56 winning tickets therein, provided such tickets are presented for payment

1 before April first of the year following the year of their purchase, 2 less an amount that shall be established and retained by such franchised 3 corporation of between twelve to seventeen percent of the total deposits 4 in pools resulting from on-track regular bets, and fourteen to twenty-5 one percent of the total deposits in pools resulting from on-track 6 multiple bets and fifteen to twenty-five percent of the total deposits 7 in pools resulting from on-track exotic bets and fifteen to thirty-six 8 percent of the total deposits in pools resulting from on-track super 9 exotic bets, plus the breaks. The retention rate to be established is 10 subject to the prior approval of the commission.

11 Such rate may not be changed more than once per calendar quarter to be 12 effective on the first day of the calendar quarter. "Exotic bets" and "multiple bets" shall have the meanings set forth in section five 13 hundred nineteen of this chapter. "Super exotic bets" shall have the 14 15 meaning set forth in section three hundred one of this chapter. For purposes of this section, a "pick six bet" shall mean a single bet or 16 17 wager on the outcomes of six races. The breaks are hereby defined as the odd cents over any multiple of five for payoffs greater than one dollar 18 five cents but less than five dollars, over any multiple of ten for 19 20 payoffs greater than five dollars but less than twenty-five dollars, 21 over any multiple of twenty-five for payoffs greater than twenty-five dollars but less than two hundred fifty dollars, or over any multiple of fifty for payoffs over two hundred fifty dollars. Out of the amount so 23 retained there shall be paid by such franchised corporation to the 24 25 commissioner of taxation and finance, as a reasonable tax by the state 26 for the privilege of conducting pari-mutuel betting on the races run at 27 the race meetings held by such franchised corporation, the following 28 percentages of the total pool for regular and multiple bets five percent 29 of regular bets and four percent of multiple bets plus twenty percent of 30 the breaks; for exotic wagers seven and one-half percent plus twenty 31 percent of the breaks, and for super exotic bets seven and one-half 32 percent plus fifty percent of the breaks.

For the period April first, two thousand one through December thirty-first, two thousand [twenty-two] twenty-three, such tax on all wagers shall be one and six-tenths percent, plus, in each such period, twenty percent of the breaks. Payment to the New York state thoroughbred breeding and development fund by such franchised corporation shall be one-half of one percent of total daily on-track pari-mutuel pools resulting from regular, multiple and exotic bets and three percent of super exotic bets and for the period April first, two thousand one through December thirty-first, two thousand [twenty-two] twenty-three, such payment shall be seven-tenths of one percent of regular, multiple and exotic pools.

§ 10. This act shall take effect immediately.

§ 2. Severability clause. If any clause, sentence, paragraph, subdivision, section or part of this act shall be adjudged by any court of competent jurisdiction to be invalid, such judgment shall not affect, impair, or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, section or part thereof directly involved in the controversy in which such judgment shall have been rendered. It is hereby declared to be the intent of the legislature that this act would have been enacted even if such invalid provisions had not been included herein.

§ 3. This act shall take effect immediately provided, however, that the applicable effective date of Parts A through EE of this act shall be as specifically set forth in the last section of such Parts.
