The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. This act enacts into law major components of legislation
 2 which are necessary to implement the state fiscal plan for the 2022-2023
 3 state fiscal year. Each component is wholly contained within a Part
 4 identified as Parts A through EE. The effective date for each particular
 5 provision contained within such Part is set forth in the last section of
 6 such Part. Any provision in any section contained within a Part,
 7 including the effective date of the Part, which makes a reference to a
 8 section "of this act", when used in connection with that particular
 9 component, shall be deemed to mean and refer to the corresponding
 10 section of the Part in which it is found. Section three of this act sets
 11 forth the general effective date of this act.

6 Section 1. This act enacts into law components of legislation relating
7 to certain tax credits. Each component is wholly contained within a
8 Subpart identified as Subparts A through C. The effective date for each
9 particular provision contained within such Subpart is set forth in the
10 last section of such Subpart. Any provision in any section contained
11 within a Subpart, including the effective date of the Subpart, which
12 makes reference to a section "of this act", when used in connection with
13 that particular component, shall be deemed to mean and refer to the
14 corresponding section of the Subpart in which it is found. Section three
15 of this act sets forth the general effective date of this act.

16 SUBPART A

17 Section 1. Subdivision 1 of section 210-B of the tax law is amended by
18 adding a new paragraph (a-1) to read as follows:

19 (a-1) For a taxpayer that is an eligible farmer, as defined in subdivi-
20 vision eleven of this section, the percentage to be used to compute the
21 credit allowed under this subdivision shall be twenty percent for prop-
22 erty described in subparagraph (i) of paragraph (b) of this subdivision
23 that is principally used by the taxpayer in the production of goods by
24 farming, agriculture, horticulture, floriculture or viticulture.

25 § 2. Subsection (a) of section 606 of the tax law is amended by adding
26 a new paragraph 1-a to read as follows:

27 (1-a) For a taxpayer that is an eligible farmer, as defined in
28 subsection (n) of this section, the percentage to be used to compute the
29 credit allowed under this subsection shall be twenty percent for proper-
30 ty described in subparagraph (A) of paragraph two of this subsection
31 that is principally used by the taxpayer in the production of goods by
32 farming, agriculture, horticulture, floriculture or viticulture.

33 § 3. This act shall take effect immediately and apply to property
34 placed in service on or after April 1, 2022.

20 Section 1. Subdivision (f) of section 42 of the tax law, as added by

 9 licensed farm winery as provided for in article six of the alcoholic
 10 beverage control law, or from the sale of cider from a licensed farm
 11 cidery as provided for in section fifty-eight-c of the alcoholic bever-
 12 age control law, then an eligible farm employee of such eligible farmer
 13 shall be included for purposes of calculating the amount of credit
 14 allowed under this section only if such eligible farm employee is
 15 employed by such eligible farmer on qualified agricultural property as

18 (g) The amount of the credit allowed under this section shall be equal
 19 to the aggregate amount of such credit allowed per eligible farm employ-

27 policy, to provide critical assistance to small businesses to comply
28 with public health or other emergency orders or regulations, and to take
29 infectious disease mitigation measures related to the COVID-19 pandemic.
30 The COVID-19 capital costs tax credit program is created to provide
31 financial assistance to economically harmed businesses to offer relief

7 equipment and/or materials and supplies for new product lines in
8 response to the COVID-19 pandemic; (xi) software for online payment
9 platforms to enable delivery or contactless purchases; (xii) building
10 construction and retrofits to accommodate social distancing and instal-
11 lation of air purifying equipment but not for costs for non-COVID-19
12 pandemic related capital renovations or general "closed for renovations"
13 upgrades; (xiii) machinery and equipment to accommodate contactless
14 sales; (xiv) materials to accommodate increased outdoor activity such as
15 heat lamps, outdoor lighting, and materials related to outdoor space
16 expansions; and (xv) other costs as determined by the department to be
17 eligible under this section; provided, however, that "qualified COVID-19
18 capital costs" do not include any cost paid for with other COVID-19
19 grant funds as determined by the commissioner.

20 § 483. Eligibility criteria. 1. To be eligible for a tax credit under
21 the COVID-19 capital costs tax credit program, a business entity must:

 51 the budget. In determining whether the New York city tourism economy has
 52 sufficiently recovered, the department of economic development will
 53 perform an analysis of key New York city economic indicators which shall
 54 include, but not be limited to, hotel occupancy rates and travel

1 metrics. The department of economic development's analysis shall also be
2 informed by the status of any remaining COVID-19 restrictions affecting
3 New York city musical and theatrical productions. In no event shall a
4 qualified New York city musical and theatrical production be eligible
5 for more than one credit under this program.

43 (3) Geothermal means a system that uses the ground or ground water as
44 a thermal energy source/sink to heat or cool a building or provide hot
45 water within the building.

46 (d) The commissioner, in consultation with the New York state energy
47 research and development authority, will develop an application process
48 to certify the expenses necessary for the conversion and a taxpayer will
49 not be eligible to claim the credit unless it has completed that appli-
50 cation process and the application has been approved by the New York
51 state energy research and development authority.

52 (e) Information sharing. The department, the department of environ-
53 mental conservation and the New York state energy research and develop-
54 ment authority shall be allowed and are directed to share and exchange
55 information regarding the information contained on the credit applica-

43 en will cover tax incentives allocated in two thousand twenty-three.
44 Program twelve will cover tax incentives allocated in two thousand twen-
45 ty-four. Program thirteen will cover tax incentives allocated in two
46 thousand twenty-five. Program fourteen will cover tax incentives allo-
47 cated in two thousand twenty-six. Program fifteen will cover tax incen-
48 tives allocated in two thousand twenty-seven. The commissioner is
49 authorized to allocate up to twenty-five million dollars of tax credits
50 under program one, ten million dollars of tax credits under program two,
51 twenty million dollars of tax credits under program three, fifty million
52 dollars of tax credits under each of programs four and five, and forty
53 million dollars of tax credits under programs six, seven, eight, nine
54 [~~and~~], ten, eleven, twelve, thirteen, fourteen and fifteen.

8 has the right to use or possess, any room in a hotel or vacation rental
9 under any lease, concession, permit, right of access, license to use or

12 subdivision.

13 (4) Operator. Any person operating a hotel or vacation rental. Such
14 term shall include a room remarketer and such room remarketer shall be
15 deemed to operate a hotel, or portion thereof, with respect to which
16 such person has the rights of a room remarketer.

17 (5) Permanent resident. Any occupant of any room or rooms in a hotel
18 or vacation rental for at least ninety consecutive days shall be consid-
19 ered a permanent resident with regard to the period of such occupancy.

20 (6) Rent. The consideration received for occupancy, including any
21 service or other charge or amount required to be paid as a condition for
22 occupancy, valued in money, whether received in money or otherwise and
23 whether received by the operator or a room remarketer or another person
24 on behalf of either of them.

25 (7) Room. Any room or rooms of any kind in any part or portion of a
26 hotel or vacation rental, which is available for or let out for any
27 purpose other than a place of assembly.

28 (8) Room remarketer. A person who reserves, arranges for, conveys, or
29 furnishes occupancy, whether directly or indirectly, to an occupant for
30 rent in a hotel for an amount determined by the room remarketer, direct-
31 ly or indirectly, whether pursuant to a written or other agreement. Such
32 person's ability or authority to reserve, arrange for, convey, or
33 furnish occupancy, directly or indirectly, and to determine rent there-
34 for, shall be the "rights of a room remarketer". A room remarketer is
35 not a permanent resident with respect to a room for which such person
36 has the rights of a room remarketer.

37 (9) Vacation rental. A building or portion of it that is used for the
38 lodging of guests. The term "vacation rental" includes a house, an
39 apartment, a condominium, a cooperative unit, a cabin, a cottage, or a
40 bungalow, or one or more rooms therein, where sleeping accommodations
41 are provided for the lodging of paying occupants, the typical occupants
42 are transients or travelers, and the relationship between the operator
43 and occupant is not that of a landlord and tenant. It is not necessary
44 that meals are served. A building or portion of a building may qualify
45 as a vacation rental whether or not amenities, including but not limited
46 to daily housekeeping services, concierge services, or linen services,
47 are provided.

48 (10) (i) Vacation rental marketplace provider. A person who, pursuant
49 to an agreement with an operator, facilitates the occupancy of a vaca-
50 tion rental by such operator or operators. A person "facilitates the
51 occupancy of a vacation rental" for purposes of this paragraph when the
52 person meets both of the following conditions: (A) such person provides
53 the forum in which, or by means of which, the sale of the occupancy
54 takes place or the offer of such sale is accepted, including a shop,
55 store, or booth, an internet website, catalog, or similar forum; and (B)
56 such person or an affiliate of such person collects the rent paid by a

1 customer to an operator for the occupancy of a vacation rental, or
2 contracts with a third party to collect such rent.

3 (ii) For the purposes of this article, the term "vacation rental
4 marketplace provider" shall not include a "room remarketer" as defined

33 to such occupancy: (A) the operator of the vacation rental can show that
34 such occupancy was facilitated by a vacation rental marketplace provider

18 property owner fails to provide the report within thirty days of such a
19 request, the proceeding shall be dismissed.

44 application for the "enhanced" STAR exemption authorized by subdivision
45 four of this section has not been filed on or before the taxable status
46 date, and the owner believes that good cause existed for the failure to
47 file the application by that date, the owner may, no later than the last
48 day for paying school taxes without incurring interest or penalty,
49 submit a written request to the commissioner asking him or her to extend
50 the filing deadline and grant the exemption. Such request shall contain

43 Upon award of a gaming license by the commission, the applicant shall be
44 required to deposit ten percent of the total investment proposed in the
45 application into an interest-bearing account. Monies received from the
46 applicant shall be held in escrow until the final stage of construction,
47 as detailed in the timeline of construction submitted with the
48 licensee's application and approved by the commission, at which time the
49 deposit plus interest earned shall be returned to the applicant to be
50 applied for the final stage. Should the applicant be unable to complete
51 the gaming facility, the deposit shall be forfeited to the state. In
52 place of a cash deposit, the commission may allow for an applicant to
53 secure a deposit bond insuring that ten percent of the proposed capital
54 investment shall be forfeited to the state if the applicant is unable to
55 complete the gaming facility.

1 2. Each applicant shall submit its proposed capital investment with
2 its application to the board which shall include stages of construction
3 of the gaming facility and the deadline by which the stages and overall
4 construction and any infrastructure improvements will be completed. In
5 awarding a license, the commission shall determine at what stage of
6 construction a licensee shall be approved to open for gaming; provided,
7 however, that a licensee shall not be approved to open for gaming until
8 the commission has determined that at least the gaming area and other
9 ancillary entertainment services and non-gaming amenities, as required
10 by the board, have been built and are of a superior quality as set forth
11 in the conditions of licensure. The commission shall not approve a
12 gaming facility to open before the completion of the permanent casino
13 area.

14 3. The board shall determine a licensing fee to be paid by a licensee
15 within thirty days after the award of the license which shall be depos-
16 ited into the commercial gaming revenue fund. The license shall set
17 forth the conditions to be satisfied by the licensee before the gaming
18 facility shall be opened to the public. The commission shall set any
19 renewal fee for such license based on the cost of fees associated with
20 the evaluation of a licensee under this article which shall be deposited
21 into the commercial gaming fund. Such renewal fee shall be exclusive of
22 any subsequent licensing fees under this section.

23 4. The commission shall determine the sources and total amount of an
24 applicant's proposed capitalization to develop, construct, maintain and
25 operate a proposed gaming facility under this article. Upon award of a
26 gaming license, the commission shall continue to assess the capitaliza-
27 tion of a licensee for the duration of construction of the proposed
28 gaming facility and the term of the license.

29 § 1321-f. Minimum license thresholds. The minimum licensing thresh-
30 olds shall be the same as those established under section thirteen
31 hundred sixteen of this article.

32 § 1321-g. Investigation of license applicants. The process used to
33 investigate license applicants shall be the same process established
34 under section thirteen hundred seventeen of this article.

35 § 1321-h. Disqualifying criteria. The criteria to disqualify appli-
36 cants shall be the same criteria used for upstate gaming facility
37 licensing, which are enumerated in section thirteen hundred eighteen of
38 this article.

39 § 1321-i. Hearings. The process used for hearings shall be the same
40 process established under section thirteen hundred nineteen of this
41 article.

42 § 1321-j. Siting evaluation. In determining whether an applicant shall
43 be eligible for a gaming facility license, the board shall evaluate how
44 each applicant proposes to advance the following objectives with consid-
45 eration given to the differences between proposed projects related to
46 whether it is a conversion of an existing video lottery gaming facility
47 or new facility construction, and the proposed location. The decision
48 by the board to select a gaming facility license applicant shall be
49 determined based on the following factors which shall include, but not
50 be limited to:

51 (a) realizing maximum capital investment exclusive of land acquisition
52 and infrastructure improvements;

53 (b) maximizing revenues received by the state and localities;

54 (c) providing the highest number of quality jobs in the gaming facili-
55 ty;

1 (d) building a gaming facility of the highest caliber with a variety
2 of quality amenities to be included as part of the gaming facility;

3 (e) offering the highest and best value to patrons to create a secure
4 and robust gaming market in the region and the state;

5 (f) providing a market analysis detailing the benefits of the site
6 location of the gaming facility and the estimated recapture rate of
7 gaming-related spending by residents travelling to an out-of-state
8 gaming facility;

9 (g) offering a reasonable and feasible construction schedule to
10 completion of the full gaming facility;

11 (h) demonstrating the ability to fully finance the gaming facility;

12 (i) demonstrating experience in the development and operation of a
13 quality gaming facility;

14 (j) mitigating potential impacts on host and nearby municipalities
15 which might result from the development or operation of the gaming
16 facility;

17 (k) carefully considering local views and consulting with appropriate
18 local governments;

19 (l) operating in partnership with and promoting local hotels, restau-
20 rants and retail facilities so that patrons experience the full diversi-
21 fied regional tourism industry;

22 (m) establishing a fair and reasonable partnership with live enter-
23 tainment venues that may be impacted by a gaming facility under which
24 the gaming facility actively supports the mission and the operation of
25 the impacted entertainment venues;

26 (n) implementing a workforce development plan that utilizes the exist-
27 ing labor force, including the estimated number of construction jobs a
28 proposed gaming facility will generate, the development of workforce
29 training programs that serve the unemployed and methods for accessing
30 employment at the gaming facility;

31 (o) taking additional measures to address problem gambling including,
32 but not limited to, training of gaming employees to identify patrons
33 exhibiting problems with gambling;

34 (p) utilizing sustainable development principles including, but not
35 limited to:

36 (1) having new and renovation construction certified under the appro-
37 priate certification category in the Leadership in Energy and Environ-
38 mental Design Green Building Rating System created by the United States
39 Green Building Council;

40 (2) efforts to mitigate vehicle trips;

41 (3) efforts to conserve water and manage storm water;

42 (4) demonstrating that electrical and HVAC equipment and appliances
43 will be Energy Star labeled where available;

44 (5) procuring or generating on-site ten percent of its annual elec-
45 tricity consumption from renewable sources; and

46 (6) developing an ongoing plan to submeter and monitor all major
47 sources of energy consumption and undertake regular efforts to maintain
48 and improve energy efficiency of buildings in their systems;

49 (q) establishing, funding and maintaining human resource hiring and
50 training practices that promote the development of a skilled and diverse
51 workforce and access to promotion opportunities through a workforce
52 training program that:

53 (1) establishes transparent career paths with measurable criteria
54 within the gaming facility that lead to increased responsibility and
55 higher pay grades that are designed to allow employees to pursue career
56 advancement and promotion;

1 (2) provides employee access to additional resources, such as tuition
2 reimbursement or stipend policies, to enable employees to acquire the
3 education or job training needed to advance career paths based on
4 increased responsibility and pay grades; and

5 (3) establishes an on-site child day care program;

6 (r) purchasing, whenever possible, domestically manufactured slot
7 machines for installation in the gaming facility;

8 (s) implementing a workforce development plan that:

9 (1) incorporates an affirmative action program of equal opportunity by
10 which the applicant guarantees to provide equal employment opportunities
11 to all employees qualified for licensure in all employment categories,
12 including persons with disabilities;

13 (2) utilizes the existing labor force in the state;

14 (3) estimates the number of construction jobs a gaming facility will
15 generate and provides for equal employment opportunities and which
16 includes specific goals for the utilization of minorities, women and
17 veterans on those construction jobs;

18 (4) identifies workforce training programs offered by the gaming
19 facility; and

20 (5) identifies the methods for accessing employment at the gaming
21 facility; and

22 (t) demonstrating that the applicant has an agreement with organized
23 labor, including hospitality services, and has the support of organized
24 labor for its application, which specifies:

25 (1) the number of employees to be employed at the gaming facility,
26 including detailed information on the pay rate and benefits for employ-
27 ees and contractors in the gaming facility and all infrastructure
28 improvements related to the project; and

29 (2) detailed plans for assuring labor harmony during all phases of the
30 construction, reconstruction, renovation, development and operation of
31 the gaming facility.

32 § 8. Section 1351 of the racing, pari-mutuel wagering and breeding law
33 is amended by adding a new subdivision 1-a to read as follows:

34 1-a. For a gaming facility licensed pursuant to title two-A of this
35 article, there is hereby imposed a tax on gross gaming revenues with the
36 rates to be determined by the gaming commission pursuant to a compet-
37 itive bidding process as outlined in title two-A of this article.

38 § 9. This act shall take effect immediately.

39 PART DD

40 Section 1. Section 509-a of the racing, pari-mutuel wagering and
41 breeding law, as amended by section 1 of part LLL of chapter 59 of the
42 laws of 2021, is amended to read as follows:

43 § 509-a. Capital acquisition fund. 1. The corporation may create and
44 establish a capital acquisition fund for the purpose of financing the
45 acquisition, construction or equipping of offices, facilities or prem-
46 ises of the corporation. Such capital acquisition fund shall consist of
47 (i) the amounts specified pursuant to subdivision three-a of section
48 five hundred thirty-two of this chapter; and (ii) contributions from the
49 corporation's pari-mutuel wagering pools, subject to the following limi-
50 tations:

51 a. no contribution shall exceed the amount of one percent of the total
52 pari-mutuel wagering pools for the quarter in which the contribution is
53 made;

1 b. no contribution shall reduce the amount of quarterly net revenues,
2 exclusive of surcharge revenues, to an amount less than fifty percent of

4 c. the balance of the fund shall not exceed the lesser of one percent

6 the undepreciated value of the corporation's offices, facilities and
7 premises.

8 2. a. Notwithstanding any other provision of law or regulation to the
9 contrary, from April nineteenth, two thousand twenty-one to March thir-
10 ty-first, two thousand twenty-two, twenty-three percent of the funds,
11 not to exceed two and one-half million dollars, in the Catskill off-
12 track betting corporation's capital acquisition fund and twenty-three
13 percent of the funds, not to exceed four hundred forty thousand dollars,
14 in the Capital off-track betting corporation's capital acquisition fund
15 established pursuant to this section shall also be available to such
16 off-track betting corporation for the purposes of statutory obligations,
17 payroll, and expenditures necessary to accept authorized wagers.

18 b. Notwithstanding any other provision of law or regulation to
19 the contrary, from April first, two thousand twenty-two to March thir-
20 ty-first, two thousand twenty-three, twenty-three percent of the funds,
21 not to exceed four hundred forty thousand dollars, in the Capital
22 off-track betting corporation's capital acquisition fund established
23 pursuant to this section shall also be available to such off-track
24 betting corporation for the purposes of statutory obligations,
25 payroll, and expenditures necessary to accept authorized wagers.

26 3. The Catskill off-track betting corporation and the Capital off-
27 track betting corporation shall make a report to the governor, speaker
28 of the assembly, temporary president of the senate and the commission
29 detailing the actual use of the funds made available in the capital
30 acquisition fund. Such report shall include, but not be limited to, any
31 impact on employment levels since utilizing the funds, the status of any
32 statutory obligations, an accounting of the use of such funds, and any
33 other information as deemed necessary by the commission. Such report
34 shall be due no later than the [~~first day of April two thousand twenty-~~
35 ~~two~~] last day of the fiscal year in which the monies were spent.

36 § 2. Section 2 of part LLL of chapter 59 of the laws of 2021 amending
37 the racing, pari-mutuel wagering and breeding law, relating to the
38 utilization of funds in the Catskill and Capital regions off-track
39 betting corporation's capital acquisition funds, is amended to read
40 as follows:

41 § 2. This act shall take effect immediately [~~and shall expire and be~~
42 ~~deemed repealed one year after such date~~].

43 § 3. This act shall take effect immediately.

44 PART EE

45 Section 1. Paragraph (a) of subdivision 1 of section 1003 of the
46 racing, pari-mutuel wagering and breeding law, as amended by section 1
47 of part DD of chapter 59 of the laws of 2021, is amended to read as
48 follows:

49 (a) Any racing association or corporation or regional off-track
50 betting corporation, authorized to conduct pari-mutuel wagering under
51 this chapter, desiring to display the simulcast of horse races on which
52 pari-mutuel betting shall be permitted in the manner and subject to the
53 conditions provided for in this article may apply to the commission for
54 a license so to do. Applications for licenses shall be in such form as

1 may be prescribed by the commission and shall contain such information
2 or other material or evidence as the commission may require. No license
3 shall be issued by the commission authorizing the simulcast transmission
4 of thoroughbred races from a track located in Suffolk county. The fee
5 for such licenses shall be five hundred dollars per simulcast facility
6 and for account wagering licensees that do not operate either a simul-
7 cast facility that is open to the public within the state of New York or
8 a licensed racetrack within the state, twenty thousand dollars per year
9 payable by the licensee to the commission for deposit into the general
10 fund. Except as provided in this section, the commission shall not
11 approve any application to conduct simulcasting into individual or group
12 residences, homes or other areas for the purposes of or in connection
13 with pari-mutuel wagering. The commission may approve simulcasting into
14 residences, homes or other areas to be conducted jointly by one or more
15 regional off-track betting corporations and one or more of the follow-
16 ing: a franchised corporation, thoroughbred racing corporation or a
17 harness racing corporation or association; provided (i) the simulcasting
18 consists only of those races on which pari-mutuel betting is authorized
19 by this chapter at one or more simulcast facilities for each of the
20 contracting off-track betting corporations which shall include wagers
21 made in accordance with section one thousand fifteen, one thousand
22 sixteen and one thousand seventeen of this article; provided further
23 that the contract provisions or other simulcast arrangements for such
24 simulcast facility shall be no less favorable than those in effect on
25 January first, two thousand five; (ii) that each off-track betting
26 corporation having within its geographic boundaries such residences,
27 homes or other areas technically capable of receiving the simulcast
28 signal shall be a contracting party; (iii) the distribution of revenues
29 shall be subject to contractual agreement of the parties except that
30 statutory payments to non-contracting parties, if any, may not be
31 reduced; provided, however, that nothing herein to the contrary shall
32 prevent a track from televising its races on an irregular basis primari-
33 ly for promotional or marketing purposes as found by the commission. For
34 purposes of this paragraph, the provisions of section one thousand thir-
35 teen of this article shall not apply. Any agreement authorizing an
36 in-home simulcasting experiment commencing prior to May fifteenth, nine-
37 teen hundred ninety-five, may, and all its terms, be extended until June
38 thirtieth, two thousand [~~twenty-two~~] twenty-three; provided, however,
39 that any party to such agreement may elect to terminate such agreement
40 upon conveying written notice to all other parties of such agreement at
41 least forty-five days prior to the effective date of the termination,
42 via registered mail. Any party to an agreement receiving such notice of
43 an intent to terminate, may request the commission to mediate between
44 the parties new terms and conditions in a replacement agreement between
45 the parties as will permit continuation of an in-home experiment until

47 in-home simulcasting in the thoroughbred special betting district shall
48 occur without the approval of the regional thoroughbred track.

49 § 2. Subparagraph (iii) of paragraph d of subdivision 3 of section
50 1007 of the racing, pari-mutuel wagering and breeding law, as amended by
51 section 2 of part DD of chapter 59 of the laws of 2021, is amended to
52 read as follows:

53 (iii) Of the sums retained by a receiving track located in Westchester
54 county on races received from a franchised corporation, for the period

1 exclusively for purses to be awarded at races conducted by such receiv-

15 any day during which a franchised corporation is conducting a race meet-
16 ing in Saratoga county at Saratoga thoroughbred racetrack until June
17 thirtieth, two thousand [~~twenty-two~~] twenty-three and on any day regard-
18 less of whether or not a franchised corporation is conducting a race
19 meeting in Saratoga county at Saratoga thoroughbred racetrack after June
20 thirtieth, two thousand [~~twenty-two~~] twenty-three. On any day on which a
21 franchised corporation has not scheduled a racing program but a
22 thoroughbred racing corporation located within the state is conducting
23 racing, each off-track betting corporation branch office and each simul-
24 casting facility licensed in accordance with section one thousand seven
25 (that has entered into a written agreement with such facility's repre-
26 sentative horsemen's organization, as approved by the commission), one
27 thousand eight, or one thousand nine of this article shall be authorized
28 to accept wagers and display the live simulcast signal from thoroughbred
29 tracks located in another state or foreign country subject to the
30 following provisions:

31 § 4. Subdivision 1 of section 1015 of the racing, pari-mutuel wagering
32 and breeding law, as amended by section 4 of part DD of chapter 59 of
33 the laws of 2021, is amended to read as follows:

34 1. The provisions of this section shall govern the simulcasting of
35 races conducted at harness tracks located in another state or country
36 during the period July first, nineteen hundred ninety-four through June
37 thirtieth, two thousand [~~twenty-two~~] twenty-three. This section shall
38 supersede all inconsistent provisions of this chapter.

39 § 5. The opening paragraph of subdivision 1 of section 1016 of the
40 racing, pari-mutuel wagering and breeding law, as amended by section 5
41 of part DD of chapter 59 of the laws of 2021, is amended to read as
42 follows:

43 The provisions of this section shall govern the simulcasting of races
44 conducted at thoroughbred tracks located in another state or country on
45 any day during which a franchised corporation is not conducting a race
46 meeting in Saratoga county at Saratoga thoroughbred racetrack until June
47 thirtieth, two thousand [~~twenty-two~~] twenty-three. Every off-track
48 betting corporation branch office and every simulcasting facility
49 licensed in accordance with section one thousand seven that have entered
50 into a written agreement with such facility's representative horsemen's
51 organization as approved by the commission, one thousand eight or one
52 thousand nine of this article shall be authorized to accept wagers and
53 display the live full-card simulcast signal of thoroughbred tracks
54 (which may include quarter horse or mixed meetings provided that all
55 such wagering on such races shall be construed to be thoroughbred races)
56 located in another state or foreign country, subject to the following

1 provisions; provided, however, no such written agreement shall be
2 required of a franchised corporation licensed in accordance with section
3 one thousand seven of this article:

4 § 6. The opening paragraph of section 1018 of the racing, pari-mutuel
5 wagering and breeding law, as amended by section 6 of part DD of chapter
6 59 of the laws of 2021, is amended to read as follows:

7 Notwithstanding any other provision of this chapter, for the period
8 July twenty-fifth, two thousand one through September eighth, two thou-
9 sand [~~twenty-one~~] twenty-two, when a franchised corporation is conduct-
10 ing a race meeting within the state at Saratoga Race Course, every off-
11 track betting corporation branch office and every simulcasting facility
12 licensed in accordance with section one thousand seven (that has entered
13 into a written agreement with such facility's representative horsemen's
14 organization as approved by the commission), one thousand eight or one
15 thousand nine of this article shall be authorized to accept wagers and
16 display the live simulcast signal from thoroughbred tracks located in
17 another state, provided that such facility shall accept wagers on races
18 run at all in-state thoroughbred tracks which are conducting racing
19 programs subject to the following provisions; provided, however, no such
20 written agreement shall be required of a franchised corporation licensed
21 in accordance with section one thousand seven of this article.

22 § 7. Section 32 of chapter 281 of the laws of 1994, amending the
23 racing, pari-mutuel wagering and breeding law and other laws relating to
24 simulcasting, as amended by section 7 of part DD of chapter 59 of the
25 laws of 2021, is amended to read as follows:

26 § 32. This act shall take effect immediately and the pari-mutuel tax
27 reductions in section six of this act shall expire and be deemed
28 repealed on July 1, [~~2022~~] 2023; provided, however, that nothing
29 contained herein shall be deemed to affect the application, qualifica-
30 tion, expiration, or repeal of any provision of law amended by any
31 section of this act, and such provisions shall be applied or qualified
32 or shall expire or be deemed repealed in the same manner, to the same

50 § 9. Paragraph (a) of subdivision 1 of section 238 of the racing,
51 pari-mutuel wagering and breeding law, as amended by section 9 of part
52 DD of chapter 59 of the laws of 2021, is amended to read as follows:

53 (a) The franchised corporation authorized under this chapter to
54 conduct pari-mutuel betting at a race meeting or races run thereat shall
55 distribute all sums deposited in any pari-mutuel pool to the holders of
56 winning tickets therein, provided such tickets are presented for payment

1 before April first of the year following the year of their purchase,
2 less an amount that shall be established and retained by such franchised
3 corporation of between twelve to seventeen percent of the total deposits
4 in pools resulting from on-track regular bets, and fourteen to twenty-
5 one percent of the total deposits in pools resulting from on-track
6 multiple bets and fifteen to twenty-five percent of the total deposits

11 Such rate may not be changed more than once per calendar quarter to be

13 "multiple bets" shall have the meanings set forth in section five
14 hundred nineteen of this chapter. "Super exotic bets" shall have the
15 meaning set forth in section three hundred one of this chapter. For
16 purposes of this section, a "pick six bet" shall mean a single bet or
17 wager on the outcomes of six races. The breaks are hereby defined as the
18 odd cents over any multiple of five for payoffs greater than one dollar
19 five cents but less than five dollars, over any multiple of ten for
20 payoffs greater than five dollars but less than twenty-five dollars,
21 over any multiple of twenty-five for payoffs greater than twenty-five
22 dollars but less than two hundred fifty dollars, or over any multiple of
23 fifty for payoffs over two hundred fifty dollars. Out of the amount so
24 retained there shall be paid by such franchised corporation to the
25 commissioner of taxation and finance, as a reasonable tax by the state
26 for the privilege of conducting pari-mutuel betting on the races run at
27 the race meetings held by such franchised corporation, the following
28 percentages of the total pool for regular and multiple bets five percent
29 of regular bets and four percent of multiple bets plus twenty percent of
30 the breaks; for exotic wagers seven and one-half percent plus twenty
31 percent of the breaks, and for super exotic bets seven and one-half
32 percent plus fifty percent of the breaks.

33 For the period April first, two thousand one through December thirty-
34 first, two thousand [~~twenty-two~~] ~~twenty-three~~, such tax on all wagers
35 shall be one and six-tenths percent, plus, in each such period, twenty
36 percent of the breaks. Payment to the New York state thoroughbred breed-
37 ing and development fund by such franchised corporation shall be one-
38 half of one percent of total daily on-track pari-mutuel pools resulting
39 from regular, multiple and exotic bets and three percent of super exotic
40 bets and for the period April first, two thousand one through December
41 thirty-first, two thousand [~~twenty-two~~] ~~twenty-three~~, such payment shall
42 be seven-tenths of one percent of regular, multiple and exotic pools.

43 § 10. This act shall take effect immediately.

44 § 2. Severability clause. If any clause, sentence, paragraph, subdivi-
45 sion, section or part of this act shall be adjudged by any court of
46 competent jurisdiction to be invalid, such judgment shall not affect,
47 impair, or invalidate the remainder thereof, but shall be confined in
48 its operation to the clause, sentence, paragraph, subdivision, section
49 or part thereof directly involved in the controversy in which such judg-
50 ment shall have been rendered. It is hereby declared to be the intent of
51 the legislature that this act would have been enacted even if such
