AN ACT to amend the penal law, in relation to establishing the crime of unlawful procurement of clients, patients or customers

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Section 176.00 of the penal law is amended by adding three 2 new subdivisions 6, 7 and 8 to read as follows:

- 3 <u>6. "Provider" means a health care professional, an owner or operator</u> 4 <u>of a health care practice or facility or an attorney.</u>
- 7. "Public media" means any of the following means of communication, provided that the use of such communication does not involve in-person contact with a specific prospective client, patient or customer for the purpose of retention, treatment or representation in a particular matter: telephone directories, professional directories, newspapers and other periodicals, radio and television, billboards, brochures, business cards, newsletters, announcements, promotional items branding materials, advertisements, websites and mailed or electronically transmitted written communications, advertisements and brandings.
- 13 8. "Runner" means a person, not a provider, who with the intent to 14 15 obtain a material pecuniary benefit, procures or attempts to procure a 16 client, patient or customer at the direction of, request of, in cooper-17 ation with, while employed by, or with intent to solicit a fee from, a provider or from any person who creates the impression that he or she or 18 his or her practice can provide legal or health care services. Such term 19 shall not include a person who procures or attempts to procure clients, 20 21 patients or customers for a provider through public media or who refers 22 clients, patients or customers as authorized or permitted by law or in 23 accordance with existing professional codes of conduct governing the 24 professional practice of a provider. Nothing in this article shall be deemed to prohibit an agent, broker or employee of a health maintenance 25 organization from seeking to sell health maintenance organization cover-27 age or health insurance coverage to an individual or group.

§ 2. The penal law is amended by adding three new sections 176.85, 2 176.90 and 176.95 to read as follows:

§ 176.85 Unlawful procurement of clients, patients or customers in the third degree.

A person is guilty of unlawful procurement of clients, patients or customers in the third degree when he or she knowingly:

- 1. Acts as a runner on more than one occasion during any twelve-month period; or
- 2. As a provider, in violation of law or existing professional codes
 of conduct governing the professional practice of the provider, uses,
 solicits, directs, hires or employs another person to act as a runner on
 more than one occasion over any twelve-month period and provides a material pecuniary benefit.
 - Unlawful procurement of clients, patients or customers in the third degree is a class A misdemeanor.
- 16 <u>§ 176.90 Unlawful procurement of clients, patients or customers in the</u>
 17 <u>second degree.</u>
 - 1. A person is guilty of unlawful procurement of clients, patients or customers in the second degree when he or she knowingly acts as a runner on five or more occasions over any twelve-month period, or for a pecuniary benefit that in the aggregate exceeds five thousand dollars in value; or
 - 2. As a provider, in violation of law or existing professional codes of conduct governing the professional practice of the provider, knowingly uses, solicits, directs, hires or employs one or more persons to act as a runner on five or more occasions over any twelve-month period, or provides a pecuniary benefit to the runner that in the aggregate exceeds five thousand dollars in value.
- 29 <u>Unlawful procurement of clients, patients or customers in the second</u> 30 <u>degree is a class E felony.</u>
- 31 § 176.95 Unlawful procurement of clients, patients or customers in the 32 first degree.
 - 1. A person is quilty of unlawful procurement of clients, patients or customers in the first degree when he or she knowingly acts as a runner on ten or more occasions over any twelve-month period, or for a pecuniary benefit that in the aggregate exceeds twenty thousand dollars in value; or
 - 2. As a provider, in violation of law or existing professional codes of conduct governing the professional practice of the provider, knowingly uses, solicits, directs, hires or employs one or more persons to act as a runner on ten or more occasions over any twelve-month period, or provides a pecuniary benefit to the runner that in the aggregate exceeds twenty thousand dollars in value.

Unlawful procurement of clients, patients or customers in the first degree is a class D felony.
