WHEREAS, With a steadfast and unwavering commitment to his profession and his community, Melvin Spoth truly earned the respect of the Western New York Volunteer Fire Service and the greater Western New York community for his unselfish dedication and devotion; and

WHEREAS, In addition to his son, Melvin Spoth is predeceased by his beloved wife, Arlene; brother, Richard and sister-in-law Margaret; he is survived by three children, Norene, Glenn and Gary; six grandchildren, Brittany, Dilara, Nicholas, Burak, Kyle and Zekeriya; and a sister, Donna (Andy); as well as nieces, nephews and his loving dog, Jenna; and

WHEREAS, Melvin Spoth's infinite selflessness and benevolence will shine on through his family's vivid and happy memories; his insight and strength will forever serve as a beacon of love, light and hope to the countless lives he touched; and
