WHEREAS, This Legislative Body is justly proud to congratulate Officer Jody Kennedy upon the occasion of his retirement after 28 years of distinguished service to the field of law enforcement; this auspicious occasion will be celebrated at an event on Sunday, May 16, 2021; and

WHEREAS, Jody Kennedy grew up in a loving home and greatly respected his father, Officer Joseph Kennedy Sr., and his law enforcement career; also heeding the call to public service, Jody followed in his father's footsteps, someone he loved and deeply admired, and decided to become a police officer; and

WHEREAS, After graduating from Broome County Law Enforcement Academy in 1993, Jody Kennedy began his long and distinguished career in law enforcement with the Deposit Police Department; from 1993-1997, he also worked for the Afton Police Department; and

WHEREAS, Officer Jody Kennedy then joined the Chenango County Sheriff's Department in March of 1997; after more than four years of service, he became a patrolman with the Johnson City Police Department, the position from which he officially retired in April of 2021; and

WHEREAS, In addition to his role as a patrolman, Officer Jody Kennedy served in the DWI enforcement unit and held the title of President of the Johnson City Police Benevolent Association (PBA) for 10 plus years; and

WHEREAS, Under Officer Jody Kennedy's luminous leadership, this fraternal organization diligently worked to promote and assist with maintaining professionalism on the part of its members as well as educating the general public regarding the role and function of its members to the community; and

WHEREAS, Officer Jody Kennedy was also instrumental in establishing

the D.W. Smith Memorial Scholarship to a high school senior in Broome County, and started and coordinated a Peer Support Team through the Johnson City Police Union, the first of its kind for the region; and

WHEREAS, Officer Jody Kennedy began his journey with peer support and suicide awareness for law enforcement in 2008, after attending a Concerns of Police Survivors (C.O.P.S.) training, as well as a training assisting law enforcement officers who are involved in deadly physical force encounters; and

WHEREAS, As a Peer Support Coordinator, Officer Jody Kennedy was working on a piece of New York State legislation in 2018, when he met Jim Banish, and learned of the New York Law Enforcement Assistance Program (NYLEAP) and its mission of improving the mental health of all law enforcement officers and first responders; and

WHEREAS, Through NYLEAP, Officer Jody Kennedy trained police officers both locally and across New York State, educating them on suicide awareness, the exposure and impact of trauma and traumatic events, career-related cumulative stress, and offering resources for help; and

WHEREAS, Officer Jody Kennedy was always passionate about helping first responders to break the stigma and to realize that it is okay not to be okay, and that it is okay to ask for help; and

WHEREAS, Throughout his career, Officer Jody Kennedy was always ready and willing to lend a helping hand to anyone; he coordinated a benefit to raise money for sick family members of fellow law enforcement officers, participated in benefit 5K runs, and was involved with Toys for Tots; and

WHEREAS, For his steadfast and unremitting commitment to his profession and community, Officer Jody Kennedy was the recipient of numerous awards and accolades; and

WHEREAS, Throughout his tenure, Officer Jody Kennedy truly served the residents of the Southern Tier with compassion, integrity, and fairness, attributes which will forever serve as an example for his fellow officers; and

WHEREAS, It is the sense of this Legislative Body that those dedicated public servants who unselfishly devote their lives to the preservation of order and the protection of others are worthy and due full praise for their commitment and noble endeavors; now, therefore, be it
