AN ACT to amend the education law, in relation to providing free SUNY, CUNY and community college tuition to volunteer firefighters

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Paragraph h of subdivision 2 of section 355 of the education law is amended by adding a new subparagraph 1-a to read as follows:

2 (1-a) The trustees shall implement a program to permit any student who
3 has been admitted to a state-operated institution of the state university
4 to attend without the payment of tuition and fees if such student
5 serves as an active volunteer firefighter as defined in subdivision one
6 of section two hundred fifteen of the general municipal law. The
7 provisions of this subparagraph shall only apply to costs of one under-
8 graduate degree and any additional costs associated with more than one
9 simultaneous undergraduate degree shall not be covered by this program.

10 (i) The trustees shall provide an application process and administer
11 the program according to the following criteria:

12 (A) Any student eligible for resident tuition rates is eligible for
13 this program.

14 (B) The student shall be required to serve as an active volunteer
15 firefighter through the completion of his or her academic program.

16 (C) Students shall be required to complete their degree program within
17 a minimum period of time to be set by the trustees which shall be no
18 fewer than three years and no more than five years.

19 (D) The student shall be required to maintain a cumulative grade point
20 average (G.P.A.) of at least 2.5 in order to remain eligible for the
21 program.

22 (ii) If a student or former student fails to fulfill any of the
23 requirements set forth in clause (i) of this subparagraph, the trustees

1 shall convert to a student loan the full amount of the tuition which
2 would have been paid by such student, as determined by the New York
3 state higher education services corporation, plus interest, according to
4 a schedule to be determined by such corporation. Such repayment may also
5 be required if a recipient fails to respond to requests for information
6 necessary to determine continued eligibility or for administration of
7 the program.

8 (iii) Any student who elects to participate in the program under this
9 subparagraph shall be required to apply for tuition assistance program
10 funding. Funds awarded on the tuition assistance program shall be
11 applied towards the cost of tuition prior to an award under this subpar-
12 agraph.

13 (iv) Students shall be responsible for all other costs including hous-
14 ing, fees and other non-tuition related charges.

15 § 2. Subdivision 7 of section 6206 of the education law is amended by
16 adding a new paragraph (f) to read as follows:

17 (f) The trustees shall implement a program to permit any student who
18 has been admitted to an institution operated by the city university to
19 attend without the payment of tuition and fees if such student fulfills
20 the requirements of such program pursuant to the provisions of this
21 paragraph.

22 (i) The trustees shall provide an application process and administer
23 the program according to the following criteria:

24 (A) Any student eligible for resident tuition rates is eligible for
25 this program.

26 (B) The student shall be required to serve as an active volunteer
27 firefighter through the completion of his or her academic program.

28 (C) Students shall be required to complete their degree program within
29 a minimum period of time to be set by the trustees which shall be no
30 fewer than three years and no more than five years.

31 (D) The student shall be required to maintain a cumulative grade point
32 average (G.P.A.) of at least 2.5 in order to remain eligible for the
33 program.

50 § 3. Subdivision 1 of section 6304 of the education law is amended by
51 adding a new paragraph e to read as follows:

52 e. The trustees, sponsors or other governing body of a community
53 college shall implement a program to permit any student who has been
54 admitted to such community college to attend without the payment of
55 tuition and fees if such student fulfills the requirements of such
56 program pursuant to the provisions of this paragraph.
