AN ACT to amend the real property tax law, in relation to tax abatement for rent-controlled and rent regulated property occupied by and real property owned by senior citizens or persons with disabilities

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Paragraphs a and b of subdivision 3 of section 467-b of the real property tax law, paragraph a as amended by section 1 of part U of chapter 55 of the laws of 2014 and paragraph b as amended by chapter 129 of the laws of 2014, are amended to read as follows:

5 a. for a dwelling unit where the head of the household is a person sixty-two years of age or older, no tax abatement shall be granted if the combined income of all members of the household for the income tax 8 year immediately preceding the date of making application exceeds four thousand dollars, or such other sum not more than twenty-five thousand 10 dollars beginning July first, two thousand five, twenty-six thousand 11 dollars beginning July first, two thousand six, twenty-seven thousand dollars beginning July first, two thousand seven, twenty-eight thousand 13 dollars beginning July first, two thousand eight, twenty-nine thousand dollars beginning July first, two thousand nine, and fifty thousand 14 dollars beginning July first, two thousand fourteen, and fifty-five 15 16 thousand dollars beginning July first, two thousand twenty-two, as may 17 be provided by the local law, ordinance or resolution adopted pursuant 18 to this section, provided that when the head of the household retires 19 before the commencement of such income tax year and the date of filing the application, the income for such year may be adjusted by excluding 21 salary or earnings and projecting his or her retirement income over the 22 entire period of such year.

23 b. for a dwelling unit where the head of the household qualifies as a 24 person with a disability pursuant to subdivision five of this section,

no tax abatement shall be granted if the combined income for all members of the household for the current income tax year exceeds fifty thousand dollars beginning July first, two thousand fourteen, and fifty-five thousand dollars beginning July first, two thousand twenty-two, as may be provided by the local law, ordinance or resolution adopted pursuant to this section.

§ 2. Paragraph (a) of subdivision 3 of section 467 of the real property tax law, as amended by chapter 558 of the laws of 2021, is amended to read as follows:

9 10 (a) if the income of the owner or the combined income of the owners of 11 the property for the income tax year immediately preceding the date of 12 making application for exemption exceeds the sum of three thousand dollars, or such other sum not less than three thousand dollars nor more 13 14 than twenty-six thousand dollars beginning July first, two thousand six, 15 twenty-seven thousand dollars beginning July first, two thousand seven, 16 twenty-eight thousand dollars beginning July first, two thousand eight, 17 twenty-nine thousand dollars beginning July first, two thousand nine, 18 and in a city with a population of one million or more fifty thousand 19 dollars beginning July first, two thousand seventeen, and fifty-five 20 thousand dollars beginning July first, two thousand twenty-two as may be 21 provided by the local law, ordinance or resolution adopted pursuant to section. Where the taxable status date is on or before April fourteenth, income tax year shall mean the twelve-month period for which the 23 owner or owners filed a federal personal income tax return for the year 24 25 before the income tax year immediately preceding the date of application 26 and where the taxable status date is on or after April fifteenth, income 27 tax year shall mean the twelve-month period for which the owner or 28 owners filed a federal personal income tax return for the income tax year immediately preceding the date of application. Where title is vest-29 in either the husband or the wife, their combined income may not 30 31 exceed such sum, except where the husband or wife, or ex-husband or 32 ex-wife is absent from the property as provided in subparagraph (ii) of paragraph (d) of this subdivision, then only the income of the spouse or 34 ex-spouse residing on the property shall be considered and may not 35 exceed such sum. Such income shall include social security and retire-36 ment benefits, interest, dividends, total gain from the sale or exchange 37 of a capital asset which may be offset by a loss from the sale or exchange of a capital asset in the same income tax year, net rental 39 income, salary or earnings, and net income from self-employment, but shall not include a return of capital, gifts, inheritances, payments 40 made to individuals because of their status as victims of Nazi perse-41 42 cution, as defined in P.L. 103-286 or monies earned through employment 43 in the federal foster grandparent program and any such income shall offset by all medical and prescription drug expenses actually paid which 45 were not reimbursed or paid for by insurance, if the governing board of 46 a municipality, after a public hearing, adopts a local law, ordinance or 47 resolution providing therefor. In addition, an exchange of an annuity 48 an annuity contract, which resulted in non-taxable gain, as determined in section one thousand thirty-five of the internal revenue code, 49 shall be excluded from such income. Provided that such exclusion shall 50 be based on satisfactory proof that such an exchange was solely an 51 52 exchange of an annuity for an annuity contract that resulted in a non-53 taxable transfer determined by such section of the internal revenue code. Furthermore, such income shall not include the proceeds of a reverse mortgage, as authorized by section six-h of the banking law, and 55 sections two hundred eighty and two hundred eighty-a of the real properS. 4216--A

ty law; provided, however, that monies used to repay a reverse mortgage may not be deducted from income, and provided additionally that any interest or dividends realized from the investment of reverse mortgage proceeds shall be considered income. The provisions of this paragraph 5 notwithstanding, such income shall not include veterans disability compensation, as defined in Title 38 of the United States Code provided 7 the governing board of such municipality, after public hearing, adopts a local law, ordinance or resolution providing therefor. In computing net 9 rental income and net income from self-employment no depreciation 10 deduction shall be allowed for the exhaustion, wear and tear of real or 11 personal property held for the production of income;

- 14 15 (a) if the income of the owner or the combined income of the owners of 16 the property for the income tax year immediately preceding the date of 17 making application for exemption exceeds the sum of three thousand 18 dollars, or such other sum not less than three thousand dollars nor more 19 than twenty-six thousand dollars beginning July first, two thousand six, 20 twenty-seven thousand dollars beginning July first, two thousand seven, 21 twenty-eight thousand dollars beginning July first, two thousand eight, 22 twenty-nine thousand dollars beginning July first, two thousand nine, 23 and in a city with a population of one million or more fifty thousand 24 dollars beginning July first, two thousand seventeen, and fifty-five 25 thousand dollars beginning July first, two thousand twenty-two as may be 26 provided by the local law or resolution adopted pursuant to this 27 section.
