AN ACT to amend the alcoholic beverage control law, in relation to the issuing of temporary retail permits; and to repeal section 97-a of such law relating thereto

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1	Section 1. Section 97-a of the alcoholic beverage control law is
2	REPEALED and a new section 97-a is added to read as follows:
3	§ 97-a. Temporary retail permit. 1. The authority is hereby authorized
4	<u>to issue a temporary retail permit:</u>
5	(a) to the transferee of a retail license to continue the operations
6	of a retail premises during the period a transfer application for the
7	license from person to person at the same premises is pending; or
8	(b) to an applicant for a premises that is not licensed in a munici-
9	pality with a population of less than one million.
10	2. Such a permit may be issued if all of the following conditions are
11	met:
12	(a) The applicant for the temporary retail permit shall have filed
13	with the authority an application for a retail license at such premises,
14	together with all required filing and license fees;
15	(b) The applicant shall have filed with the authority an application
16	for a temporary retail permit, accompanied by a nonrefundable filing fee
17	of either one hundred twenty-eight dollars for all retail beer licenses
18	or six hundred forty dollars for all other retail licenses;
19	(c) In the case of a transfer application, the premises shall have
20	been operated under a retail license within thirty days of the date of
21	filing the application for a temporary permit; and

1	(d) In the case of a transfer application, the current license in
2	effect at said premises must be surrendered or placed in safekeeping
3	with the authority.
4	3. A temporary retail permit under paragraph (b) of subdivision one of
5	this section may not be issued for any premises that is subject to the
б	provisions of subdivision seven of section sixty-four, subdivision seven
7	of section sixty-four-a, subdivision five of section sixty-four-b,
8	subdivision twelve of section sixty-four-c, subdivision eight of section
9	sixty-four-d or subdivision three of section one hundred five of this
10	<u>chapter.</u>
11	4. A temporary permit issued by the authority pursuant to this section
12	shall be for a period not to exceed ninety days. A temporary permit may
13	be extended at the discretion of the authority, for an additional thirty
14	day period.
15	5. A temporary retail permit is a conditional permit and authorizes
16	the holder thereof:
17	(a) In the case of a transfer application, to purchase and sell such
18	alcoholic beverages as would be permitted to be purchased and sold under
19	the privileges of the retail license for which the transfer application
20	has been made;
21	(b) In the case of all other retail applications, to purchase and sell
22	such alcoholic beverages as would be permitted to be purchased and sold
23	under the privileges of the license applied for; and
24	(c) To sell such alcoholic beverages to consumers only and not for
25	resale.
26	6. The holder of a temporary retail permit shall purchase alcoholic
27	beverages only by payment in currency or check on or before the day such
28	alcoholic beverages are delivered, provided, however, that the holder of
29	a temporary retail permit who also holds one or more retail licenses and
30	is operating under such retail license or licenses in addition to the
31	temporary retail permit, and who is not delinquent under the provisions
32	of section one hundred one-aa or one hundred one-aaa of this chapter as
33	to any retail license under which it operates, may purchase alcoholic
34	beverages on credit under the temporary permit.
35	7. Notwithstanding any other provision of law, a temporary permit may
36	be summarily cancelled or suspended at any time if the authority deter-
37	mines that good cause for such cancellation or suspension exists. The
38	authority shall promptly notify the holder of a temporary permit in
39	writing of such cancellation or suspension and shall set forth the
40	reasons for such action.
41	8. Application for a temporary permit shall be on such form as the
41 42	authority shall prescribe.
43	9. Approval of or extension of a temporary retail permit shall not be
43 44	deemed as an approval of the retail application.
44 45	<u>10. Notwithstanding any inconsistent provision of law to the contrary,</u>
45 46	the authority may promulgate such rules and regulations as may be neces-
