Introduced by Sen. GALLIVAN -- read twice and ordered printed, and when printed to be committed to the Committee on Transportation

AN ACT to amend the vehicle and traffic law, in relation to presumed consent to organ and tissue donation; and to repeal certain provisions of such law relating to licensure of drivers

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Subdivision 2 of section 490 of the vehicle and traffic
2 law, as amended by chapter 465 of the laws of 2012, the third undesignated
3 paragraph as amended by chapter 248 of the laws of 2016, is
4 amended to read as follows:

5 2. Application. Any person to whom a driver's license or learner's
6 permit has not been issued by the commissioner, or whose driver's
7 license or learner's permit is expired, suspended, revoked or surrendered,
8 may make application to the commissioner for the issuance of an
9 identification card. The commissioner shall [~~ensure that space is
10 provided on the application so that the applicant shall register or
11 decline registration in the donate life registry for organ and tissue
12 donations pursuant to section forty three hundred ten of the public
13 health law and that the following is stated on the application in clear
14 and conspicuous type:~~

15 ~~"You must fill out the following section: Would you like to be added
16 to the Donate Life Registry? Check box for 'yes' or 'skip this question'."~~

17 ~~The commissioner of health shall not maintain records of any person
18 who checks "skip this question". Except where the application is made in
19 person or electronically, failure to check a box shall not impair the
20 validity of an application, and failure to check "yes" or checking "skip
21 this question" shall not be construed to imply a wish not to donate. In
22 the case of an applicant under eighteen years of age, checking "yes"
23 shall not constitute consent to make an anatomical gift or registration~~

23 cant's consent to anatomical donation of the applicant's organs and
24 tissue. The commissioner shall advise each applicant who did not opt out
25 of organ and tissue donation that the applicant's name shall be trans-
26 mitted to the New York state donate life registry for organ, eye and
27 tissue donations under section forty-three hundred ten of the public
28 health law, and that the applicant shall notify the federally designated
29 organ procurement organization of any changes to the applicant's
30 donation. Where an applicant has previously consented to make an
31 anatomical gift or registered in the donate life registry, [~~checking~~

33 consent or registration.

34 § 2. Subdivision 1 of section 502 of the vehicle and traffic law, as
35 amended by chapter 487 of the laws of 2012, is REPEALED.

36 § 3. Subdivision 1 of section 502 of the vehicle and traffic law, as
37 amended by chapter 37 of the laws of 2019, is amended to read as
38 follows:

39 1. Application for license. Application for a driver's license shall
40 be made to the commissioner. The fee prescribed by law may be submitted
41 with such application. The applicant shall furnish such proof of identi-
42 ty, age, and fitness as may be required by the commissioner. With
43 respect to a non-commercial driver's license or learner's permit which
44 does not meet federal standards for identification, in addition to the
45 acceptable proofs of age and identity approved by the commissioner as of
46 January first, two thousand nineteen, acceptable proof of identity shall
47 also include, but not be limited to, a valid, unexpired foreign passport
48 issued by the applicant's country of citizenship (which shall also be
49 eligible as proof of age), a valid, unexpired consular identification
50 document issued by a consulate from the applicant's country of citizen-
51 ship, or a valid foreign driver's license that includes a photo image of
52 the applicant and which is unexpired or expired for less than twenty-
53 four months of its date of expiration, as primary forms of such proof.
54 Nothing contained in this subdivision shall be deemed to preclude the
55 commissioner from approving additional proofs of identity and age. The
56 commissioner may also provide that the application procedure shall

1 include the taking of a photo image or images of the applicant in
2 accordance with rules and regulations prescribed by the commissioner.
3 The commissioner shall provide space so that the applicant may request a
4 notation upon such license that he or she is a veteran of the United
5 States armed forces. In addition, the commissioner also shall require
6 that the applicant provide his or her social security number or, in lieu
7 thereof, with respect to an application for a non-commercial driver's
8 license or learner's permit which does not meet federal standards for
9 identification, an affidavit signed by such applicant that they have not
10 been issued a social security number. The commissioner also shall
11 [~~provide space on the application so that the applicant may register in~~

2 who will operate a commercial motor vehicle in interstate commerce shall
3 certify that such applicant meets the requirements to operate a commer-
4 cial motor vehicle, as set forth in public law 99-570, title XII, and
5 title 49 of the code of federal regulations, and all regulations promul-
6 gated by the United States secretary of transportation under the hazard-
7 ous materials transportation act. In addition, an applicant for a
8 commercial driver's license shall submit a medical certificate at such
9 intervals as required by the federal motor carrier safety improvement
10 act of 1999 and Part 383.71(h) of title 49 of the code of federal regu-
11 lations relating to medical certification and in a manner prescribed by
12 the commissioner. For purposes of this section and sections five
13 hundred three, five hundred ten-a, and five hundred ten-aa of this
14 title, the terms "medical certificate" and "medical certification" shall
15 mean a form substantially in compliance with the form set forth in Part
16 391.43(h) of title 49 of the code of federal regulations. Upon a deter-
17 mination that the holder of a commercial driver's license has made any
18 false statement, with respect to the application for such license, the
19 commissioner shall revoke such license.

20 § 4. This act shall take effect on the one hundred eightieth day after
21 it shall have become a law.
