AN ACT to amend the executive law, in relation to establishing the Alex R. Jimenez New York state military immigrant family legacy program

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

- Section 1. The executive law is amended by adding a new section 354-f 2 to read as follows:
- § 354-f. Staff sergeant Alex R. Jimenez New York state military immiqrant family legacy program. 1. For the purposes of this section, the following terms shall have the following meanings:
 - (a) "Uniformed service member" shall mean a member of the army, navy, air force, space corps, marine corps, coast quard, public health service commissioned corps, or national oceanic and atmospheric administration commissioned officer corps serving on active duty.
- 10 (b) "The program" shall mean the staff sergeant Alex R. Jimenez mili-11 tary immigrant family legacy program.
- 12 <u>(c) "Coordinator" shall mean a military immigrant family legacy</u> 13 <u>program coordinator appointed pursuant to subdivision three of this</u> 14 <u>section.</u>
- 15 <u>(d) "Veteran" shall a person who served in the active military, naval</u> 16 <u>or air service and who was discharged or released under conditions other</u> 17 <u>than dishonorable.</u>
- 18 <u>(e) "Intended recipients" shall mean uniformed service members, veter-</u>
 19 <u>ans, reserve component members and their family members.</u>
- 20 <u>(f) "Reserve component members" shall mean those serving in the army</u>
 21 <u>reserve, navy reserve, marine corps reserve, the army national guard or</u>
 22 <u>the air national guard during the time the unit was federally recognized</u>
- 23 <u>as a reserve component.</u>

 2. There is hereby established within the division of veterans' services, in conjunction with the division of military and naval affairs, the staff sergeant Alex R. Jimenez New York state military immigrant family legacy program which shall be jointly developed and implemented by the director of veterans' services and the adjutant general of the division of military and naval affairs, in consultation with the office for new Americans established pursuant to section ninety-four-b of this chapter, and in accordance with the provisions of this section. The primary purpose of the program shall be to assist intended recipients to secure legal immigration status in the United States, including but not limited to, citizenship.

- 3. Two military immigrant family legacy program coordinators shall be appointed, one appointed by the director of veterans' services and one by the adjutant general of the division of military and naval affairs, to administer the program. Each coordinator shall be a veteran. The coordinators' duties shall include, but not be limited to:
- (a) assisting intended recipients who may qualify for adjustment of status, special immigration status through the federal Parole in Place program authorized by section 1758 of the 2020 National Defense Authorization Act, or any other sort of relief that can lead to citizenship.
- (b) communication with the director of veterans' services and the adjutant general and the office for new Americans regarding existing policies and regulations pertaining to the needs of intended recipients and to make recommendations regarding the improvement of benefits and services to such intended recipients.
- (c) serving as liaison between the divisions, the United States citizenship and immigration services, immigration and customs enforcement, the United States department of veterans affairs, local veterans' service agencies, state agencies, community groups, advocates, and other veterans and military organizations and interested parties.
- 31 (d) consulting with qualified immigration attorneys or duly authorized 32 board of immigration appeals approved representatives to facilitate such 33 coordination with the United States citizenship and immigration services 34 or other appropriate agency.
 - (e) advocating for intended recipients.
 - (f) developing and maintaining a clearinghouse for information and resources relating to the program.
 - (g) promoting events and activities that educate and assist intended recipients, including but not limited to, veteran human rights conferences, veterans benefit and resources events.
 - (h) including the contributions that intended recipients have made on behalf of the United States and this state on the division's official website.
 - (i) developing information to be made available to congressionally chartered veterans' organizations, and local veterans' services agencies to provide a general overview of the program, including but not limited to, its purpose and the eligibility requirements for adjustment of status, citizenship, or any other form of available relief.
 - (j) preparing reports on topics, including but not limited to, the demographics of intended recipients, the number of such intended recipients by county, and the unique needs of the intended recipients within New York state to the director, the adjutant general of the division of military and naval affairs and the office for new Americans.
- 4. The coordinators shall submit a report to the director and to the adjutant general of the division of military and naval affairs on January first each year following the first full year after the effective

date of this section. Such report shall include, but not be limited to, a description of the coordinators' activities for the preceding calendar year. The director shall submit the report to the governor and the legislature in accordance with the provisions of section three hundred fifty-three of this article. The adjutant general of the division of military and naval affairs shall submit the report to the governor and the legislature in accordance with the provisions of section one hundred sixty-four of this chapter.

- 9 § 2. Section 353 of the executive law is amended by adding a new 10 subdivision 19-a to read as follows:
- 11 19-a. To encourage the development of and provide for the establish-12 ment of a state military immigrant family legacy program coordinator, as 13 provided in section three hundred fifty-four-f of this article.
- 14 \S 3. The military law is amended by adding a new section 255 to read 15 as follows:
- § 255. State military immigrant family legacy program support. The adjutant general shall encourage the development of and provide for the establishment of a state military immigrant family legacy program coordinator, as provided in section three hundred fifty-four-f of the executive law.
- 21 § 4. Paragraph (1) of subdivision 5 of section 94-b of the executive 22 law, as added by chapter 206 of the laws of 2014, is amended to read as 23 follows:
- 24 (1) (i) Coordinate with other state agencies and otherwise marshal the 25 resources of the state to serve the needs of immigrants, and (ii) advise 26 the state military immigrant family legacy program coordinators pursuant 27 to section three hundred fifty-four-f of this chapter;
- 28 § 5. This act shall take effect on the ninetieth day after it shall 29 have become a law.
