- AN ACT to amend the state technology law, in relation to conducting an examination and evaluation of New York state's information technology infrastructure, data use and management, policies, procedures and operational processes; and providing for the repeal of such provisions upon the expiration thereof

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Section 103 of the state technology law is amended by 2 adding two new subdivisions 22 and 23 to read as follows: 22. To contract with a private firm that specializes in conducting 3 information technology audits to conduct an examination and evaluation 4 5 of New York state's information technology infrastructure, applications, б data use and management, policies, procedures and operational processes. 7 Such evaluation and examination shall include, but not be limited to: 8 (a) the information technology infrastructure, applications, data use 9 and management, policies, procedures and operational processes of the departments of labor and health; 10 (b) any and all applications and systems operated by the state and its 11 12 agencies that the public regularly utilizes to obtain and utilize 13 services provided the state, and/or to apply for and access any benefits 14 provided by or distributed by the state; (c) a study of the applicable best practices being utilized in both 15 16 public and private internet and technology services; and
