- AN ACT to amend the mental hygiene law, in relation to establishing a pilot program to create an assistance hotline for individuals with intellectual and developmental disabilities and complex behavioral needs

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1	Section 1. Section 13.17 of the mental hygiene law is amended by
2	adding a new subdivision (e) to read as follows:
3	(e) 1. The commissioner shall establish and administer a three-year
4	pilot program to create an assistance hotline for individuals with
5	intellectual and developmental disabilities and complex behavioral
б	needs.
7	2. The assistance hotline shall be accessible via a toll-free tele-
8	phone number and video relay service or other technology accessible to
9	individuals who are deaf, hard of hearing or have speech disabilities,
10	<u>that operates twenty-four hours a day, seven days a week.</u>
11	3. The office shall recruit and train employees to assist individuals
12	with intellectual and developmental disabilities and complex behavioral
13	health needs with access to services offered by the office. Individuals
14	with intellectual and developmental disabilities and complex behavioral
15	health needs, or the parent or guardian of such individuals, may call
16	the hotline to receive assistance with access to services, referral to
17	services, and general information on services offered by the office.
