AN ACT to amend the education law, in relation to providing an annual growth amount for tuition and regional rate reimbursement for approved school-age and preschool special education programs

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Paragraph c of subdivision 4 of section 4405 of the education law, as amended by chapter 82 of the laws of 1995, is amended to  
2 read as follows:

3 c. The director of the budget, in consultation with the commissioner  
4 [~~of education~~], the commissioner of social services, and any other state  
5 agency or other source the director may deem appropriate, shall approve  
6 reimbursement methodologies for tuition and for maintenance. Any modification in the approved reimbursement methodologies shall be subject to  
7 the approval of the director of the budget. [~~Notwithstanding any other~~

1 including, but not limited to, special class and special class in an  
2 integrated setting programs, multi-disciplinary evaluation programs,  
3 special education itinerant services, and preschool transportation  
4 services for which tuition and/or regional rates are determined, shall  
5 grow by a percentage equal to the greater of: (i) the difference of the  
6 quotient arrived at when dividing the apportionments for general support  
7 for public schools for the base year, as defined in section thirty-six  
8 hundred two of this chapter by such apportionments for one year prior to  
9 the base year, as computed based on an electronic data file used to  
10 produce the school aid computer listing produced by the commissioner in  
11 support of the enacted budget for the base year, less one; or (ii) zero.

12 § 2. This act shall take effect immediately.
