AN ACT to amend chapter 192 of the laws of 2011, relating to izing certain health care professionals licensed to practice in other jurisdictions to practice in this state in connection with an event sanctioned by New York Road Runners, in relation to extending the provisions thereof

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Chapter 192 of the laws of 2011, relating to authorizing 2 certain health care professionals licensed to practice in other jurisdictions to practice in this state in connection with an event sanctioned by New York Road Runners, as amended by section 1 of item EE of subpart B of part XXX of chapter 58 of the laws of 2020, is amended to read as follows:

7 Section 1. Notwithstanding any inconsistent provision of law, any 8 person who is licensed to practice as a physician, physician's assistant, massage therapist, physical therapist, chiropractor, dentist, opto-9 10 metrist, nurse, nurse practitioner, certified athletic trainer or podia-11 trist in another state or territory, who is in good standing in such 12 state or territory and who has been appointed by the New York Road Runners to provide professional services at an event in this state sanc-14 tioned by the New York Road Runners, may provide such professional 15 services to athletes and team personnel registered to train at a location in this state or registered to compete in an event conducted 16 17 under the sanction of the New York Road Runners in the state without first being licensed pursuant to the provisions of title 8 of the educa-19 tion law. Such services shall be provided only four days before through 20 one day after each of the following events: 21 a. [the Staten Island half marathon scheduled to be held on a date in

l b.] the New York city marathon scheduled to be held on [a date in 2 2020] November 7, 2021;

- 3 [e.] b. the Brooklyn half marathon scheduled to be held on [a date in 4 2020 and on] May 15, 2021 and on a date in May 2022;
 - [dr] c. the Bronx [half marathon] 10k scheduled to be held on [a date in 2020] October 10, 2021;
 - [e. the Queens 10k scheduled to be held on a date in 2020;] and
- 8 [f.] d. the New York city half marathon scheduled to be held on [a date in 2020 and on March 14, 2021] a date in March 2022.
- 10 § 2. This act shall take effect immediately and shall expire and be 11 deemed repealed June [$\frac{30}{7}$, $\frac{2021}{2}$] 2, 2022.
- 12 § 2. This act shall take effect immediately and shall be deemed to 13 have been in full force and effect on and after January 1, 2021; 14 provided that the amendments to section 1 of chapter 192 of the laws of 2011, made by section one of this act, shall not affect the expiration of such section and shall be deemed repealed therewith.
