AN ACT to amend the education law, in relation to the practice of acupuncture and certain exemptions

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Subdivision 4 of section 8216 of the education law, as
2 amended by chapter 773 of the laws of 1990, is amended to read as
3 follows:

4 (4) A person who does not otherwise possess the credentials or quali-
5 fications required for the practice of acupuncture prescribed by this
6 article or the regulations promulgated hereunder or any other law but
7 ~~[who is authorized by the division of alcoholism and alcohol abuse, the~~
8 ~~division of substance abuse services, or the department of health to~~
9 ~~provide treatment for alcoholism, substance dependence, or chemical~~
