AN ACT to amend the vehicle and traffic law, in relation to authorizing the town of Hempstead in the county of Nassau to establish residential parking systems in the neighborhoods of Bellerose Terrace and Elmont

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

- 1 Section 1. Legislative findings and intent. The legislature finds that
2 a lack of parking for residents of certain areas of the town of Hemp-
3 stead, Nassau county, has resulted in traffic hazards, congestion and
4 air and noise pollution. In addition, such lack of parking poses a
5 hazard to residents and other pedestrians in such areas.
6 The legislature further finds that a residential parking system within
7 such areas would be in the public interest. The legislature further
8 finds that a residential parking system within such areas will reduce
9 such hazards and will reduce pollution levels as well. The legislature,
10 therefore, hereby declares the necessity of this act to authorize the
11 town of Hempstead to adopt a residential parking permit system in
12 accordance with the provisions of this act.
13 § 2. Subdivision 2 of section 1662-e of the vehicle and traffic law,
14 as amended by chapter 337 of the laws of 2021, is amended to read as
15 follows:
16 2. Such residential parking permit system may only be established:
17 (i) within the area known as East Meadow of the town consisting of the
18 following roadways:

- 34 Road to Merrick Road; thence running east on Merrick Road to Oceanside

- 36 running east along Sunrise Highway to Charing Cross Road; thence running
- 37 south on Charing Cross Road to Merrick Road; thence running west on

12 (iv) within the area known as Bellerose Terrace of the town consisting
13 of the following roadways:

14 (a) Superior Road west of Colonial Road;

15 (b) Ontario Road from Colonial Road to 242nd Street and from 239th
16 Street to 240th Street;

17 (c) 95th Avenue east of 225th Street;

18 (d) 225th Street;

19 (e) 226th Street;

20 (f) 238th Street;

21 (g) 239th Street from Superior Road to Jamaica Avenue westbound;

22 (h) 240th Street from Superior Road to Jamaica Avenue westbound;

23 (i) 241st Street from Superior Road to Jamaica Avenue westbound;

24 (j) 242nd Street;

25 (k) 243rd Street;

26 (l) 244th Street from Superior Road to Jamaica Avenue westbound;

27 (m) 245th Street from Superior Road to the Jericho Turnpike westbound;
