AN ACT to amend the mental hygiene law, in relation to establishing the independent intellectual and developmental disability ombudsman program

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. The mental hygiene law is amended by adding a new section 33.28 to read as follows:

3 § 33.28 Independent intellectual and developmental disability ombudsman program. 4

(a) There is hereby established by the office for people with developmental disabilities the independent intellectual and developmental disability ombudsman program for the purpose of assisting individuals with intellectual and developmental disabilities to ensure their access to services and preservation of their rights.

10 (b) Such ombudsman program shall have the following duties, including, 11 but not limited to:

1. establishing a service delivery structure based in New York state 12 13 that includes a toll-free telephone hotline, an interactive website, and 14 availability of in-person, telephone and email access to ombudsman program staff or volunteers; 15

2. identifying, investigating, referring and resolving complaints made by, or on behalf of, individuals relative to their access to services provided by the office for people with developmental disabilities or the care coordination provided by health homes serving individuals with intellectual and/or developmental disabilities or services provided by other providers;

3. providing assistance for navigating and completing processes, such 23 as paperwork and documentation, to access services provided by the office for people with developmental disabilities or the care coordi-24 nation provided by health homes serving individuals with intellectual 26 and/or developmental disabilities to individuals or services provided by other providers, and/or anyone seeking assistance on their behalf; 27

4. assisting individuals in filing and preparing appeals, and representing individuals in appeals and hearings concerning adverse benefit determinations regarding services provided by the office for people with developmental disabilities or health homes serving individuals with intellectual and/or developmental disabilities to individuals or services provided by other providers;

- 5. collecting, tracking, and quantifying problems and inquiries encountered by individuals; and
- 6. educating individuals on their rights and responsibilities with respect to access to services provided by the office for people with developmental disabilities and care coordination provided by health homes serving individuals with intellectual and/or developmental disabilities or services provided by other providers.
- (c) Notices and materials provided to individuals by the office for people with developmental disabilities, providers of services, and the health homes serving individuals with intellectual and/or developmental disabilities shall include the name, phone number and website address of the independent intellectual and developmental disability ombudsman program established by the office for people with developmental disabilities pursuant to this section.
- 20 21 (d) Notwithstanding sections one hundred twelve and one hundred 22 sixty-three of the state finance law and section one hundred forty-two of the economic development law, or any other inconsistent provision of 23 law, funds available for expenditure pursuant to this section for the 24 25 establishment of an independent intellectual and developmental disability ombudsman program may be allocated and distributed by the commission-26 27 er of the office for people with developmental disabilities, subject to the approval of the director of the budget, but only after the commis-28 sioner of the office for people with developmental disabilities holds a 29 30 request for proposal process for the establishment of an independent intellectual and developmental disability ombudsman program. Only domes-31 32 tic not-for-profit corporations shall be eliqible to submit proposals 33 for such program. Entities that currently receive funding from the 34 office for people with developmental disabilities to provide services to 35 people with intellectual and developmental disabilities, or to operate 36 care coordination organizations, or that bill the Medicaid program for 37 medical or healthcare services, shall be excluded from consideration. The commissioner of the office for people with developmental disabili-38 39 ties shall consider all competitive proposals submitted through such request for proposal process and shall determine, based on his or her 40 discretion, which proposal submitted is most competitive for the estab-41 42 lishment of an independent intellectual and developmental disability 43 ombudsman program. In the exercise of such discretion, the commissioner 44 of the office for people with developmental disabilities shall exercise 45 a preference in favor of applicants who demonstrate experience providing 46 advocacy or assistance to people with intellectual and developmental 47 disabilities, experience operating a call center, and experience track-48 ing and reporting on case activities while protecting individual confi-49 dentiality.
- 50 § 2. This act shall take effect on the one hundred eightieth day after 51 it shall have become a law.
