AN ACT to amend the executive law, in relation to awards made to crime victims

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Subdivision 8 of section 621 of the executive law, as added 2 by chapter 197 of the laws of 1983, is amended to read as follows:

- 8. "Essential personal property" shall mean articles of personal property necessary and essential to the health, welfare or safety of the victim.
- (a) Personal property necessary and essential to the welfare of the victim shall mean personal property of a victim that is lost, damaged, or stolen as a result of a crime and for which reimbursement or replacement is reasonably necessary for the victim to restore stability or maintain a reasonable and/or basic standard of living.
- 11 (b) The office shall promulgate rules and regulations for the determi-12 nation and approval of what constitutes property reasonably necessary to 13 restore or maintain a reasonable and/or basic standard of living 14 consistent with this article.
- § 2. Subdivision 9 of section 631 of the executive law, as amended by 16 chapter 487 of the laws of 2014, is amended to read as follows:
- 17 9. (a) Any award made for the cost of repair or replacement of essential personal property, including cash losses of essential personal 18 property, shall be limited to an amount of [five] twenty-five hundred 19 20 dollars, except that all cash losses of essential personal property shall be limited to the amount of one hundred dollars. In the case of 22 medically necessary life-sustaining equipment which was lost or damaged 23 as the direct result of a crime, the award shall be limited to the 24 amount of ten thousand dollars.
- 25 (b) For property necessary and essential to the welfare of the victim, 26 the office may request that the claimant provide estimates or receipts

for personal property lost, damaged or stolen as a result of the crime. A claimant's inability to produce a receipt for lost, stolen or damaged personal items shall not in itself disqualify a claimant from receiving reimbursement for such items. The office shall consider all the facts

- § 3. Subdivision 9 of section 631 of the executive law, as amended by 35 section 1 of part I of chapter 55 of the laws of 2022, is amended to 36 37 read as follows:
- 38 9. (a) Any award made for the cost of repair or replacement of essen-39 tial personal property, including cash losses of essential personal property, shall be limited to an amount of twenty-five hundred dollars, 40 except that all cash losses of essential personal property shall be 41 limited to the amount of one hundred dollars. In the case of medically 42 43 necessary life-sustaining equipment which was lost or damaged as the direct result of a crime, the award shall be limited to the amount of 44 45 ten thousand dollars.
- 46 (b) For property necessary and essential to the welfare of the victim, 47 the office may request that the claimant provide estimates or receipts for personal property lost, damaged or stolen as a result of the crime. 48 A claimant's inability to produce a receipt for lost, stolen or damaged 49 personal items shall not in itself disqualify a claimant from receiving 50 reimbursement for such items. The office shall consider all the facts 51 52 and circumstances of each case before making a determination.
- (c) Personal property necessary and essential to the welfare of the 53 54 victim shall include, but not be limited to, the following items lost, 55 <u>damaged</u>, or stolen as a result of the crime:
