AN ACT authorizing the county of Suffolk to alienate certain lands used as parklands to enable Sunrise Wind, LLC to construct, maintain and operate a subterranean conduit and electrical distribution cable system, together with subterranean transition joint bays and link boxes, on county of Suffolk parkland located at Southaven County Park, Smith Point County Park and Smith Point County Marina and appurtenances thereto

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Subject to the provisions of this act, the county of
2 Suffolk is hereby authorized, acting by and through its governing body,
3 and upon such terms and conditions as determined by such governing body,
4 to: (a) temporarily discontinue the use of the parklands described in
5 section three of this act; and (b) to discontinue the use as parkland
6 and alienate the lands described in section four of this act, and convey
7 such lands to Sunrise Wind, LLC for the purpose of constructing, main-
8 taining and operating a subterranean conduit and electrical distribution
9 cable system, together with subterranean transition joint bays and link
10 boxes, and appurtenances thereto, on county of Suffolk parkland located
11 at Southaven County Park, Smith Point County Park and Smith Point County
12 Marina.

13 § 2. The authorization contained in section one of this act shall only
14 be effective on the condition that the county of Suffolk dedicate an
15 amount equal to or greater than fair market value of the parklands being
16 alienated pursuant to section one of this act towards the acquisition of
17 new parklands and/or capital improvements to existing park and recre-
18 ational facilities.

§ 3. The parklands authorized by section one of this act to be temporarily discontinued as parkland for construction are described as follows:

Parcel 1

Thence running northwesterly through land now or formerly of Suffolk County the following five courses and distances: North 67°00'09" West a distance of 131.82 feet to a point; thence along a curve to the right having a radius of 210.00 feet, a central angle of 49°08'23", a length of 180.11 feet, and a chord bearing of North 42°25'58" West a distance of 174.64 feet to a point; thence North 17°51'46" West a distance of 219.84 feet to a point; thence along a curve to the right having a radi-

us of 210.00 feet, a central angle of 14°05'52", a length of 51.67 feet and a chord bearing of North 10°48'50" West a distance of 51.54 feet to the point; thence North 33°00'22" West a distance of 247.88' feet to a point, said point being on the southerly side of Bellport Bay, being land now or formerly of the Town of Brookhaven;

Thence running northeasterly along land now or formerly of the Town of Brookhaven the following two courses and distances: North 20°10'55" East a distance of 49.45 feet to a point; thence North 21°13'47" East a distance of 37.48 feet to a point;

Thence running southeasterly through land now or formerly of Suffolk County the following seven courses and distances: South 33°00'22" East a distance of 166.37 feet to a point; thence along a curve to the right having a radius of 210.00 feet, a central angle of 35°45'38", a length of 131.07 feet, and chord bearing South 15°07'34" East a distance of 128.95 feet to a point; thence South 2°45'15" West a distance of 2.31 feet to a point; along a curve to the left having a radius of 190.00 feet, a central angle of 20°37'01", a length of 68.37 feet, and a chord bearing of South 7°33'16" East a distance of 68.00 feet to a point; thence South 17°51'46" East a distance of 219.84 feet to a point; thence along a curve to the left having a radius of 190.00 feet, a central angle of 49°08'23", a length of 162.95 feet, and a chord bearing of South 42°25'58" East a distance of 158.00 feet to a point; thence South 67°00'09" East a distance of 131.82 feet to a point;

Thence running southeasterly through land now or formerly of Suffolk County and the William Floyd Parkway, in part through each along a curve to the left having a radius of 190.00 feet, a central angle of 41°46'26", a length of 138.53 feet, and a chord bearing of South 87°53'22" East a distance of 135.48 feet to a point;

Thence running northeasterly through the William Floyd Parkway and land now or formerly of Suffolk County, in part through each North 71°13'25" East a distance of 195.44 feet to a point;

Thence running northeasterly through land now or formerly of Suffolk County the following five courses and distances: along a curve to the left having a radius of 190.00 feet, a central angle of 68°23'16", a length of 226.78 feet, and a chord bearing of North 37°01'47" East a distance of 213.56 feet to a point; thence North 2°50'09" East a distance of 37.60 feet to a point; thence along a curve to the right having a radius of 210.00 feet, a central angle of 65°05'16", a length of 238.56 feet, and a chord bearing of North 35°22'48" East a distance of 225.94 feet to a point; thence North 67°55'26" East a distance of 1,249.25 feet to a point; thence along a curve to the right having a radius of 210.00 feet, a central angle of 39°33'13", a length of 144.97 feet, and a chord bearing of North 87°42'02" East a distance of 142.11 feet to a point;

Thence running southwesterly through land now or formerly of Suffolk County South 46°41'57" West a distance of 11.55 feet to the point of beginning.

Containing within said bounds 1.68 Acres, more or less.

§ 5. Upon completion of construction, Sunrise Wind, LLC, as authorized by this act in agreement and in consultation with the Suffolk County Department of Parks, Recreation & Conservation, shall restore the surface of the lands more particularly described in section three of this act and such lands shall continue to be used for park purposes.

§ 6. In the event that the county of Suffolk received any funding support or assistance from the federal government for the purchase, maintenance, or improvement of the parklands set forth in sections three

1 and four of this act, the discontinuance and alienation of such park-
2 lands authorized by the provisions of this act shall not occur until the
3 county of Suffolk has complied with any federal requirements pertaining
4 to the alienation or conversion of parklands, including satisfying the
5 secretary of the interior that the alienation or conversion complies
6 with all conditions which the secretary of the interior deems necessary
7 to assure the substitution of other lands shall be equivalent in fair
8 market value and usefulness to the lands being alienated or converted.
9 § 7. This act shall take effect immediately.
