AN ACT to amend chapter 463 of the laws of 2000 relating to authorizing the village of Saugerties to lease the waterfront park land and convey a right of way to the Hudson River Sloop Clearwater, Inc., in relation to the number and description of courses in the right of way easement

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Section 3 of chapter 463 of the laws of 2000 relating to
2 authorizing the village of Saugerties to lease the waterfront park land
3 and convey a right of way to the Hudson River Sloop Clearwater, Inc., is
4 amended to read as follows:

5 § 3. The easement over park lands authorized by section one of this
6 act, is bounded and described as follows:

7 ALL THAT TRACT OR PARCEL OF LAND situate in the village of Saugerties;
8 County of Ulster, State of New York, and said parcel being more partic-
9 ularly bounded and described as follows:

10 Beginning at a point on the Northerly line of a public road known as
11 East Bridge Street, said point also being at the centerline of the here-
12 in described 16' (feet) wide right-of-way and on the Southerly line of
13 lands now or formerly of the Village of Saugerties (Saugerties Water-
14 front Park), and S71°20'42"E 13.40' (feet) from the Southeast corner of
15 lands now or formerly of East Bridge Street Associates, L.P.; and
16 running thence, through the lands of aforesaid Village of Saugerties,
17 the following [~~six (6)~~] seven (7) courses:

18 (1) N19°16'39"E 165.16'(feet) to a point,

19 (2) On a curve to the right having a radius of 50'(feet), an arc
20 length of 17.38'(feet) and a chord of N29°14'10"E 17.29'(feet) to a
21 point,

22 (3) N39°11'41"E 44.53'(feet) to a point,

23 (4) On a curve to the left having a radius of 50'(feet), an arc length
24 of 21.49'(feet) and a chord of N26°52'45"E 21.33'(feet) to a point,

25 (5) N14°33'49"E 29.31'(feet) to a point,

1 (6) On a curve to the right having a radius of 50.00'(feet), an arc
2 length of 9.92'(feet) and a chord of N20°14'57"E 9.91'(feet) to a point,

3 (7) N25°56'06"E 12.00' (feet) to a point on the Southerly line of
4 lands now or formerly of Clearwater, Inc., said point being S77°07'17"E
5 35.67' (feet) from the Southwest corner of lands of said Clearwater,
6 Inc.

7 Hereby intending to describe a 16' (feet) wide right of way over a
8 parcel of land containing .11 acres of land more or less.

9 § 2. This act shall take effect immediately.
