AN ACT to amend the navigation law, in relation to the rates for pilotage on the Hudson river

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Subparagraph 1 of paragraph (b) of subdivision 4 of section 89-a of the navigation law is amended by adding five new clauses (viii), (ix), (x), (xi) and (xii) to read as follows:

(viii) Effective January first, two thousand twenty-three, the following base pilotage rates shall be applicable:

All vessels of 100 pilotage units and over shall pay \$14.02 per pilotage unit for Section 1, Lower River; Yonkers, to all ports through Hyde Park.

The following base pilotage rates shall be applicable to Section 1, Lower River:

Up to 50 pilotage units \$979.74

More than 50 and up to 100 pilotage units \$1400.60

A maximum charge of up to 500 pilotage units shall be applicable.

All vessels of 100 pilotage units and over shall pay a base pilotage rate of \$19.75

per pilotage unit for Section 2, Upper River; Yonkers to all ports beyond Hyde Park through Albany or Troy.

The following base pilotage rates shall be applicable to Section 2, Upper River:

Up to 50 pilotage units \$1615.01

More than 50 and up to 100 pilotage units \$1973.91

A maximum charge of up to 500 pilotage units shall be applicable.

(ix) Effective January first, two thousand twenty-four, the following base pilotage rates shall be applicable:

All vessels of 100 pilotage units and over shall pay \$14.44 per pilotage unit for Section 1, Lower River; Yonkers to all ports through Hyde Park.

The following base pilotage rates shall be applicable to Section 1, Lower River:

Up to 50 pilotage units \$1009.13

More than 50 and up to 100 pilotage units \$1442.62

A maximum charge of up to 500 pilotage units shall be applicable.

All vessels of 100 pilotage units and over shall pay a base pilotage rate of \$20.34 per pilotage unit for Section 2, Upper River; Yonkers to all ports beyond Hyde Park through Albany or Troy.

The following base pilotage rates shall be applicable to Section 2, Upper River:

Up to 50 pilotage units \$1663.46

More than 50 and up to 100 pilotage units \$2033.13

A maximum charge of up to 500 pilotage units shall be applicable.

(x) Effective January first, two thousand twenty-five, the following base pilotage rates shall be applicable:

All vessels of 100 pilotage units and over shall pay \$14.87 per pilotage unit for Section 1, Lower River; Yonkers to all ports through Hyde Park.

The following base pilotage rates shall be applicable to Section 1, Lower River:

Up to 50 pilotage units \$1039.40

More than 50 and up to 100 pilotage units \$1485.90

A maximum charge of up to 500 pilotage units shall be applicable.

All vessels of 100 pilotage units and over shall pay a base pilotage rate of \$20.95 per pilotage unit for Section 2, Upper River; Yonkers to all ports beyond Hyde Park through Albany or Troy.

The following base pilotage rates shall be applicable to Section 2, Upper River:

Up to 50 pilotage units \$1713.36

More than 50 and up to 100 pilotage units \$2094.12

A maximum charge of up to 500 pilotage units shall be applicable.

(xi) Effective January first, two thousand twenty-six, the following base pilotage rates shall be applicable:

All vessels of 100 pilotage units and over shall pay \$15.32 per pilotage unit for Section 1, Lower River; Yonkers to all ports through Hyde Park.

The following base pilotage rates shall be applicable to Section 1, Lower River:

Up to 50 pilotage units \$1070.58

More than 50 and up to 100 pilotage units \$1530.48

A maximum charge of up to 500 pilotage units shall be applicable.

All vessels of 100 pilotage units and over shall pay a base pilotage rate of \$21.58 per pilotage unit for Section 2, Upper River; Yonkers to all ports beyond Hyde Park through Albany or Troy.

The following pilotage rates shall be applicable to Section 2, Upper River:

Up to 50 pilotage units \$1764.76

More than 50 and up to 100 pilotage units \$2156.94

A maximum charge of up to 500 pilotage units shall be applicable.

1 (xii) Effective January first, two thousand twenty-seven, the follow-
2 ing base pilotage rates shall be applicable:

3 All vessels of 100 pilotage units and over shall pay \$15.78 per pilo-
4 tage unit for Section 1, Lower River; Yonkers to all ports through Hyde

8 Up to 50 pilotage units \$1102.70

9 More than 50 and up to 100 pilotage units \$1576.39

10 A maximum charge of up to 500 pilotage units shall be applicable.

11 All vessels of 100 pilotage units and over shall pay a base pilotage
12 rate of \$22.23

13 per pilotage unit for Section 2, Upper River; Yonkers to all ports
14 beyond Hyde Park through Albany or Troy.

15 The following pilotage rates shall be applicable to Section 2, Upper
16 River:

17 Up to 50 pilotage units \$1817.70

18 More than 50 and up to 100 pilotage units \$2221.65

19 A maximum charge of up to 500 pilotage units shall be applicable.

20 § 2. This act shall take effect January 1, 2023.
