AN ACT to amend the environmental conservation law, in relation to providing free lifetime licenses for New York state's honorably discharged, disabled veterans

## The People of the State of New York, represented in Senate and Assembly, do enact as follows:

- 1 Section 1. Subdivision 1 of section 11-0702 of the environmental 2 conservation law, as amended by section 16 of part R of chapter 58 of 3 the laws of 2013, is amended to read as follows:
- 1. There are hereby created the following lifetime hunting, fishing, trapping, archery and muzzle-loading privileges and fees therefor subject to the same privileges and obligations of a comparable short term license:

The holder of a lifetime hunting license or lifetime fishing license may, at any time, convert such license to a lifetime license pursuant to paragraph a of this subdivision for an additional fee equal to the difference between the current fee for the new license and the fee originally paid for the license.
