AN ACT to amend the navigation law, in relation to Hudson River pilotage

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Subparagraph 1 of paragraph (b) of subdivision 4 of section 89-a of the navigation law is amended by adding five new clauses (viii), 3 (ix), (x), (xi) and (xii) to read as follows: 4 (viii) Effective January first, two thousand twenty-three, the follow-5 <u>ing base pilotage rates shall be applicable:</u> 6 All vessels of 100 pilotage units and over shall pay \$14.02 per pilo-7 tage unit for Section 1, Lower River; Yonkers, to all ports through Hyde 8 Park.
