AN ACT to amend the labor law, in relation to the calculation of the experience rating charge of certain employers for purposes of contributions to the state unemployment insurance fund

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Paragraph (e) of subdivision 1 of section 581 of the labor 2 law is amended by adding a new subparagraph 7 to read as follows:

3 (7) An employer's account shall not be charged, and the charges shall
4 instead be made to the general account, for benefits paid to a claimant
5 whose employment was terminated as a result of the reinstatement of an
6 employee pursuant to section two hundred three-b of the workers' compen7 sation law.

§ 2. This act shall take effect immediately.
