AN ACT to amend the environmental conservation law, in relation to establishing a Senior Environmental Corps that would utilize the expertise of professional seniors for environmental and natural resource programs

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. The environmental conservation law is amended by adding a 2 new article 50 to read as follows:

17 <u>§ 50-0103. Legislative findings.</u>

18 The legislature finds that:

(1) Enhancement and protection of the state's environment demands more

20 resources than government funding can provide;

(2) A critical underutilized asset to society is the knowledge,

22 skills, abilities, and wisdom of our expanding, able senior population;

- (3) Central to the well-being and continued connection to the society of New York's senior citizens is the opportunity for them to voluntarily continue to provide meaningful contributions and to share their professional training, lifelong skills, talents, and wisdom with New York's citizens;

- As used in this article:
- (1) "Agency" means one of the agencies or organizations participating in the activities of the senior environmental corps.
- (2) "Coordinator" means the person designated by the commissioner with the advice of the council to administer the activities of the senior environmental corps.
  - (3) "Corps" means the senior environmental corps.
- 18 (4) "Council" means the senior environmental corps coordinating coun-19 cil.
  - (5) "Department" means the department of environmental conservation.
  - (6) "Commissioner" means the commissioner of the department of environmental conservation or the commissioner's authorized representative.
  - (7) "Representative" means the person who represents an agency on the council and is responsible for the activities of the senior environmental corps in his or her agency.
    - (8) "Senior" means any person who is fifty-five years of age or over.
  - (9) "Volunteer" means a person who is willing to work without expectation of salary or financial reward, and who chooses where he or she provides services and the type of services he or she provides.
  - § 50-0107. Creation of senior environmental corps.
  - The senior environmental corps is created within the department. The departments of health, education and family assistance and the office of aging and the division of veterans' affairs shall participate in the administration and implementation of the corps and each such department, office and division shall appoint three representatives to the council. § 50-0109. Goals of senior environmental corps.
    - The goals of the corps shall be to:
  - (1) Provide resources and a support structure to facilitate corps activities and accomplish goals;
- 40 (2) Carry out professional and paraprofessional projects that focus
  41 on conservation, protection, rehabilitation and enhancement of the
  42 state's natural, environmental and recreational resources and that
  43 otherwise would not be implemented because of limited financial
  44 resources;
- 45 (3) Provide meaningful opportunities for senior volunteers to continue 46 to utilize their professional training, lifelong skills, abilities, 47 experience and wisdom through participation in corps projects;
- 48 (4) Assist agencies in carrying out statutory assignments with limited 49 funding resources;
- 50 <u>(5) Enhance community understanding of environmental issues through</u>
  51 <u>educational outreach; and</u>
- 52 <u>(6) Enhance the state's ability to provide needed public services in</u> 53 <u>both urban and rural settings.</u>

- 55 <u>The department shall convene a senior environmental corps coordinating</u> 56 <u>council to meet as needed to establish and assess policies; define stan-</u>

- dards for projects, evaluate and select projects; develop recruitment,
- training and placement procedures; receive and review project status and 3
- completing reports; and provide for recognition of volunteer activity.
- The council shall include sixteen representatives, with three represen-
- tatives appointed by the departments of health, education and family
- assistance and the office of aging and the division of veterans'
  - affairs, and one representative appointed by the department. The coun-
- 8 cil shall develop bylaws, policies and procedures to govern its activ-9 <u>ities.</u>
- 10 The council shall advise the commissioner on distribution of available 11 funding for corps activities.

- (1) Contingent upon available funding, the department shall:
- 14 a. Provide a coordinator and staff support to the council as needed;
- 15 b. Provide support to the agencies for recruitment of volunteers;
- 16 c. Develop a budget and allocate available funds with advice of the 17 council;
  - d. Develop a written volunteer agreement;
    - e. Collect and maintain project and volunteer records;
- 20 f. Provide reports to the state legislature and the council as 21 requested;
- q. Provide agency project managers and volunteers with orientation to 22 the corps program and training in the use of volunteers; 23
- h. Act as a liaison with and provide information to other states and 24 25 jurisdictions on the corps program and program activities;
  - i. Appoint a representative to the coordinating council;
- 27 j. Develop project proposals;
  - k. Administer project activities within the agency;
- 1. Develop appropriate procedures for the use of volunteers; 29

n. Maintain project records and provide project reports;

- 30 m. Provide project orientation, technical training, safety training,
- 31 equipment and supplies to carry out project activities;
- o. Apply for and accept grants or contributions for corps approved 33 34 projects; and
- 35 p. With the approval of the council, enter into memoranda of understanding and cooperative agreements with federal, state and local agen-36 37 cies to carry out corps approved projects.
- 38 (2) The department shall not use corps volunteers to displace current-39 ly employed workers.
- 40 § 50-0115. Volunteer agreements.
- 41 All volunteer activity must be performed under the terms of a written 42 master agreement approved by the council and the attorney general. As a 43 minimum, the volunteer agreement must include a description of the work that the volunteer is to perform, including the standards of performance 44 45 required, any expenses or other benefits to which the volunteer is to be 46 entitled, such as mileage, lodging, state industrial coverage, uniforms or other clothing or supplies, training or other support to be provided 47 to the volunteer by the agency, the duration of the agreement, and the 48 terms under which the agreement may be canceled. 49
- § 2. This act shall take effect on the one hundred fiftieth day after 50 it shall have become a law. Effective immediately, the department of 51 52 environmental conservation shall promulgate any rules and regulations 53 necessary for the timely implementation of this act on or before such 54 effective date.
