AN ACT to amend the penal law, in relation to establishing enhanced penalties for threatening to expose a witness or a domestic violence victim's immigration status

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. The penal law is amended by adding a new section 70.11 to 2 read as follows:

§ 70.11 Sentences of imprisonment for domestic violence; aggravating factors.

16 17 In matters divested to a criminal court under section eight hundred twelve of the family court act, or where such court exercises concurrent jurisdiction under such section and in matters referred to a criminal court under article six-A of the social services law, where the respondent threatens to expose a witness or a victim's immigration status in order to coerce such victim or witness or conceal such offense, shall result in the following enhancement of such sentence:
