Introduced by M. of A. BRABENEC -- read once and referred to the Committee on Codes

AN ACT to amend the criminal procedure law and the penal law, in relation to providing judges more discretion regarding securing orders and limiting the lengths of certain orders and increasing the lengths of certain prison sentences; to repeal certain provisions of the criminal procedure law, the judiciary law, the executive law and the penal law relating thereto; to repeal certain provisions of the executive law relating to the use of force by law enforcement; and to repeal certain provisions of the criminal procedure law relating to discovery and motions to vacate judgments

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Subdivision 3 of section 150.10 of the criminal procedure
2 law is REPEALED.

3 § 2. Subdivision 1 of section 150.20 of the criminal procedure law, as
4 amended by section 1-a of part JJJ of chapter 59 of the laws of 2019, is
5 amended to read as follows:

6 1. ~~[(a)]~~ Whenever a police officer is authorized pursuant to section
7 140.10 of this title to arrest a person without a warrant for an offense
8 other than a class A, B, C or D felony or a violation of section 130.25,
9 130.40, 205.10, 205.17, 205.19 or 215.56 of the penal law, he ~~[shall,~~
10 ~~except as set out in paragraph (b) of this subdivision]~~ or she may,
11 subject to the provisions of subdivisions three and four of section
12 150.40 of this ~~[title]~~ article, instead issue to and serve upon such
13 person an appearance ticket.

14 ~~[(b) An officer is not required to issue an appearance ticket if:~~
15 ~~(i) the person has one or more outstanding local criminal court or~~
16 ~~superior court warrants;~~
17 ~~(ii) the person has failed to appear in court proceedings in the last~~

~~(iii) the person has been given a reasonable opportunity to make their verifiable identity and a method of contact known, and has been unable or unwilling to do so, so that a custodial arrest is necessary to subject the individual to the jurisdiction of the court. For the purposes of this section, an officer may rely on various factors to determine a person's identity, including but not limited to personal knowledge of such person, such person's self-identification, or photographic identification. There is no requirement that a person present photographic identification in order to be issued an appearance ticket in lieu of arrest where the person's identity is otherwise verifiable; however, if offered by such person, an officer shall accept as evidence of identity the following: a valid driver's license or non-driver identification card issued by the commissioner of motor vehicles, the federal government, any United States territory, commonwealth or possession, the District of Columbia, a state government or municipal government within the United States or a provincial government of the dominion of Canada; a valid passport issued by the United States government or any other country; an identification card issued by the armed forces of the United States; a public benefit card, as defined in paragraph (a) of subdivision one of section 158.00 of the penal law;~~

~~(iv) the person is charged with a crime between members of the same family or household, as defined in subdivision one of section 530.11 of this chapter;~~

~~(v) the person is charged with a crime defined in article 130 of the penal law;~~

~~(vi) it reasonably appears the person should be brought before the court for consideration of issuance of an order of protection, pursuant to section 530.13 of this chapter, based on the facts of the crime or offense that the officer has reasonable cause to believe occurred;~~

~~(vii) the person is charged with a crime for which the court may suspend or revoke his or her driver license;~~

~~(viii) it reasonably appears to the officer, based on the observed behavior of the individual in the present contact with the officer and facts regarding the person's condition that indicates a sign of distress to such a degree that the person would face harm without immediate medical or mental health care, that bringing the person before the court would be in such person's interest in addressing that need; provided, however, that before making the arrest, the officer shall make all reasonable efforts to assist the person in securing appropriate services.]~~

§ 3. The criminal procedure law is amended by adding a new section 150.30 to read as follows:

§ 150.30 Appearance ticket; issuance and service thereof after arrest upon posting of pre-arraignment bail.

1. Issuance and service of an appearance ticket by a police officer following an arrest without a warrant, as prescribed in subdivision two of section 150.20 of this article, may be made conditional upon the posting of a sum of money, known as pre-arraignment bail. In such case, the bail becomes forfeit upon failure of such person to comply with the directions of the appearance ticket. The person posting such bail must complete and sign a form which states (a) the name, residential address and occupation of each person posting cash bail; and (b) the title of the criminal action or proceeding involved; and (c) the offense or offenses which are the subjects of the action or proceeding involved, and the status of such action or proceeding; and (d) the name of the principal and the nature of his or her involvement in or connection with

1 such action or proceeding; and (e) the date of the principal's next
2 appearance in court; and (f) an acknowledgement that the cash bail will
3 be forfeited if the principal does not comply with the directions of the
4 appearance ticket; and (g) the amount of money posted as cash bail. Such
5 pre-arraignment bail may be posted as provided in subdivision two or
6 three of this section.

7 2. A desk officer in charge at a police station, county jail, or
8 police headquarters, or any of his or her superior officers, may in such
9 place, fix pre-arraignment bail, in an amount prescribed in this subdi-
10 vision, and upon the posting thereof must issue and serve an appearance
11 ticket upon the arrested person, give a receipt for the bail, and
12 release such person from custody. Such pre-arraignment bail may be fixed
13 in the following amounts:

14 (a) If the arrest was for a class E felony, any amount not exceeding
15 seven hundred fifty dollars.

16 (b) If the arrest was for a class A misdemeanor, any amount not
17 exceeding five hundred dollars.

18 (c) If the arrest was for a class B misdemeanor or an unclassified
19 misdemeanor, any amount not exceeding two hundred fifty dollars.

20 (d) If the arrest was for a petty offense, any amount not exceeding
21 one hundred dollars.

22 3. A police officer, who has arrested a person without a warrant
23 pursuant to subdivision two of section 150.20 of this article for a
24 traffic infraction, may, where he or she reasonably believes that such
25 arrested person is not licensed to operate a motor vehicle by this state
26 or any state covered by a reciprocal compact guaranteeing appearance as
27 is provided in section five hundred seventeen of the vehicle and traffic
28 law, fix pre-arraignment bail in the amount of fifty dollars; provided,
29 however, such bail shall be posted by means of a credit card or similar
30 device. Upon the posting thereof, said officer must issue and serve an
31 appearance ticket upon the arrested person, give a receipt for the bail,
32 and release such person from custody.

33 4. The chief administrator of the courts shall establish a system for
34 the posting of pre-arraignment bail by means of credit card or similar
35 device, as is provided by section two hundred twelve of the judiciary
36 law. The head of each police department or police force and of any state
37 department, agency, board, commission or public authority having police
38 officers who fix pre-arraignment bail as provided herein may elect to
39 use the system established by the chief administrator or may establish
40 such other system for the posting of pre-arraignment bail by means of
41 credit card or similar device as he or she may deem appropriate.

42 § 4. Subdivision 1 of section 150.40 of the criminal procedure law, as
43 amended by section 8 of part UU of chapter 56 of the laws of 2020, is
44 amended to read as follows:

45 1. An appearance ticket must be made returnable [~~at a date as soon as~~
46 ~~possible, but in no event later than twenty days from the date of issu-~~
47 ~~ance, or at the next scheduled session of the appropriate local criminal~~
48 ~~court if such session is scheduled to occur more than twenty days from~~
49 ~~the date of issuance; or at a later date, with the court's permission~~
50 ~~due to enrollment in a pre-arraignment diversion program. The appearance~~
51 ~~ticket shall be made returnable] in a local criminal court designated in
52 section 100.55 of this title as one with which an information for the
53 offense in question may be filed.~~

54 § 5. Section 150.80 of the criminal procedure law is REPEALED.

55 § 6. Subdivision 2 of section 245.30 of the criminal procedure law is
56 REPEALED.

§ 7. Subdivision 9 of section 440.10 of the criminal procedure law is REPEALED.

§ 8. Subparagraph (ii) of paragraph (i) and paragraph (j) of subdivision 1 of section 440.10 of the criminal procedure law, as amended by chapter 131 of the laws of 2019, are amended to read as follows:

(ii) official documentation of the defendant's status as a victim of trafficking, compelling prostitution or trafficking in persons at the time of the offense from a federal, state or local government agency shall create a presumption that the defendant's participation in the offense was a result of having been a victim of sex trafficking, compelling prostitution or trafficking in persons, but shall not be required for granting a motion under this paragraph[~~†~~]

~~(j) The judgment is a conviction for a class A or unclassified misdemeanor entered prior to the effective date of this paragraph and satisfies the ground prescribed in paragraph (h) of this subdivision. There shall be a rebuttable presumption that a conviction by plea to such an offense was not knowing, voluntary and intelligent, based on ongoing collateral consequences, including potential or actual immigration consequences, and there shall be a rebuttable presumption that a conviction by verdict constitutes cruel and unusual punishment under section five of article one of the state constitution based on such consequences~~; or

§ 9. Subdivisions 3-a, 3-b, 21 and 22 of section 500.10 of the criminal procedure law are REPEALED.

§ 10. Subdivisions 5, 6, 7 and 9 of section 500.10 of the criminal procedure law, as amended by section 1-e of part JJJ of chapter 59 of the laws of 2019, are amended to read as follows:

5. "Securing order" means an order of a court committing a principal to the custody of the sheriff, or fixing bail, ~~[where authorized,]~~ or releasing the principal on the principal's own recognizance ~~[or releasing the principal under non-monetary conditions]~~.

6. "Order of recognizance or bail" means a securing order releasing a principal on the principal's own recognizance or ~~[under non-monetary conditions or, where authorized,]~~ fixing bail.

7. "Application for recognizance or bail" means an application by a principal that the court, instead of committing the principal to or retaining the principal in the custody of the sheriff, either release the principal on the principal's own recognizance~~[, release under non-monetary conditions, or, where authorized,]~~ or fix bail.

9. "Bail" means cash bail~~[,]~~ or a bail bond ~~[or money paid with a credit card]~~.

§ 11. Section 510.10 of the criminal procedure law, as amended by section 2 of part JJJ of chapter 59 of the laws of 2019 and subdivision 4 as amended by section 2 of part UU of chapter 56 of the laws of 2020, is amended to read as follows:

§ 510.10 Securing order; when required~~[, alternatives available, standard to be applied]~~.

~~[1.]~~ When a principal, whose future court attendance at a criminal action or proceeding is or may be required, initially comes under the control of a court, such court shall~~[, in accordance with this title,]~~ by a securing order, either release the principal on the principal's own recognizance, ~~[release the principal under non-monetary conditions, or, where authorized,]~~ fix bail or commit the principal to the custody of the sheriff. ~~[In all such cases, except where another type of securing order is shown to be required by law, the court shall release the principal pending trial on the principal's own recognizance, unless it is~~

~~demonstrated and the court makes an individualized determination that the principal poses a risk of flight to avoid prosecution. If such a finding is made, the court must select the least restrictive alternative and condition or conditions that will reasonably assure the principal's return to court. The court shall explain its choice of release, release with conditions, bail or remand on the record or in writing.~~

~~2. A principal is entitled to representation by counsel under this chapter in preparing an application for release, when a securing order is being considered and when a securing order is being reviewed for modification, revocation or termination. If the principal is financially unable to obtain counsel, counsel shall be assigned to the principal.~~

~~3. In cases other than as described in subdivision four of this section the court shall release the principal pending trial on the principal's own recognizance, unless the court finds on the record or in writing that release on the principal's own recognizance will not reasonably assure the principal's return to court. In such instances, the court shall release the principal under non-monetary conditions, selecting the least restrictive alternative and conditions that will reasonably assure the principal's return to court. The court shall explain its choice of alternative and conditions on the record or in writing.~~

~~4. Where the principal stands charged with a qualifying offense, the court, unless otherwise prohibited by law, may in its discretion release the principal pending trial on the principal's own recognizance or under non-monetary conditions, fix bail, or, where the defendant is charged with a qualifying offense which is a felony, the court may commit the principal to the custody of the sheriff. A principal stands charged with a qualifying offense for the purposes of this subdivision when he or she stands charged with:~~

~~(a) a felony enumerated in section 70.02 of the penal law, other than robbery in the second degree as defined in subdivision one of section 160.10 of the penal law, provided, however, that burglary in the second degree as defined in subdivision two of section 140.25 of the penal law shall be a qualifying offense only where the defendant is charged with entering the living area of the dwelling;~~

~~(b) a crime involving witness intimidation under section 215.15 of the penal law;~~

~~(c) a crime involving witness tampering under section 215.11, 215.12 or 215.13 of the penal law;~~

~~(d) a class A felony defined in the penal law, provided that for class A felonies under article two hundred twenty of the penal law, only class A-I felonies shall be a qualifying offense;~~

~~(e) a sex trafficking offense defined in section 230.34 or 230.34-a of the penal law, or a felony sex offense defined in section 70.80 of the penal law, or a crime involving incest as defined in section 255.25, 255.26 or 255.27 of such law, or a misdemeanor defined in article one hundred thirty of such law;~~

~~(f) conspiracy in the second degree as defined in section 105.15 of the penal law, where the underlying allegation of such charge is that the defendant conspired to commit a class A felony defined in article one hundred twenty five of the penal law;~~

~~(h) criminal contempt in the second degree as defined in subdivision three of section 215.50 of the penal law, criminal contempt in the first degree as defined in subdivision (b), (c) or (d) of section 215.51 of the penal law or aggravated criminal contempt as defined in section 215.52 of the penal law, and the underlying allegation of such charge of criminal contempt in the second degree, criminal contempt in the first degree or aggravated criminal contempt is that the defendant violated a duly served order of protection where the protected party is a member of the defendant's same family or household as defined in subdivision one of section 530.11 of this title;~~

~~(i) facilitating a sexual performance by a child with a controlled substance or alcohol as defined in section 263.30 of the penal law, use of a child in a sexual performance as defined in section 263.05 of the penal law or luring a child as defined in subdivision one of section 120.70 of the penal law, promoting an obscene sexual performance by a child as defined in section 263.10 of the penal law or promoting a sexual performance by a child as defined in section 263.15 of the penal law;~~

~~(j) any crime that is alleged to have caused the death of another person;~~

~~(k) criminal obstruction of breathing or blood circulation as defined in section 121.11 of the penal law, strangulation in the second degree as defined in section 121.12 of the penal law or unlawful imprisonment in the first degree as defined in section 135.10 of the penal law, and is alleged to have committed the offense against a member of the defendant's same family or household as defined in subdivision one of section 530.11 of this title;~~

~~(l) aggravated vehicular assault as defined in section 120.04-a of the penal law or vehicular assault in the first degree as defined in section 120.04 of the penal law;~~

~~(m) assault in the third degree as defined in section 120.00 of the penal law or arson in the third degree as defined in section 150.10 of the penal law, when such crime is charged as a hate crime as defined in section 485.05 of the penal law;~~

~~(n) aggravated assault upon a person less than eleven years old as defined in section 120.12 of the penal law or criminal possession of a weapon on school grounds as defined in section 265.01-a of the penal law;~~

~~(o) grand larceny in the first degree as defined in section 155.42 of the penal law, enterprise corruption as defined in section 460.20 of the penal law, or money laundering in the first degree as defined in section 470.20 of the penal law;~~

~~(p) failure to register as a sex offender pursuant to section one hundred sixty-eight t of the correction law or endangering the welfare of a child as defined in subdivision one of section 260.10 of the penal law, where the defendant is required to maintain registration under article six C of the correction law and designated a level three offender pursuant to subdivision six of section one hundred sixty-eight l of the correction law;~~

~~(q) a crime involving bail jumping under section 215.55, 215.56 or 215.57 of the penal law, or a crime involving escaping from custody under section 205.05, 205.10 or 205.15 of the penal law;~~

~~(r) any felony offense committed by the principal while serving a sentence of probation or while released to post release supervision;~~
~~(s) a felony, where the defendant qualifies for sentencing on such charge as a persistent felony offender pursuant to section 70.10 of the penal law; or~~

~~(t) any felony or class A misdemeanor involving harm to an identifiable person or property, where such charge arose from conduct occurring while the defendant was released on his or her own recognizance or released under conditions for a separate felony or class A misdemeanor involving harm to an identifiable person or property, provided, however, that the prosecutor must show reasonable cause to believe that the defendant committed the instant crime and any underlying crime. For the purposes of this subparagraph, any of the underlying crimes need not be a qualifying offense as defined in this subdivision.~~

~~5. Notwithstanding the provisions of subdivisions three and four of this section, with respect to any charge for which bail or remand is not ordered, and for which the court would not or could not otherwise require bail or remand, a defendant may, at any time, request that the court set bail in a nominal amount requested by the defendant in the form specified in paragraph (a) of subdivision one of section 520.10 of this title, if the court is satisfied that the request is voluntary, the court shall set such bail in such amount.~~

~~6.]~~ When a securing order is revoked or otherwise terminated in the course of an uncompleted action or proceeding but the principal's future court attendance still is or may be required and the principal is still under the control of a court, a new securing order must be issued. When the court revokes or otherwise terminates a securing order which committed the principal to the custody of the sheriff, the court shall give written notification to the sheriff of such revocation or termination of the securing order.

§ 12. Section 510.20 of the criminal procedure law, as amended by section 3 of part JJJ of chapter 59 of the laws of 2019, is amended to read as follows:

§ 510.20 Application for [~~a change in securing order~~] recognizance or bail; making and determination thereof in general.

1. Upon any occasion when a court [~~has issued~~] is required to issue a securing order with respect to a principal [~~and the~~], or at any time when a principal is confined in the custody of the sheriff as a result of [~~the securing order or~~] a previously issued securing order, the principal may make an application for recognizance[, ~~release under non-monetary conditions~~] or bail.

2. [~~(a) The principal is entitled to representation by counsel in the making and presentation of such application. If the principal is financially unable to obtain counsel, counsel shall be assigned to the principal.~~

~~(b)]~~ Upon such application, the principal must be accorded an opportunity to be heard[, ~~present evidence~~] and to contend that an order of recognizance[, ~~release under non-monetary conditions~~] or[, ~~where authorized,~~] bail must or should issue, that the court should release the principal on the principal's own recognizance [~~or under non-monetary conditions~~] rather than fix bail, and that if bail is [~~authorized and~~] fixed it should be in a suggested amount and form.

§ 13. Section 510.30 of the criminal procedure law, as amended by section 5 of part JJJ of chapter 59 of the laws of 2019, is amended to read as follows:

§ 510.30 Application for ~~[securing order]~~ recognizance or bail; rules of law and criteria controlling determination.

1. Determinations of applications for recognizance or bail are not in all cases discretionary but are subject to rules, prescribed in article five hundred thirty of this title and other provisions of law relating to specific kinds of criminal actions and proceedings, providing (a) that in some circumstances such an application must as a matter of law be granted, (b) that in others it must as a matter of law be denied and the principal committed to or retained in the custody of the sheriff, and (c) that in others the granting or denial thereof is a matter of judicial discretion.

2. To the extent that the issuance of an order of recognizance or bail and the terms thereof are matters of discretion rather than of law, an application is determined on the basis of the following factors and criteria:

(a) With respect to any principal, the court ~~[in all cases, unless otherwise provided by law,]~~ must ~~[impose the least restrictive]~~ consider the kind and degree of control or restriction that is necessary to secure the principal's ~~[return to]~~ court attendance when required. In determining that matter, the court must, on the basis of available information, consider and take into account:

(i) The principal's character, reputation, habits and mental condition;

(ii) The principal's employment and financial resources;

(iii) The principal's family ties and the length of his or her residence if any in the community;

~~(iv) [information about the principal that is relevant to the principal's return to court, including:~~

~~(a) The principal's activities and history;~~

~~(b) If the principal is a defendant, the charges facing the principal;~~

~~(c) The principal's criminal [conviction] record if any;~~

~~(d) (v) The principal's record of previous adjudication as a juvenile delinquent, as retained pursuant to section 354.2 of the family court act, or, of pending cases where fingerprints are retained pursuant to section 306.1 of such act, or a youthful offender, if any;~~

~~(e) (vi) The principal's previous record if any in responding to court appearances when required or~~ with respect to flight to avoid criminal prosecution;

~~(f) If monetary bail is authorized, according to the restrictions set forth in this title, the principal's individual financial circumstances, and, in cases where bail is authorized, the principal's ability to post bail without posing undue hardship, as well as his or her ability to obtain a secured, unsecured, or partially secured bond;~~

~~(g) (vii) Where the principal is charged with a crime or crimes against a member or members of the same family or household as that term is defined in subdivision one of section 530.11 of this title, the following factors:~~

~~(i) (A) any violation by the principal of an order of protection issued by any court for the protection of a member or members of the same family or household as that term is defined in subdivision one of section 530.11 of this title, whether or not such order of protection is currently in effect; and~~

~~(ii) (B) the principal's history of use or possession of a firearm; and~~

~~(h) (viii) If the principal is a defendant, the weight of the evidence against him or her in the pending criminal action and any other~~

1 factor indicating probability or improbability of conviction; or, in the
2 case of an application for [~~a securing order~~] bail or recognizance pend-
3 ing appeal, the merit or lack of merit of the appeal; and

4 (ix) If he or she is a defendant, the sentence which may be or has
5 been imposed upon conviction.

6 [~~2-~~] (b) Where the principal is a defendant-appellant in a pending
7 appeal from a judgment of conviction, the court must also consider the
8 likelihood of ultimate reversal of the judgment. A determination that
9 the appeal is palpably without merit alone justifies, but does not
10 require, a denial of the application, regardless of any determination
11 made with respect to the factors specified in paragraph (a) of this
12 subdivision [~~one of this section~~].

13 3. When bail or recognizance is ordered, the court shall inform the
14 principal, if the principal is a defendant charged with the commission
15 of a felony, that the release is conditional and that the court may
16 revoke the order of release and [~~may be authorized~~] to commit the prin-
17 cipal to the custody of the sheriff in accordance with the provisions of
18 subdivision two of section 530.60 of this [~~chapter~~] title if the princi-
19 pal commits a subsequent felony while at liberty upon such order.

20 § 14. Section 510.40 of the criminal procedure law, as amended by
21 section 6 of part JJJ of chapter 59 of the laws of 2019 and paragraph
22 (c) of subdivision 4 as amended by section 7 of part UU of chapter 56 of
23 the laws of 2020, is amended to read as follows:

24 § 510.40 [~~Court notification to principal of conditions of release and~~
25 ~~of alleged violations of conditions of release~~] Application
26 for recognizance or bail; determination thereof, form of
27 securing order and execution thereof.

28 1. An application for recognizance or bail must be determined by a
29 securing order which either:

30 (a) Grants the application and releases the principal on his or her

33 (c) Denies the application and commits the principal to, or retains
34 him or her in, the custody of the sheriff.

35 2. Upon ordering that a principal be released on the principal's own

44 [~~2-~~] 3. Upon the issuance of an order fixing bail[~~, where authorized,~~]
45 and upon the posting thereof, the court must examine the bail to deter-
46 mine whether it complies with the order. If it does, the court must, in
47 the absence of some factor or circumstance which in law requires or
48 authorizes disapproval thereof, approve the bail and must issue a
49 certificate of release, authorizing the principal to be at liberty, and,
50 if the principal is in the custody of the sheriff at the time, directing
51 the sheriff to discharge the principal therefrom. If the bail fixed is
52 not posted, or is not approved after being posted, the court must order
53 that the principal be committed to the custody of the sheriff. [~~In the~~
54 ~~event of any such non-approval, the court shall explain promptly in~~
55 ~~writing the reasons therefor.~~

~~3. Non-monetary conditions of release shall be individualized and established in writing by the court. At future court appearances, the court shall consider a lessening of conditions or modification of conditions to a less burdensome form based on the principal's compliance with such conditions of release.
