AN ACT to amend the criminal procedure law and the family court act, in relation to orders of protection

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. The opening paragraph of subdivision 1 of section 530.14 of
2 the criminal procedure law, as amended by chapter 60 of the laws of
3 2018, is amended to read as follows:

4 Suspension of firearms license and ineligibility for such a license
5 upon issuance of temporary order of protection. Whenever a temporary
6 order of protection is issued pursuant to subdivision one of section
7 530.12 or subdivision one of section 530.13 of this article the court
8 shall inquire of the defendant and the protected party, if the court has
9 reason to believe that such protected party would have actual knowledge
10 or reason to know such information, as to the existence and location of
11 any firearm, rifle or shotgun owned or possessed by the defendant and:

12 § 2. The opening paragraph of subdivision 2 of section 530.14 of the
13 criminal procedure law, as amended by chapter 60 of the laws of 2018, is
14 amended to read as follows:

15 Revocation or suspension of firearms license and ineligibility for
16 such a license upon issuance of an order of protection. Whenever an
17 order of protection is issued pursuant to subdivision five of section
18 530.12 or subdivision four of section 530.13 of this article the court
19 shall inquire of the defendant and the protected party, if the court has
20 reason to believe that such protected party would have actual knowledge
21 or reason to know such information, as to the existence and location of
22 any firearm, rifle or shotgun owned or possessed by the defendant and:

23 § 3. The opening paragraph of subdivision 3 of section 530.14 of the
24 criminal procedure law, as amended by chapter 60 of the laws of 2018, is
25 amended to read as follows:

26 Revocation or suspension of firearms license and ineligibility for
27 such a license upon a finding of a willful failure to obey an order of
28 protection. Whenever a defendant has been found pursuant to subdivision

eleven of section 530.12 or subdivision eight of section 530.13 of this article to have willfully failed to obey an order of protection issued by a court of competent jurisdiction in this state or another state, territorial or tribal jurisdiction, in addition to any other remedies available pursuant to subdivision eleven of section 530.12 or subdivision eight of section 530.13 of this article the court shall inquire of the defendant and the protected party, if the court has reason to believe that such protected party would have actual knowledge or reason to know such information, as to the existence and location of any firearm, rifle or shotgun owned or possessed by the defendant and:

§ 4. The opening paragraph of subdivision 1 of section 842-a of the family court act, as amended by chapter 60 of the laws of 2018, is amended to read as follows:

Suspension of firearms license and ineligibility for such a license upon the issuance of a temporary order of protection. Whenever a temporary order of protection is issued pursuant to section eight hundred twenty-eight of this article, or pursuant to article four, five, six, seven or ten of this act the court shall inquire of the respondent and the petitioner or, if the petitioner is not the protected party, any party protected by such order, if the court has reason to believe that such petitioner or protected party would have actual knowledge or reason to know such information, as to the existence and location of any firearm, rifle or shotgun owned or possessed by the respondent and:

§ 5. The opening paragraph of subdivision 2 of section 842-a of the family court act, as amended by chapter 60 of the laws of 2018, is amended to read as follows:

Revocation or suspension of firearms license and ineligibility for such a license upon the issuance of an order of protection. Whenever an order of protection is issued pursuant to section eight hundred forty-one of this part, or pursuant to article four, five, six, seven or ten of this act the court shall inquire of the respondent and the petitioner or, if the petitioner is not the protected party, any party protected by such order, if the court has reason to believe that such petitioner or protected party would have actual knowledge or reason to know such information, as to the existence and location of any firearm, rifle or shotgun owned or possessed by the respondent and:

§ 6. The opening paragraph of subdivision 3 of section 842-a of the family court act, as amended by chapter 60 of the laws of 2018, is amended to read as follows:

Revocation or suspension of firearms license and ineligibility for such a license upon a finding of a willful failure to obey an order of protection or temporary order of protection. Whenever a respondent has been found, pursuant to section eight hundred forty-six-a of this part to have willfully failed to obey an order of protection or temporary order of protection issued pursuant to this act or the domestic relations law, or by this court or by a court of competent jurisdiction in another state, territorial or tribal jurisdiction, in addition to any other remedies available pursuant to section eight hundred forty-six-a of this part the court shall inquire of the respondent and the petitioner or, if the petitioner is not the protected party, any party protected by such order, if the court has reason to believe that such petitioner or protected party would have actual knowledge or reason to know such information, as to the existence and location of any firearm, rifle or shotgun owned or possessed by the respondent and:

§ 7. This act shall take effect immediately.
