AN ACT authorizing Carl Spatola to receive a refund from the New York state teachers' retirement system

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Notwithstanding the provisions of subdivision b of section 2 902 of the retirement and social security law, Carl Spatola a Tier 4 3 member of the New York state teachers' retirement system who was formerly a member of the New York city teachers' retirement system with 12 5 years 1 month of service credit who then paid contributions as an employee of the Amityville school district during the period October 1, 2000 through June 30, 2004 and initiated a transfer from the New York city teachers' retirement system to the New York state teachers' retirement system during the school year ending June 30, 2005, shall be entitled to a refund of the accumulated three percent contributions paid to 10 said retirement system for the period in which the transfer was not initiated and cessation date was not established if an application is 12 13 filed within one year of the effective date of this act.

- 14 § 2. All costs associated with the implementation of this act shall be 15 borne by the employers of the members of the New York state teachers' 16 retirement system.
 - § 3. This act shall take effect immediately.

FISCAL NOTE. -- Pursuant to Legislative Law, Section 50:

This bill (legislative bill draft 10644-01-1) would allow Carl Spatola, a Tier 4 member of the New York State Teachers' Retirement System (NYSTRS), who was formerly a member of the New York City Teachers' Retirement System (NYCTRS) and who initiated a transfer from NYCTRS to NYSTRS during the school year ending June 30, 2005 to receive a refund of his accumulated 3% contributions paid to NYSTRS for the period in which the transfer was not initiated and the cessation date was not

established. Mr. Spatola must file a written request with the head of the New York State Teachers' Retirement System within one year of the effective date of this bill.

The cost of this benefit is equal to the refund of the accumulated member contributions paid by Mr. Spatola to NYSTRS during this period, which is estimated to be \$22,000. This cost is to be borne by the employers of members of the NYSTRS.

Member data is from the System's most recent actuarial valuation files, consisting of data provided by the employers to the Retirement System. Data distributions and statistics can be found in the System's Annual Report. System assets are as reported in the System's financial statements, and can also be found in the System's Annual Report. Actuarial assumptions and methods are provided in the System's Actuarial Valuation Report.
