Introduced by M. of A. TAYLOR -- read once and referred to the Committee on Election Law

AN ACT to amend the election law, in relation to the appointment of commissioners of elections

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Subdivision 4 of section 3-204 of the election law, as  
2 amended by chapter 116 of the laws of 2010, is amended to read as  
3 follows:

4 4. (a) Commissioners of election shall be appointed by the county  
5 legislative body, or in the city of New York, by the city council.

6 (b) Provided, however, that if a legislative body shall fail to  
7 appoint any person recommended by a party for appointment as a commis-  
8 sioner pursuant to this section, within thirty days after the filing of  
9 a certificate of recommendation with such legislative body, then the  
10 member or members of such legislative body who are members of the poli-  
11 tical party which filed such certificate may appoint such person. And  
12 further provided, if there are no members of the legislative body who  
13 are members of the political party which filed such certificate, the  
14 ~~[appointment shall take effect]~~ person named in the certificate of party  
15 recommendation shall be deemed appointed upon the expiration of thirty  
16 days from the date that the certificate was filed.

17 (c) Where the legislative body includes a member or members of the  
18 political party which filed such certificate, and no action is taken to  
19 appoint such recommended person by either the legislative body or such  
20 member or members within sixty days after the filing of any such certifi-  
21 cate, the person named in such certificate shall be deemed appointed  
22 upon the expiration of such sixty days.

23 (d) If ~~[none of the]~~, pursuant to this subdivision, the members of  
24 such legislative body who are members of the political party which filed  
25 such certificate reject any persons named in any of the certificates

6 (e) If the members of such legislative body who are members of the  
7 political party which filed such certificate fail to appoint such person  
8 recommended by a party in a second certificate of recommendation within  
9 thirty days of the filing of such certificate, the person named in such  
10 certificate shall be deemed appointed upon the expiration of thirty days  
11 from the date that the second certificate was filed.

12 (f) If a party fails to file a certificate within the time prescribed  
13 by this section, the members of the legislative body who are members of  
14 such party may appoint any eligible person to such office.

15 § 2. This act shall take effect immediately.
