Introduced by M. of A. RAJKUMAR -- read once and referred to the Committee on Labor

AN ACT to amend the labor law and the administrative code of the city of New York, in relation to notification of job skills training programs and employment services for taxicab drivers

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Due to a multitude of challenges currently being faced by  
2 many taxicab drivers, there is an increasing desire among some to seek  
3 alternate employment. The introduction of transportation network compa-  
4 nies such as Uber and Lyft, the uncertainty of reliable and adequate  
5 income, long hours, health and safety risks and the recent medallion  
6 crisis which revealed that the average taxicab driver is over \$500,000  
7 in debt, have combined to force many taxicab drivers to leave the indus-  
8 try. The legislature finds that the state and the city of New York  
9 should work to provide job training to aid in the successful transition  
10 of interested taxicab drivers to new employment opportunities.

11 § 2. The labor law is amended by adding a new section 45 to read as  
12 follows:

13 § 45. Job skills training and employment services for taxicab drivers.  
14 The department, in conjunction with the New York city department of  
15 employment, or any other department or agency designated by the mayor of  
16 the city of New York, shall generate a list of all job skills training  
17 programs and employment services provided by or contracted through the  
18 state or the city of New York that are available and open, at no cost,  
19 to taxicab drivers. Programs which provide language instruction, finan-  
20 cial literacy, social services, computer training and career counseling  
21 services shall be included. Such list shall include information on how  
22 to contact and enroll in such programs. Such information shall be  
23 updated annually and provided to the New York city taxi and limousine  
24 commission for distribution to holders of taxicab licenses or medal-  
25 lions.

26 § 3. The administrative code of the city of New York is amended by  
27 adding a new section 19-557 to read as follows:

1 § 19-557 Distribution of job skills training programs and employment  
2 service information. The commission shall distribute, semi-annually, to  
3 all drivers licensed to operate a taxicab under this chapter, the list  
4 and information on available job skills training programs and employment  
5 services which are compiled pursuant to section forty-five of the labor  
6 law. Such information shall be produced in the ten most common languages  
7 spoken by individuals in this state and distributed according to the  
8 language preference indicated by the taxicab driver.

9 § 4. This act shall take effect on the thirtieth day after it shall  
10 have become a law.
