AN ACT to amend the social services law and the education law, in relation to the provision of universal child care; to amend chapter 493 of the laws of 2017 amending the social services law relating to establishing a child care availability taskforce to evaluate the need for and availability of child care throughout the state, in relation to the effectiveness thereof; to amend the state finance law, in relation to establishing certain funds to provide for the establishment and funding of universal child care; to repeal certain provisions of the social services law relating thereto; and making an appropriation therefor

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. This act shall be known and may be cited as the "universal
2 child care act".
3 § 2. Legislative findings. The legislature hereby finds and declares
4 that New York State's child care sector is facing an economic crisis. In
5 2018, the legislature created a Child Care Availability Task Force. In
6 2021, that Task Force issued its final report, finding that the current
7 crisis "requires a dramatically different approach to child care: one
8 that recognizes that high-quality child care is a public good and that
9 provides the necessary public investment" to implement a system of high-
10 quality universal child care. This legislation will move New York
11 towards such a dramatically new system, where child care workers are
12 treated with dignity and compensated generously as the educators that
13 they are, where child care is free and available to all just like our
14 public education system is free and available for all, where burdensome
15 and ineffective means-testing requirements are ultimately eliminated,
16 where public investments are directed towards those most in need as we
17 build out our important child care infrastructure, where families have a
18 meaningful ability to select the modalities that work best for their
19 children, where child care providers are not forced to compete against
20 each other, where high-quality is ensured for all so that we do not have

1 a two-tiered child care system where the wealthy have high-quality care
2 and the working poor have substandard care, where both federal and state
3 funding is allocated generously, where the burden on localities is mini-
4 mized, and where our child care system is truly universal.

5 § 3. Section 390-k of the social services law, as added by chapter 493
6 of the laws of 2017, subdivisions 2, 3, and 4 as amended by chapter 33
7 of the laws of 2018, is amended to read as follows:

8 § 390-k. Child care availability taskforce. 1. There shall be estab-
9 lished within the office of children and family services a child care
10 taskforce for the purpose of [~~evaluating the need for and availability~~
11 ~~of child care throughout the state~~] guiding New York towards a system of
12 free and universal child care.

13 2. The taskforce shall be chaired by a representative of the executive
14 chamber and the commissioners of the office of children and family
15 services [~~and~~], the department of labor and the department of education,
16 or their designees. Members of the taskforce shall serve without compen-
17 sation for three year terms, but may be reimbursed for actual costs
18 incurred for participation on such taskforce. Ensuring adequate
19 geographic representation, members of the taskforce shall be appointed
20 by the governor and comprised as follows:

21 (a) three individuals shall be appointed upon the recommendation of
22 the speaker of the assembly, at least one of whom shall be a parent who
23 has utilized subsidized child care;

24 (b) three individuals shall be appointed upon the recommendation of
25 the temporary president of the senate, at least one of whom shall be a
26 parent who has utilized subsidized child care;

27 (c) two representatives of a child care resource and referral agency;

28 (d) two representatives of home-based child care providers;

29 (e) two representatives of center-based child care providers;

30 (f) two representatives from the business community;

31 (g) two representatives from unions that represent child care provid-
32 ers; and

33 (h) at least one representative from each of the following entities:

34 (i) the office of temporary and disability assistance;

35 (ii) the council on children and families;

36 (iii) the department of taxation and finance;

37 (iv) a regional economic development council;

38 (v) the state university of New York or the city university of New
39 York;

40 (vi) the state education department;

41 (vii) the early childhood advisory council;

42 (viii) a social service district or county government or an entity
43 that advocates on behalf of social services or county governments; and

44 (ix) a non-profit child care advocacy organization.

45 3. The taskforce shall advise the state in developing an implementa-
46 tion framework leading to an expeditious phased-in rollout of universal
47 child care using existing state and federal resources and shall examine
48 the following:

49 (a) [~~affordable child care with a focus on the cost of care for fami-~~
50 ~~lies and factors that contribute to such costs~~] how to implement a truly
51 universal child care system that is free at the point of service for all
52 families and delivers high-quality child care to all New Yorkers, with a
53 four-year phase-in that follows priorities and principles: where expan-
54 sions are targeted to first cover low-income families, historically
55 underserved communities and families facing complex needs, including
56 children with disabilities and child welfare involvement; where work

1 requirements, activities tests, and immigration status requirements for
2 low-income families are all eliminated; where the phase-in takes all
3 reasonable steps to avoid benefits' cliffs; where reasonable steps are
4 taken to guard against increases in costs for middle-income families;
5 and where the roll-out of universal child care is coordinated with the
6 expansions to universal pre-K and 3-K for all programs so that such
7 programs do not cause unintentional harm to child care providers;

8 (b) [~~access to and availability of subsidized child care, including~~
9 ~~the identification of~~] how to eliminate the barriers families eligible
10 under state law face obtaining or utilizing [~~such~~] subsidies;

11 (c) how to ensure the availability of child care for non-traditional
12 work hours, and identification of the funding that would be needed to
13 expand facilities that cover such non-traditional work hours;

14 (d) whether parents are voluntarily leaving the workforce due to lack
15 of [~~affordable or accessible~~] child care, and the demographic informa-
16 tion of such parents, if known;

17 (e) whether employers have identified lack of child care as a reason
18 for a shortage of a qualified workforce;

19 (f) the impact of child care, or lack thereof, on economic development
20 throughout the state;

21 (g) varying levels of quality of care throughout the state;

22 (h) availability of quality child care by economic development region
23 including identification of underserved communities and recommendations
24 making available free, high-quality child care in such communities;

25 (i) whether regulatory or statutory changes could promote free and
26 universal access to high-quality child care and improve health and safe-
27 ty standards in child care programs;

28 (j) [~~business~~] incentives to institutions that offer child care to
29 increase universal and free child care [~~access and the impact on tax~~
30 ~~credits and deductions relating to child care~~];

31 (k) ways to address concerns identified in the course of the examina-
32 tion required by this subdivision; [~~and~~]

33 (l) the existence of illegal and unregulated child care providers, the
34 labor conditions of employees at such facilities, and regulatory recom-
35 mendations for approaching such providers;

36 (m) disparities in the quality of child care provided to families of
37 different economic backgrounds, and the funding needed to provide high-
38 quality child care for all;

39 (n) the factors contributing to the success of implementing universal
40 pre-k programs in the state and the unintended consequences impacting
41 child care providers, particularly family-based providers, in the state,
42 together with recommendations;

43 (o) how to implement federal funding for child care and universal
44 pre-k in a way that maximizes federal appropriations, allows the state
45 to achieve and fund a more expansive program that is not restricted by
46 narrow and restrictive means-testing requirements and implements
47 universal pre-k funding in a manner where the state education department
48 and the office of children and family services coordinate so that such
49 funding is allocated in a manner that supports and expands the state's
50 child care providers, rather than harming existing programs;

51 (p) how to ensure an expeditious phased-in rollout of universal child
52 care using existing state and federal resources, in no more than four
53 years, with an emphasis on building out necessary infrastructure and
54 providing care for those most in need while we move towards a truly
55 universal system;

1 (q) how best to phase in the establishment of a permanent department
2 of early education and care, which shall possess the duties required to
3 maintain and administer the free and high-quality universal child care
4 system pursuant to the recommendations of the taskforce;

5 (r) anything else the taskforce deems necessary.

6 4. The taskforce shall report [~~its interim findings and recommenda-~~
7 ~~tions in accordance with subdivision three of this section to the gover-~~
8 ~~nor, the speaker of the assembly and the temporary president of the~~
9 ~~senate no later than November first, two thousand eighteen and its final~~
10 ~~findings and recommendations no later than December thirty-first, two~~
11 ~~thousand twenty] a four-year plan for a phased roll-out of universal
12 child care in the state, and make annual recommendations, starting in
13 November two thousand twenty-two and each November thereafter through
14 November two thousand twenty-five, for specific appropriations for budg-
15 et allocations that would allow for a truly free and universal child
16 care system, including, but not limited to: (i) wage increases for child
17 care workers that allow them to achieve pay parity with public school
18 teachers; (ii) capital expenditures to allow for the expansion of child
19 care infrastructure into communities most in need; and (iii) startup
20 funds to allow for the creation of new child care programs in child care
21 deserts. Such recommendations shall include recommendations to identify
22 all reasonable means of maximizing the allocation of federal funds, as
23 well as supplemental funding from the state that would allow for a truly
24 free and universal child care system. The taskforce report shall further
25 make recommendations for the integration of child care programs into
26 existing public programs, such as public schools, public universities,
27 and public housing, to deliver high-quality child care to all New York-
28 ers. Such recommendations shall be based on what is needed to actually
29 achieve a high-quality universal child care system in the state, and
30 what additional funding would be needed from the state to achieve that
31 goal. Each year, following the annual state budget, the taskforce shall
32 also provide a score card stating how close New York has come to achiev-
33 ing a high-quality universal child care system, provided, however, that
34 taskforce members who are employees of the governor's office and the
35 state legislature shall recuse themselves from such rating process. The
36 taskforce shall report its findings annually through November two thou-
37 sand twenty-five.~~

38 § 4. Subdivision 8 of section 390 of the social services law, as added
39 by chapter 750 of the laws of 1990, is amended to read as follows:

40 8. The [~~department~~] office of children and family services shall
41 establish and maintain a list of all current registered and licensed
42 child day care programs and a list of all programs whose license or
43 registration has been revoked, rejected, terminated, or suspended. [~~Such~~
44 ~~information shall be available to the public, pursuant to procedures~~
45 ~~developed by the department] The office of children and family services
46 shall work with service providers and child care resource and referral
47 agencies throughout the state to gather information to create and main-
48 tain a publicly-searchable, user-friendly, and language-accessible data-
49 base of available child care facilities on the office's website and on a
50 companion phone application. Such database shall be updated in real
51 time and shall provide and be searchable by the following information:~~

52 (a) the name and address of the facility;

53 (b) the capacity of the facility;

54 (c) whether the facility is fully enrolled or has current availabili-
55 ty, with the available capacity specified by age group;

1 (d) whether the facility has a waiting list for which a family can
2 apply;
3 (e) the age range allowable for the facility;
4 (f) the modality for the facility;
5 (g) the operating hours for the facility;
6 (h) the language or languages spoken at the facility; and
7 (i) whether the facility has been cited for any violations, with any
8 such violations separated into "dangerous" and "non-dangerous" catego-
9 ries, and prominent notices indicating whether any such violations have
10 been cured or addressed.

11 The office of children and family services shall provide information
12 on its website in English, French, Polish, and the ten most common non-
13 English languages spoken by individuals with limited English proficiency
14 in the state, based on United States census data.

15 § 5. Subdivision 1 of section 410 of the social services law, as added
16 by chapter 395 of the laws of 1965, is amended to read as follows:

17 1. A public welfare official of a county, city or town is [~~authorized~~]
18 obligated, provided funds have been made available therefor, to provide
19 day care at public expense for children residing in his or her territory
20 [~~who are eligible therefor pursuant to provisions of this title. Such~~
21 ~~care may be provided only in cases where it is determined, under crite-~~
22 ~~ria established by the department, that there is a need therefor because~~
23 ~~of inability of the parents to provide care and supervision for a~~
24 ~~substantial part of the day and that such care is in the best interest~~
25 ~~of the child and parent. Where the family is able to pay part or all of~~
26 ~~the costs of such care, payment of such fees as may be reasonable in the~~
27 ~~light of such ability shall be required] with the aim of providing free
28 and universal child care for all families within such territory.~~

29 § 6. Subdivision 2 of section 410-b of the social services law, as
30 added by chapter 395 of the laws of 1965 and as renumbered by chapter
31 640 of the laws of 1971, is amended and a new subdivision 5 is added to
32 read as follows:

33 2. The [~~department of social welfare~~] office of children and family
34 services is hereby designated and empowered to act as the agent of the
35 state in carrying out the provisions of any such federal law with
36 respect to such day care facilities in this state. In exercising this
37 duty as agent of the state, the office of children and family services
38 shall seek to obtain any waivers or permissions from federal agencies
39 necessary and proper to allow the state and its various subdivisions to
40 implement a child care system that is universal and free at the point of
41 service, notwithstanding that the state's child care system may be more
42 expansive than what is being reimbursed with federal funds.

43 5. To the extent that federal funds are offered for child care and are
44 contingent on matching funds from the state, the state shall make all
45 reasonable efforts to maximize the allocation of federal funds by making
46 sufficient state-level appropriations.

47 § 7. Subdivisions 5, 6, 7 and 8 of section 410-x of the social
48 services law are renumbered subdivisions 6, 7, 8 and 9 and a new subdivi-
49 sion 5 is added to read as follows:

50 5. (a) For each group for which the office of children and family
51 services determines a separate payment rate pursuant to subdivision four
52 of this section, and at the same frequency, such office shall utilize a
53 cost estimation model to determine the actual cost providers incur when
54 providing high-quality child care. The cost estimation model shall iden-
55 tify and take into account cost drivers including but not limited to
56 employee salary and benefits, enrollment levels, facility costs and

1 compliance with statutory and regulatory requirements. Where a quality
2 rating system or any quality indicators are being utilized, the cost
3 estimation model shall also take into account the cost of providing
4 services at each level of quality.

5 (b) In developing such model the office of children and family
6 services shall consult with stakeholders including, but not limited to,
7 representatives of child care resource and referral agencies, child care
8 providers, labor leaders for any labor unions representing child care
9 workers in the state, and any state advisory council established pursu-
10 ant to 42 U.S.C.S. § 9831 et. seq., as amended. The cost estimation
11 model shall be statistically valid, using complete and current data and
12 rigorous collection methods. The cost estimation model shall further
13 account for biases in reported data that tend to underestimate the cost
14 of care, and shall make appropriate adjustments.

15 § 8. Section 410-z of the social services law, as added by section 52
16 of part B of chapter 436 of the laws of 1997, is amended to read as
17 follows:

18 § 410-z. Reporting requirements. 1. Each social services district
19 shall collect and submit to the [~~department~~] office of children and
20 family services, in such form and at such times as specified by the
21 [~~department~~] office of children and family services, such data and
22 information regarding child care assistance provided under the block
23 grant as the [~~department~~] office of children and family services may
24 need to comply with federal reporting requirements.

25 2. The office of children and family services shall prepare a report
26 detailing the actual cost providers incur when providing child care in
27 each setting, as determined by the cost estimation model established in
28 paragraph (a) of subdivision five of section four hundred ten-x of this
29 title. The report shall detail cost data for each setting, age group,
30 care provided to children with special needs, and any other grouping for
31 which a separate cost estimation is conducted. Such data shall include:

32 (a) the level of quality care as determined by a quality rating system
33 or any quality indicators utilized by the state;

34 (b) a description of the major cost drivers for providing care; and

35 (c) a comparison of the costs of child care for each grouping to the
36 market rate determined by the office of children and family services
37 pursuant to subdivision four of section four hundred ten-x of this
38 title.

39 The report shall be submitted to the governor, the speaker of the
40 assembly and the temporary president of the senate by June first, two
41 thousand twenty-three and June first of every other year thereafter. The
42 office of children and family services shall post the information
43 contained in the report on its website.

44 § 9. Subdivision 1 and paragraph (b) of subdivision 5 of section 410-c
45 of the social services law, subdivision 1 as added by chapter 1014 of
46 the laws of 1969, paragraph (a) of subdivision 1 as amended by chapter
47 110 of the laws of 1971, and paragraph (b) of subdivision 5 as amended
48 by chapter 277 of the laws of 1990, and such section as renumbered by
49 chapter 640 of the laws of 1971, are amended to read as follows:

50 1. (a) Expenditures made by counties, cities, and towns for day care
51 and its administration, and day care center projects, pursuant to the
52 provisions of this title, shall, if approved by the department, be
53 subject to reimbursement by the state, in accordance with the regu-
54 lations of the department, as follows: There shall be paid to each coun-
55 ty, city or town (1) the amount of federal funds, if any, properly
56 received or to be received on account of such expenditures; (2) [~~fifty~~]

1 ninety per centum of its expenditures for day care and its adminis-
2 tration and day care center projects, after first deducting therefrom
3 any federal funds received or to be received on account thereof, and any
4 expenditures defrayed by fees paid by parents or by other private
5 contributions.

6 (b) For the purpose of this title, expenditures for administration of
7 day care shall include expenditures for compensation of employees in
8 connection with the furnishing of day care, including but not limited to
9 costs incurred for pensions, federal old age and survivors insurance and
10 health insurance for such employees; training programs for personnel,
11 operation, maintenance and service costs; and such other expenditures
12 such as equipment costs, depreciation and charges and rental values as
13 may be approved by the department. It [~~shall not~~] may include expendi-
14 tures for capital costs in appropriate cases at the discretion of the
15 department, provided that capital costs are prioritized in areas that
16 are categorized as child care deserts. In the case of day care purchased
17 from a non-profit corporation constituting an eligible borrower pursuant
18 to title five-a of this article, expenditures shall include an allocable
19 proportion of all operating costs of such facility as may be approved by
20 the department including but not limited to the expenditures enumerated
21 in this paragraph [~~(b)~~] and expenditures for amortization, interest and
22 other financing costs of any mortgage loan made to such non-profit
23 corporation.

24 (b) The commissioner shall, within appropriations made available
25 therefor, select proposed school age child day care programs which shall
26 be eligible to receive an award [~~of no more than twenty five thousand~~
27 ~~dollars~~] for start up or expansion costs, including planning, rental,
28 operational and equipment costs, or minor renovations identified as
29 being necessary in order for the program to comply with applicable state
30 or local building, fire safety or licensing standards, based on plans
31 submitted to him. The commissioner shall give preference to those areas
32 of the state which are significantly underserved by existing school age
33 child day care programs and to those programs which involve parents in
34 the development and implementation of programs. The commissioner shall
35 publicize this availability of funds to be used for purposes of this
36 subdivision in awarding grants. Plans may be submitted by private not-
37 for-profit corporations, organizations or governmental subdivisions.

38 § 10. Subdivision 8 of section 410-w of the social services law, as
39 amended by section 1 of part Z of chapter 56 of the laws of 2021, is
40 amended to read as follows:

41 8. Notwithstanding any other provision of law, rule or regulations to
42 the contrary, a social services district that implements a plan amend-
43 ment to the child care portion of its child and family services plan,
44 either as part of an annual plan update, or through a separate plan
45 amendment process, where such amendment reduces eligibility for, or
46 increases the family share percentage of, families receiving child care
47 services, or that implements the process for closing child care cases as
48 set forth in the district's approved child and family services plan, due
49 to the district determining that it cannot maintain its current caseload
50 because all of the available funds are projected to be needed for open
51 cases, shall provide all families whose eligibility for child care
52 assistance or family share percentage will be impacted by such action
53 with at least thirty days prior written notice of the action. Provided,
54 however, that a family receiving assistance pursuant to this title shall
55 not be required to contribute more than what is required by federal law
56 or ten percent of their income exceeding the federal poverty level,

1 whichever is lower, and that such cost shall be covered entirely by the
2 state.

3 § 11. Subdivision 6 of section 410-x of the social services law, as
4 amended by section 2 of part Z of chapter 56 of the laws of 2021, is
5 amended to read as follows:

6 6. Pursuant to department regulations, child care assistance shall be
7 provided on a sliding fee basis based upon the family's ability to pay;
8 provided, however, that a family receiving assistance pursuant to this
9 title shall not be required to contribute more than what is required by
10 federal law or ten percent of their income exceeding the federal poverty
11 level, whichever is lower, and that such cost shall be covered entirely
12 by the state.

13 § 12. Section 410-x of the social services law is amended by adding a
14 new subdivision 9 to read as follows:

15 9. A social services district shall establish differential payment
16 rates for child care services provided by licensed, registered or
17 enrolled child care providers as required by this subdivision.

18 (a) Local social services districts shall establish a differential
19 payment rate for child care services provided by licensed or registered
20 child care providers who provide care to a child or children experienc-
21 ing homelessness. Such differential payment rate shall be twenty percent
22 higher than the actual cost of care or the applicable market-related
23 payment rate established by the office of children and family services
24 in regulations, whichever is less.

25 (b) Local social services districts shall establish a differential
26 payment rate for child care services provided by licensed, registered,
27 or enrolled child care providers who provide care to a child during
28 nontraditional hours. "Nontraditional hours" shall mean care provided in
29 the evening, night, or on the weekend. Such differential payment rate
30 shall be twenty percent higher than the actual cost of care or the
31 applicable market-related payment rate established by the office of
32 children and family services in regulations, whichever is less.

33 (c) The cost of the differential payment rates established under this
34 subdivision shall be covered by the state.

35 § 13. Subdivision 1 of section 410 of the social services law, as
36 added by chapter 395 of the laws of 1965, is amended to read as follows:

37 1. A public welfare official of a county, city or town [~~is authorized~~]
38 shall, provided funds have been made available therefor, [~~to~~] and with
39 the state making all reasonable efforts to obtain federal funding and
40 supplementing those amounts with additional state funding, provide day
41 care at public expense for children residing in his or her territory who
42 are eligible therefor pursuant to provisions of this title. Such care
43 [~~may~~] shall be provided [~~only in cases where it is determined,~~] under
44 criteria established by the [~~department, that there is a need therefor~~
45 ~~because of inability of the parents to provide care and supervision for~~
46 ~~a substantial part of the day and that such care is in the best interest~~
47 ~~of the child and parent~~] office of children and family services;
48 provided, however, that the public welfare official shall not limit
49 authorized child care services strictly based on the work, training, or
50 educational schedule of the parents or the number of hours the parents
51 spend in work, training, or educational activities, nor shall the
52 public welfare official limit authorized child care services based on
53 proof of immigration status. Where the family [~~is able to pay part or~~
54 ~~all of the costs of such care~~] income is more than one thousand percent
55 of the poverty line, payment of such fees as may be reasonable in the
56 light of such ability [~~shall~~] may be required to the extent necessary as

1 the state transitions to a system that is free and universal. To the
2 extent there are insufficient funds to immediately serve all families,
3 the state shall make all reasonable efforts to incrementally expand to
4 universal access over a period of four years, pursuant to the phase-in
5 priorities and principles recommended by the taskforce under section
6 three hundred ninety-k of this article.

7 § 14. Paragraph (b) of subdivision 3 of section 410 of the social
8 services law is REPEALED and paragraphs (c) and (d) are relettered para-
9 graphs (b) and (c).

10 § 15. Subdivisions 1 and 2 of section 410-bb of the social services
11 law, subdivision 1 as added by chapter 503 of the laws of 1988, subdivi-
12 sion 2 as amended by chapter 659 of the laws of 1988, are amended to
13 read as follows:

14 1. The legislature finds and declares that a crisis exists in the
15 availability and quality of child day care in New York state and that
16 this crisis poses a danger both to the welfare and safety of the chil-
17 dren and to the productivity of this state's workforce; that inadequate
18 salaries and in many cases nonexistent benefit packages have substan-
19 tially contributed to the existing crisis by precluding day care centers
20 from recruiting and retaining necessary teaching and supervisory staff;
21 that an extremely high turnover rate has interfered in many instances
22 with the ability of day care centers to comply with regulatory require-
23 ments and to properly serve the children in their care; and that because
24 of these extraordinary circumstances New York state must intervene and
25 provide assistance for recruitment and retention of child care workers,
26 with the goal of creating a free and universal child care system that is
27 available to all, in the same manner as the public school system, with-
28 out the burdens of means-testing. The legislature recognizes that a
29 long-term solution to this crisis will require cooperative efforts among
30 [~~the business community, local and state governments and families~~] all
31 New Yorkers.

32 2. Within amounts appropriated specifically therefor, and after
33 deducting funds as specified in subdivision three of this section, the
34 commissioner shall allocate funds to local social services districts for
35 grants to [~~eligible not-for-profit day care centers~~] child care provid-
36 ers for retention and recruitment of teaching and supervisory staff, [~~as~~
37 ~~follows:~~

38 ~~(a) a city social services district with a population in excess of one~~
39 ~~million shall be allocated a portion of such funds based on an equal~~
40 ~~weighting of:~~

41 ~~(i) its proportion of the state population of children aged five and~~
42 ~~under, and~~

43 ~~(ii) its proportion of total claims for reimbursement received by the~~
44 ~~department by May thirty-first, nineteen hundred eighty-eight for the~~
45 ~~low income, transitional and teen parent day care programs authorized by~~
46 ~~chapter fifty-three of the laws of nineteen hundred eighty-seven.~~

12 § 24. This act shall take effect immediately; provided, that the
13 amendments to section 390-k of the social services law made by section
14 three of this act shall not affect the repeal of such section and shall
15 be deemed repealed therewith; provided, however, that the amendments to
16 subdivision 8 of section 410-w of the social services law made by
17 section ten of this act and the amendments to subdivision 6 of section
18 410-x of the social services law made by section eleven of this act
19 shall not affect the expiration of such subdivisions and shall be deemed
20 to expire therewith.
