Introduced by M. of A. GOTTFRIED -- read once and referred to the Committee on Health

AN ACT in relation to directing the commissioner of health and the commissioner of the office for people with developmental disabilities to conduct a study of the delivery of services to individuals with traumatic brain injury

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Legislative intent. The legislature recognizes that a traumatic brain injury results from a sudden blow or jolt to the head and
2 can present in individuals with a wide range of mild, moderate or severe
3 symptoms. Each traumatic brain injury case is unique and complex, often
4 requiring supports and services to allow individuals to achieve the
5 highest quality of life. This legislation will direct a study on the
6 delivery of services to New Yorkers with traumatic brain injury. Specifically, the study will evaluate the availability and accessibility of
7 quality services, emerging trends, regional disparities, and the effectiveness of the administrative process for individuals with traumatic
8 brain injury who receive official approvals or denials of services.
9 Furthermore, the commissioner of health and the commissioner of the
10 office for people with developmental disabilities should make
11 suggestions to enhance New York state's response to traumatic brain
12 injuries based on the findings of this study.

13 § 2. a. The commissioner of health and the commissioner of the office
14 for people with developmental disabilities shall conduct a study on the
15 delivery of services provided to individuals diagnosed with traumatic
16 brain injury. Such services to be studied shall include, but not be
17 limited to acute and sub-acute rehabilitation, counseling and behavioral
18 services, home care services, independent living skills training, environmental modifications, housing opportunities, and any services or
19 programs specific to traumatic brain injury or that serve individuals
20 with traumatic brain injury. In conducting the study, the commissioners
21 shall consult with people with traumatic brain injury and their fami-

1 lies, organizations representing such people, and providers of health
2 care and other services to people with traumatic brain injury.

3 b. The study shall examine the availability and accessibility of
4 services for individuals diagnosed with traumatic brain injury, the cost
5 of receiving such services, and any disparities that may exist in the
6 regional availability of services.

7 c. The study shall identify emerging trends in traumatic brain injury,
8 including changes in incidences, changes in the needs of individuals
9 with traumatic brain injury, and assess the training service providers
10 receive relating to traumatic brain injury.

11 d. The study shall also examine the difference in services availabili-
12 ty and outcomes for individuals that may be enrolled in any Medicaid
13 waiver.

14 e. The study shall examine the efficiency of the administrative proc-
15 esses that provide individuals with traumatic brain injury official
16 approvals or denials of service.

17 f. The commissioner of health and the commissioner of the office for
18 people with developmental disabilities shall make recommendations to
19 improve the delivery, quality, accessibility, and cost of the full range
20 of services available to individuals with traumatic brain injury.

21 g. The commissioner of health and the commissioner of the office for
22 people with developmental disabilities shall report and publish on the
23 department of health's website, and transmit such commissioners' find-
24 ings and recommendations to the governor, the speaker of the assembly,
25 the minority leader of the assembly, the temporary president of the
26 senate and the minority leader of the senate on or before one year from
27 the date this act shall take effect.

28 § 3. This act shall take effect immediately.
