AN ACT to amend part E of chapter 55 of the laws of 2020, amending the state finance law relating to establishing the criminal justice discovery compensation fund; amending the criminal procedure law relating to monies recovered by county district attorneys before the filing of an accusatory instrument; and providing for the repeal of certain provisions upon expiration thereof, in relation to making certain provisions of the state finance law permanent (Part A); to amend the correction law, in relation to the placement of incarcerated individuals who have a gender identity that differs from their assigned sex at birth, have a diagnosis of gender dysphoria, who identify as transgender, gender nonconforming, or nonbinary, or who are intersex within state and local correctional facilities (Part B); to amend the correction law in relation to limited credit time and eligibility for furloughs and educational leave (Part C); to repeal subdivision 9 of section 201 of the correction law relating to the parole supervision fee (Part D); to amend the correction law and public health law, in relation to authorizing the department of corrections and community supervision access to certain records (Part E); to amend the executive law, in relation to requiring members of the state parole board to devote their entire time to the duties of their office (Part F); to amend the tax law, in relation to suspending the transfer of monies into the emergency services revolving loan fund from the public safety communications account (Part G); to amend the civil practice law and rules and the executive law, in relation to establishing a mandatory training certification for all domestic and gender-based victim advocates and creating the New York state gender-based violence training institute within the office for the prevention of domestic violence (Part H); to amend the executive law, in relation to awarding reimbursement for certain items of essential personal property (Part I); to amend chapter 674 of the laws of 1993, amending

and responsibilities of the New York state higher education capital matching grant board, in relation to increasing the amount of authorized matching capital grants; to amend the New York state urban development corporation act, in relation to the nonprofit infrastructure capital investment program; to amend the New York state urban development corporation act, in relation to personal income tax notes for 2022, in relation to authorizing the dormitory authority of the state of New York and the urban development corporation to enter into line of credit facilities for 2022, and in relation to state-supported debt issued during the 2022 fiscal year; to amend the state finance law, in relation to payments of bonds; to amend the state finance law, in relation to the mental health services fund; to amend the state finance law, in relation to the issuance of revenue bonds; to repeal subdivisions 4 and 5 of section 16 of part T of chapter 57 of the laws of 2007, relating to providing for the administration of certain funds and accounts related to the 2007-2008 budget; and providing for the repeal of certain provisions upon expiration thereof (Part Y); to establish the "independent ethics commission reform act of 2022"; to amend the executive law, in relation to creating the independent commission on ethics and lobbying in government, and to repeal certain provisions of such law relating thereto; and to amend the legislative law, the public officers law, and the executive law, in relation to making technical corrections thereto (Part Z); to amend the criminal procedure law and the correction law, in relation to automatic sealing of certain convictions (Part AA); and to amend the correction law, in relation to employment by a private sector entity or as part of a prison industries certification program authorized by the United States (Part BB)

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. This act enacts into law major components of legislation
2 necessary to implement the state public protection and general govern-
3 ment budget for the 2022-2023 state fiscal year. Each component is whol-
4 ly contained within a Part identified as Parts A through BB. The effec-
5 tive date for each particular provision contained within such Part is
6 set forth in the last section of such Part. Any provision in any section
7 contained within a Part, including the effective date of the Part, which
8 makes a reference to a section "of this act", when used in connection
9 with that particular component, shall be deemed to mean and refer to the
10 corresponding section of the Part in which it is found. Section three of
11 this act sets forth the general effective date of this act.

12 PART A

13 Section 1. Section 3 of part E of chapter 55 of the laws of 2020,
14 amending the state finance law relating to establishing the criminal
15 justice discovery compensation fund; amending the criminal procedure law
16 relating to monies recovered by county district attorneys before the
17 filing of an accusatory instrument; and providing for the repeal of
18 certain provisions upon expiration thereof, is amended to read as
19 follows:

20 § 3. This act shall take effect immediately; provided, however, [~~that~~
21 ~~subdivision 2 of section 99-hh of the state finance law, as added by~~

~~section one of this act, shall expire and be deemed repealed March 31, 2022, and provided, further~~] that the amendments to section 95.00 of the criminal procedure law made by section two of this act shall not affect the repeal of such section and shall be deemed repealed therewith.

§ 2. This act shall take effect immediately and shall be deemed to have been in full force and effect on and after March 31, 2022.

PART B

Section 1. Subdivision 1 of section 71 of the correction law is amended by adding a new paragraph (c) to read as follows:

(c) Notwithstanding the foregoing, incarcerated individuals who have a gender identity that differs from their assigned sex at birth, have a diagnosis of gender dysphoria, who identify as transgender, gender nonconforming, or nonbinary, or who are intersex may be received at a correctional facility designated for males or females. The department shall establish a mechanism by which incarcerated individuals who have a gender identity that differs from their assigned sex at birth, have a diagnosis of gender dysphoria, who identify as transgender, gender nonconforming, or nonbinary, or who are intersex may request placement in a facility designated for males or females prior to reception.

§ 2. The correction law is amended by adding a new section 135 to read as follows:

§ 135. Placement based on gender identity. Incarcerated individuals who have a gender identity that differs from their assigned sex at birth, have a diagnosis of gender dysphoria, who identify as transgender, gender nonconforming, or nonbinary, or who are intersex may request to be placed in a correctional facility with persons of the gender that is consistent with such person's gender identity.

(a) Decisions regarding the placement of incarcerated individuals who have a gender identity that differs from their assigned sex at birth, have a diagnosis of gender dysphoria, who identify as transgender, gender nonconforming, or nonbinary, or who are intersex in a facility designated for the confinement of males or females shall be made on a case-by-case basis, with careful consideration given to housing consistent with the individual's gender identity, following an individualized and informed assessment but subject to denial based on safety, security or health concerns. The department shall provide a determination in writing to the affected person.

(b) If an incarcerated individual raises concerns for their health or safety at any time, or if their placement raises safety, security or health concerns at any time, their housing and placement shall be reassessed.

(c) Any incarcerated individual who has been placed in a facility consistent with the individual's gender identity, may request at any time to be transferred to a facility housing individuals of their assigned sex at birth.

(i) If granted, such request shall be effectuated as soon as practicable.

(ii) Any incarcerated individual who has a gender identity that differs from their assigned sex at birth, has a diagnosis of gender dysphoria, who identifies as transgender, gender nonconforming, or nonbinary, or who is intersex who has declined to be housed in a facility consistent with the individual's gender identity, or who has requested to leave such a placement, may request to have their placement

1 reassessed in accordance with procedures established by the commission-
2 er.

3 § 3. Section 137 of the correction law is amended by adding a new
4 subdivision 7 to read as follows:

5 7. The commissioner shall promulgate rules and regulations to ensure
6 the appropriate treatment of incarcerated individuals who have a gender
7 identity that differs from their assigned sex at birth, have a diagnosis
8 of gender dysphoria, who identify as transgender, gender nonconform-
9 ing, or nonbinary, or who are intersex such that:

10 (a) incarcerated individuals who have a gender identity that differs
11 from their assigned sex at birth, have a diagnosis of gender dysphoria,
12 who identify as transgender, gender nonconforming, or nonbinary, or
13 who are intersex shall:

14 (i) have access to department-issued undergarments and clothing that
15 are consistent with the individuals' gender identity, and shall have the
16 ability to receive undergarments, clothing and personal care items
17 through package procedures, subject to gender-neutral restrictions; and

18 (ii) have the right to gender affirming medical and mental health care
19 consistent with the community standard of care.

20 (iii) The absence of a documented history of gender variance shall not
21 preclude an incarcerated individual from self-identification as trans-
22 gender, gender nonconforming, or nonbinary.

23 (b) No employee of the department shall misgender any individual in
24 the care or custody of the department by intentionally referring to
25 someone, including but not limited to, a transgender, gender nonconform-
26 ing, nonbinary or intersex person, using a word, pronoun or form of
27 address that does not correctly reflect the gender with which they iden-
28 tify.

29 (c) Employees of the department shall only use information pertaining
30 to an incarcerated individual's gender identity and expression as neces-
31 sary for the performance of their official duties and shall not reveal
32 any information related to an incarcerated individual's gender identity
33 and expression other than to the extent necessary for legitimate opera-
34 tional functions of the facility or the department.

35 (d) No incarcerated individual may be denied access to programming or
36 education based on their gender identity or expression.

37 (e) The commissioner shall implement procedures for incarcerated indi-
38 viduals who have a gender identity that differs from their assigned sex
39 at birth, have a diagnosis of gender dysphoria, who identify as trans-
40 gender, gender nonconforming, or nonbinary, or who are intersex to
41 designate their gender preference for personal searches.

42 (f) The department shall provide training on the provisions of this
43 subdivision to all personnel every two years.

44 (g) The department shall make available documentation summarizing the
45 provisions of this subdivision to incarcerated individuals who have a
46 gender identity that differs from their assigned sex at birth, have a
47 diagnosis of gender dysphoria, who identify as transgender, gender
48 nonconforming, or nonbinary, or who are intersex, and shall widely
49 distribute such documentation such that it is readily accessible.

50 § 4. Section 500-b of the correction law is amended by adding a new
51 subdivision 14 to read as follows:

52 14. Notwithstanding any other provision, incarcerated individuals who
53 have a gender identity that differs from their assigned sex at birth,
54 have a diagnosis of gender dysphoria, who identify as transgender,
55 gender nonconforming, or nonbinary, or who are intersex may request to

1 be placed in a housing unit designated for individuals of the gender
2 that most closely aligns with such individuals' gender identity.

3 (a) Decisions regarding the placement of incarcerated individuals who
4 have a gender identity that differs from their assigned sex at birth,
5 have a diagnosis of gender dysphoria, who identify as transgender,
6 gender nonconforming, or nonbinary, or who are intersex shall be made on
7 a case-by-case basis, with careful consideration given to housing most
8 closely aligning with the individuals' gender identity, following an
9 individualized and informed assessment but subject to denial based on
10 safety, security or health concerns. The chief administrative officer
11 or their designee shall provide a determination in writing to the
12 affected person.

13 (b) If an incarcerated individual placed in a housing unit consistent
14 with the individual's gender identity or expression raises concerns for
15 their health or safety at any time, or if their placement raises safety,
16 security or health concerns at any time, their housing and placement
17 shall be reassessed.

18 (c) An incarcerated individual who has been placed in a housing unit
19 consistent with the individual's gender identity may request at any time
20 to be transferred to a housing unit housing individuals of their
21 assigned sex at birth.

22 (i) Such request shall be reviewed as soon as practicable.

23 (ii) An individual who has declined to be housed in a housing unit
24 consistent with the individual's gender identity, or who has requested
25 to leave such a placement, may request to have their placement reas-
26 sessed in accordance with procedures established by the chief adminis-
27 trative officer or their designee.

28 § 5. Subdivision 1 of section 500-k of the correction law, as sepa-
29 rately amended by chapters 93 and 322 of the laws of 2021, is amended to
30 read as follows:

31 1. Subdivisions five [~~and~~], six and seven of section one hundred thir-
32 ty-seven of this chapter, except paragraphs (d) and (e) of subdivision
33 six of such section, relating to the treatment of incarcerated individ-
34 uals in state correctional facilities are applicable to incarcerated
35 individuals confined in county jails; except that the report required by
36 paragraph (f) of subdivision six of such section shall be made to a
37 person designated to receive such report in the rules and regulations of
38 the state commission of correction, or in any county or city where there
39 is a department of correction, to the head of such department; and the
40 state commission of correction shall promulgate rules and regulations
41 which prescribe the manner in which subdivision seven of section one
42 hundred thirty-seven of this chapter shall apply to the treatment of
43 incarcerated individuals who have a gender identity that differs from
44 their assigned sex at birth, have a diagnosis of gender dysphoria, who
45 identify as transgender, gender nonconforming, or nonbinary, or who
46 are intersex confined in local correctional facilities.

47 § 6. Subdivision (a) of section 601 of the correction law, as amended
48 by section 209 of chapter 322 of the laws of 2021, is amended to read as
49 follows:

50 (a) Whenever an incarcerated individual shall be delivered to the
51 superintendent of a state correctional facility pursuant to an indeter-
52 minate or determinate sentence, the officer so delivering such incarcer-
53 ated individual shall deliver to such superintendent, the sentence and
54 commitment or certificate of conviction, or a certified copy thereof,
55 and a copy of any order of protection pursuant to section 380.65 of the
56 criminal procedure law received by such officer from the clerk of the

1 court by which such incarcerated individual shall have been sentenced, a
2 copy of the report of the probation officer's investigation and report
3 or a detailed statement covering the facts relative to the crime and
4 previous history certified by the district attorney, a copy of the
5 incarcerated individual's fingerprint records, a detailed summary of
6 available medical records, psychiatric records and reports relating to
7 assaults, or other violent acts, attempts at suicide or escape by the
8 incarcerated individual while in the custody of the local correctional
9 facility, a copy of records reflecting the individual's gender identity
10 and gender-related housing requests; any such medical or psychiatric
11 records in the possession of a health care provider other than the local
12 correctional facility shall be summarized in detail and forwarded by
13 such health care provider to the medical director of the appropriate
14 state correctional facility upon request; the superintendent shall pres-
15 ent to such officer a certificate of the delivery of such incarcerated
16 individual, and the fees of such officer for transporting such incarcer-
17 ated individual shall be paid from the treasury upon the audit and
18 warrant of the comptroller. Whenever an incarcerated individual of the
19 state is delivered to a local facility, the superintendent shall forward
20 summaries of such records to the local facility with the incarcerated
21 individual.

22 § 7. Subdivision (a) of section 601 of the correction law, as amended
23 by section 209-a of chapter 322 of the laws of 2021, is amended to read
24 as follows:

25 (a) Whenever an incarcerated individual shall be delivered to the
26 superintendent of a state correctional facility pursuant to an indeter-
27 minate or determinate sentence, the officer so delivering such incarcer-
28 ated individual shall deliver to such superintendent, the sentence and
29 commitment or certificate of conviction, or a certified copy thereof,
30 and a copy of any order of protection pursuant to section 380.65 of the
31 criminal procedure law received by such officer from the clerk of the
32 court by which such incarcerated individual shall have been sentenced, a
33 copy of the report of the probation officer's investigation and report
34 or a detailed statement covering the facts relative to the crime and
35 previous history certified by the district attorney, a copy of the
36 incarcerated individual's fingerprint records, a detailed summary of
37 available medical records, psychiatric records and reports relating to
38 assaults, or other violent acts, attempts at suicide or escape by the
39 incarcerated individual while in the custody of the local correctional
40 facility, a copy of records reflecting the individual's gender identity
41 and gender-related housing requests; any such medical or psychiatric
42 records in the possession of a health care provider other than the local
43 correctional facility shall be summarized in detail and forwarded by

49 warrant of the comptroller. Whenever an incarcerated individual of the
50 state is delivered to a local facility, the superintendent shall forward
51 summaries of such records to the local facility with the incarcerated
52 individual.

53 § 8. This act shall take effect immediately; provided, however, that
54 section five of this act shall take effect on the same date and in the
55 same manner as section 13 of chapter 93 of the laws of 2021, takes
56 effect; provided, further, that the amendments to section 500-b of the

1 correction law made by section four of this act shall not affect the
2 repeal of such section and shall be deemed repealed therewith; and
3 provided, further, that the amendments to subdivision (a) of section 601
4 of the correction law made by section six of this act shall be subject
5 to the expiration and reversion of such subdivision pursuant to subdivi-
6 sion d of section 74 of chapter 3 of the laws of 1995, as amended when
7 upon such date the provisions of section seven of this act shall take
8 effect.

PART C

10 Section 1. Subparagraph i of paragraph (c) of subdivision 1 of
11 section 803-b of the correction law, as amended by chapter 322 of the
12 laws of 2021, is amended to read as follows,

13 (i) participates in no less than two years of college programming or
14 participates in one year of college programming while confined in a
15 general confinement facility and thereafter participates in six months
16 of college programming while a participant in educational release; or

17 § 2. Subdivisions 4 and 7 of section 851 of the correction law, as
18 amended by chapter 322 of the laws of 2021, is amended to read as
19 follows:

20 4. "Furlough program" means a program under which eligible incarcerat-
21 ed individuals may be granted the privilege of leaving the premises of
22 an institution for a period not exceeding seven days for the purpose of
23 seeking employment, maintaining family ties, solving family problems,
24 seeking post-release housing, attending a short-term educational or
25 vocational training course, or for any matter necessary to the further-
26 ance of any such purposes. Notwithstanding the provisions of subdivi-
27 sion two of this section, an eligible incarcerated individual for the
28 furlough program shall also include an incarcerated individual who is
29 not serving a sentence for an offense that would render such person
30 ineligible for the limited credit time allowance, as set forth in
31 section eight hundred three-b of this chapter, and provided further that
32 such incarcerated individual has successfully participated in college
33 programming while incarcerated with the department in a general confine-
34 ment facility for a period of at least one year, and is presently
35 successfully participating in college programming through educational
36 leave as provided for in subdivision seven of this section.

37 7. "Educational leave" means a privilege granted to an eligible incar-
38 cerated individual to leave the premises of an institution for a period
39 not exceeding fourteen hours in any day for the purpose of education or
40 vocational training, or for any matter necessary to the furtherance of
41 any such purposes. Notwithstanding the provisions of subdivision two of
42 this section, an eligible incarcerated individual for educational leave
43 shall also include an incarcerated individual who is not serving a
44 sentence for an offense that would render such person ineligible for the
45 limited credit time allowance, as set forth in section eight hundred
46 three-b of this chapter, and provided further that such incarcerated
47 individual has successfully participated in college programming while
48 incarcerated with the department in a general confinement facility for a
49 period of at least one year.

50 § 3. This act shall take effect on April 1, 2022; provided, however,
51 that the amendments to subdivisions 4 and 7 of section 851 of the
52 correction law made by section two of this act shall not affect the
53 expiration of such section and shall be deemed expired therewith.

2 Section 1. Subdivision 9 of section 201 of the correction law is
3 REPEALED.

4 § 2. This act shall take effect immediately.

PART E

6 Section 1. Subdivision (a) of section 601 of the correction law, as
7 amended by section 209 of chapter 322 of the laws of 2021, is amended to
8 read as follows:

9 (a) Whenever an incarcerated individual shall be delivered to the
10 superintendent of a state correctional facility pursuant to an indeter-
11 minate or determinate sentence, the officer so delivering such incarcer-
12 ated individual shall deliver to such superintendent, the sentence and
13 commitment or certificate of conviction, or a certified copy thereof,
14 and a copy of any order of protection pursuant to section 380.65 of the
15 criminal procedure law received by such officer from the clerk of the
16 court by which such incarcerated individual shall have been sentenced, a
17 copy of the report of the probation officer's investigation and report
18 or a detailed statement covering the facts relative to the crime and
19 previous history certified by the district attorney, a copy of the
20 incarcerated individual's fingerprint records, a detailed summary of
21 available medical records, psychiatric records and reports relating to
22 assaults, or other violent acts, attempts at suicide or escape by the
23 incarcerated individual while in the custody of the local correctional
24 facility; any such medical or psychiatric records in the possession of a
25 health care provider other than the local correctional facility shall be
26 summarized in detail and forwarded by such health care provider to the
27 medical director of the appropriate state correctional facility upon
28 request; the superintendent shall present to such officer a certificate
29 of the delivery of such incarcerated individual, and the fees of such
30 officer for transporting such incarcerated individual shall be paid from
31 the treasury upon the audit and warrant of the comptroller. The
32 sentence and commitment or certificate of conviction shall be deemed to
33 grant authorization to the department of corrections and community
34 supervision to request a certified copy or certified transcript of birth
35 on behalf of an incarcerated individual, when such request is made
36 pursuant to subdivision four of section four thousand one hundred seven-
37 ty-four of the public health law or section four thousand one hundred
38 seventy-nine of such law. Whenever an incarcerated individual of the
39 state is delivered to a local facility, the superintendent shall forward
40 summaries of such records to the local facility with the incarcerated
41 individual.

42 § 2. Subdivision 4 of section 4174 of the public health law, as
43 amended by chapter 322 of the laws of 2021, is amended to read as
44 follows:

45 4. No fee shall be charged for a search, certification, certificate,
46 certified copy or certified transcript of a record to be used for school
47 entrance, employment certificate or for purposes of public relief or
48 when required by the veterans administration to be used in determining
49 the eligibility of any person to participate in the benefits made avail-
50 able by the veterans administration or when required by a board of
51 elections for the purposes of determining voter eligibility or when
52 requested by the department of corrections and community supervision or
53 a local correctional facility as defined in subdivision sixteen of

1 section two of the correction law for the purpose of providing a certi-
2 fied copy or certified transcript of birth to an incarcerated individual
3 in anticipation of such incarcerated individual's release from custody
4 or to obtain a death certificate to be used for administrative purposes
5 for an incarcerated individual who has died under custody or when
6 requested by the office of children and family services or an authorized
7 agency for the purpose of providing a certified copy or certified tran-
8 script of birth to a youth placed in the care and custody or custody and
9 guardianship of the local commissioner of social services or the care
10 and custody or custody and guardianship of the office of children and

48 (i) "Line of credit facility" shall mean one or more revolving credit

51 financial institution or a consortium of financial institutions for the
52 purpose of assisting the state to temporarily finance its budgetary

54 (ii) "Related expenses and fees" shall mean interest costs, commitment
55 fees and other costs, expenses and fees incurred in connection with a
56 line of credit facility and/or a service contract or other agreement of

1 the state securing such line of credit facility that contractually obli-
2 gates the state to pay debt service subject to an appropriation.

3 (c) Notwithstanding any other provision of law to the contrary,

5 2000 and section 67-b of the state finance law, the dormitory authority
6 of the state of New York and the urban development corporation are
7 authorized until March 31, 2023 to: (i) enter into one or more line of
8 credit facilities not in excess of two billion dollars in aggregate
9 principal amount; (ii) draw, at one or more times at the direction of
10 the director of the budget, upon such line of credit facilities and
11 provide to the state the amounts so drawn for the purpose of assisting
12 the state to temporarily finance its budgetary needs; provided, however,
13 that the total principal amounts of such draws for each fiscal year
14 shall not exceed two billion dollars; and (iii) secure repayment of all
15 draws under such line of credit facilities and the payment of related
16 expenses and fees, which repayment and payment obligations shall not
17 constitute a debt of the state within the meaning of any constitutional
18 or statutory provision and shall be deemed executory only to the extent
19 moneys are available and that no liability shall be incurred by the
20 state beyond the moneys available for such purpose, and that such
21 payment obligation is subject to annual appropriation by the legisla-
22 ture. Any line of credit facility agreements entered into by the dormi-
23 tory authority of the state of New York and/or the urban development
24 corporation with financial institutions pursuant to this section may
25 contain such provisions that the dormitory authority of the state of New
26 York and/or the urban development corporation deem necessary or desira-
27 ble for the establishment of such credit facilities. The maximum term of
28 any line of credit facility shall be one year from the date of incur-
29 rence; provided however that no draw on any such line of credit facility
30 shall occur after March 31, 2023, and provided further that any such
31 line of credit facility whose term extends beyond March 31, 2023 shall
32 be supported by sufficient appropriation authority enacted by the legis-

39 ry, the comptroller is hereby authorized and directed to deposit to the
40 credit of the general fund, all amounts provided by the dormitory
41 authority of the state of New York and/or the urban development corpo-
42 ration to the state from draws made on any line of credit facility
43 authorized by paragraph (c) of this subdivision.

44 (e) Notwithstanding any other provision of law to the contrary, for so
45 long as any amounts under a line of credit facility authorized by para-
46 graph (c) of this subdivision are due and payable, such amounts shall
47 not constitute nor be treated as state-supported debt for purposes of
48 article 5-B of the state finance law. As applicable, all of the
49 provisions of the state finance law, the dormitory authority act and the
50 New York state urban development corporation act relating to notes and
51 bonds which are not inconsistent with the provisions of this section
52 shall apply to any line of credit facility established in accordance

38 (h) Any service contract or other agreement entered into pursuant to
39 paragraph (g) of this subdivision or any payments made or to be made
40 thereunder may be assigned and pledged by the dormitory authority of the
41 state of New York and/or the urban development corporation as security
42 for any related payment obligation it may have with one or more finan-
43 cial institutions in connection with a line of credit facility author-
44 ized by paragraph (c) of this subdivision.

45 (i) In addition to the foregoing, the director of the budget, the

47 corporation shall each be authorized to enter into such other agreements

21 ger rail transportation project commonly known as the gateway project,
22 is needed to preserve and improve the functionality and strengthen the
23 resiliency of long-distance and commuter rail infrastructure between the
24 state of New York and the state of New Jersey.

25 2. Definitions. When used in this section:

26 "Commission" shall mean the gateway development commission, a bi-state
27 commission and a body corporate and politic established by the state of
28 New Jersey and the state of New York, acting in the public interest and
29 exercising essential governmental functions in accordance with the Gate-
30 way development commission act, and any successor thereto.

31 "Federal transportation loan" shall mean one or more loans made to the
32 commission to finance the Hudson tunnel project under or pursuant to any
33 U.S. Department of Transportation program or act, including but not
34 limited to the Railroad Rehabilitation & Improvement Financing Program
35 or the Transportation Infrastructure Finance and Innovation Act, which
36 loan or loans are related to the state capital commitment.

37 "Gateway development commission act" shall mean chapter 108 of the
38 laws of New York, 2019, as amended.

39 "Gateway project" shall mean the passenger rail and related infras-
40 tructure projects undertaken by the commission, including the hudson
41 tunnel project.

42 "Hudson tunnel project" shall mean the project consisting of
43 construction of a tunnel connecting the states of New York and New
44 Jersey and the completion of certain ancillary facilities including
45 construction of concrete casing at Hudson Yards in Manhattan, New York
46 and the rehabilitation of the existing North River Tunnels.

47 "State capital commitment" shall mean an aggregate principal amount
48 not to exceed \$2,350,000,000, plus any interest costs, including capi-
49 talized interest, and related expenses and fees payable by the state of
50 New York to the commission under one or more service contracts or other
51 agreements pursuant to this section, as well as any expenses of the
52 state incurred in connection therewith.

53 "Related expenses and fees" shall mean commitment fees and other
54 ancillary costs, expenses and fees incurred, and to become due and paya-
55 ble, by the commission in connection with the Federal transportation
56 loan.

1 3. Notwithstanding any other provision of law to the contrary, in
2 order to provide for the payment for the state capital commitment, the
3 director of the budget is hereby authorized to enter into one or more
4 service contracts or other agreements with the commission, none of which
5 shall exceed the maximum duration of the Federal transportation loan,
6 upon such terms and conditions as the director of the budget and commis-
7 sion agree, so as to provide to the commission, for each state fiscal
8 year, a sum not to exceed the amount required for the payment of the
9 state capital commitment for such fiscal year. Any such service contract
10 or other agreement shall provide that the obligation of the state to pay
11 the amount therein provided shall not constitute a debt of the state
12 within the meaning of any constitutional or statutory provision and
13 shall be deemed executory only to the extent of monies available, that
14 no liability shall be incurred by the state beyond the monies available
15 for such purpose, and that such obligation is subject to annual appro-
16 priation by the legislature. Any such service contract or other agree-
17 ment and any payments made or to be made thereunder may be assigned and
18 pledged by the commission as security for the repayment by the commis-
19 sion of the Federal transportation loan.

20 4. The director of the budget is also authorized to enter into such
21 other agreements and to take or cause to be taken such additional
22 actions as are necessary or desirable to effectuate the purposes of the
23 transactions contemplated by the state capital commitment provided for
24 herein and the service contract or other agreement authorized by subdi-
25 vision 3 of this section.

26 § 57. Subdivisions 4 and 5 of section 16 of part T of chapter 57 of
27 the laws of 2007, relating to providing for the administration of
28 certain funds and accounts related to the 2007-2008 budget, are
29 REPEALED.

30 § 58. This act shall take effect immediately and shall be deemed to
31 have been in full force and effect on and after April 1, 2022; provided,
32 however, that the provisions of sections one, one-a, two, three, four,
33 five, six, seven, eight, thirteen, fourteen, fifteen, sixteen, seven-
34 teen, eighteen, nineteen, twenty, twenty-two, and twenty-three of this
35 act shall expire March 31, 2023 when upon such date the provisions of
36 such sections shall be deemed repealed; provided, further, that the
37 amendments to section 89-h of the state finance law made by section
38 twenty-eight of this act shall not affect the repeal of such section and
39 shall be deemed repealed therewith.

40 PART Z

41 Section 1. This act shall be known and may be cited as the "independ-
42 ent ethics commission reform act of 2022".

43 § 2. Section 94 of the executive law is REPEALED and a new section 94
44 is added to read as follows:

45 § 94. Independent commission on ethics and lobbying in government. 1.
46 Commission established. There is hereby established within the depart-
47 ment of state, the "independent commission on ethics and lobbying in
48 government", an independent agency responsible for administering,
49 enforcing, and interpreting New York state's ethics and lobbying laws.
50 The commission shall have and exercise the powers and duties set forth
51 in this section with respect to statewide elected officials, members of
52 the legislature and employees of the legislature, and state officers and
53 employees as defined in section seventy-three of the public officers
54 law, candidates for statewide elected office and for the senate or

1 assembly, and the political party chairman as is defined in section
2 seventy-three-a of the public officers law, lobbyists and the clients of
3 lobbyists as defined in section one-c of the legislative law, and indi-
4 viduals who have formerly held such positions, were lobbyists or clients
5 of lobbyists as defined in section one-c of the legislative law, or who
6 have formerly been such candidates. This section shall not be deemed to
7 have revoked or rescinded any regulations or advisory opinions in effect
8 on the effective date of this section that were issued by predecessor
9 ethics and lobbying bodies. The commission shall cooperate, consult, and
10 coordinate with the legislative ethics commission, to the extent possi-
11 ble, to administer and enforce the laws under its jurisdiction.

12 2. Definitions. For the purposes of this section, the following terms
13 shall have the following meanings:

14 (a) "commission" means the independent commission on ethics and
15 lobbying in government established pursuant to subdivision one of this
16 section.

17 (b) "selection committee" means the committee of the American Bar
18 Association accredited New York state-law school deans or interim deans
19 tasked with selecting the members of the commission pursuant to subdivi-
20 sion three of this section.

21 (c) "respondent" means the individual or individuals or organization
22 or organizations subject to an inquiry, investigation, or enforcement
23 action.

24 3. Selection committee. (a) The selection committee shall select five
25 commission members.

26 (b) The selection committee shall publish a procedure by which it will
27 solicit and receive applications from members of the public, review
28 qualifications, and select commission membership and reappointment in
29 accordance with this section. The chair of the selection committee
30 shall rotate annually among the deans in alphabetical order by the names
31 of their respective law schools. Appropriate staffing and other
32 resources shall be provided for in the commission's budget for the
33 selection committee to carry out its powers, functions, and duties.

34 (c) The majority of the selection committee shall constitute a quorum
35 to hold a meeting.

36 (d) Notwithstanding the provisions of article seven of the public
37 officers law, no meeting or proceeding of the selection committee shall
38 be open to the public, except the applicable records pertaining to the
39 selection process for a member's seat shall be subject to disclosure
40 pursuant to article six of the public officers law only after an indi-
41 vidual member is appointed to the commission. Requests for such records
42 shall be made to, and processed by, the commission's records access
43 officer.

44 (e) In the selection of the commission members, the selection commit-
45 tee shall take all appropriate steps to recruit and prioritize the
46 selection of members who will bring diversity of lived experience,
47 diversity of geographic location, and professional expertise and skill-
48 sets, such as, but not limited to, ethics, familiarity with the lobbying
49 industry, public administration, compliance, or education, to reflect
50 the mission of the commission.

51 (f) No individual shall be eligible for appointment as a member of the
52 commission who is currently, or has within the last two years:

53 (i) been registered as a lobbyist in New York state;

54 (ii) been a member of the New York state legislature, a statewide
55 elected official, or a commissioner of an executive agency appointed
56 by the governor;

1 (iii) been a political party chairman, as defined in section seven-
2 ty-three of the public officers law; or

3 (iv) been a state officer or employee or legislative employee as
4 defined in section seventy-three of the public officers law.

5 4. Commission. (a) The first class of members of the commission shall
6 serve staggered terms to ensure continuity. For the first class of the
7 commission, two members shall serve a term of four years, two members
8 shall serve a term of two years, and one member shall serve a term of
9 one year. All subsequent members shall serve a term of four years. No
10 member shall be selected to the commission for more than two full
11 consecutive terms, except, that a member who has held the position by
12 filling a vacancy, can be selected to the commission for an additional
13 two full consecutive terms.

14 (b) The commission by majority vote shall elect a chairperson from
15 among its members for a term of two years. A chairperson may be elected
16 to more than one term for such office.

17 (c) Members of the commission may be removed by majority vote of the
18 commission solely for substantial neglect of duty, misconduct in office,
19 violation of the confidentiality restrictions set forth in this
20 section, inability to discharge the powers or duties of office or
21 violation of this section, after written notice and opportunity for a
22 reply.

23 (d) Any vacancy occurring on the commission shall be filled within
24 thirty days of its occurrence in the same manner as a member is initial-
25 ly selected to complete the vacant term.

26 (e) During the period of a member's service as a member of the commis-
27 sion, the member shall refrain from making, or soliciting from other
28 persons, any contributions to candidates for election to the offices of
29 governor, lieutenant governor, member of the assembly or the senate,
30 attorney general or state comptroller.

31 (f) Members of the commission shall receive a per diem allowance equal
32 to the salary of a justice of the supreme court divided by two hundred
33 twenty for each day or each pro-rated day actually spent in the perform-
34 ance of the member's duties under this section, and, in addition there-
35 to, shall be reimbursed for all reasonable expenses actually and neces-
36 sarily incurred by the member in the performance of the member's duties
37 under this section. For the purposes of this subdivision, a day shall
38 consist of at least seven and one-half hours spent in the performance of
39 the member's duties under this section.

40 (g) A meeting may be called by the chairperson or three members of the
41 commission. The commission shall be subject to articles six and seven
42 of the public officers law.

43 (h) Three members of the commission shall constitute a quorum, and the
44 commission shall have the power to act by majority vote of the total
45 number of members of the commission without vacancy.

46 (i) The commission shall meet at least once per month for at least ten
47 months in a calendar year. The commission shall hold a public hearing
48 at least once each calendar year to take testimony regarding the
49 operation of the commission and solicit public input regarding potential
50 or proposed changes in the laws under its jurisdiction.

51 5. Powers. (a) The commission has the authority to: (i) adopt, amend,
52 and rescind any rules and regulations pertaining to section seventy-
53 three, seventy-three-a or seventy-four of the public officers law,
54 article one-A of the legislative law, or section one hundred seven of
55 the civil service law; (ii) adopt, amend, and rescind any procedures of
56 the commission, including but not limited to, procedures for advice and

1 guidance, training, filing, review, and enforcement of financial disclo-
2 sure statements, investigations, enforcement, and due process hearings;
3 and (iii) develop and promulgate any programs for reviews, training, and
4 guidance to carry out the commission's mission.

5 (b) The commission has the authority to compel the testimony of
6 witnesses, and may administer oaths or affirmations, subpoena witnesses,
7 compel their attendance and require the production of any books or
8 records which it may deem relevant or material.

9 6. Executive director and commission staff. The commission shall:

10 (a) (i) Appoint an executive director who shall act in accordance with
11 the policies of the commission. The executive director shall be
12 appointed without regard to political affiliation and solely on the
13 basis of fitness to perform the duties assigned by this section, and
14 shall be a qualified, independent professional. No individual shall be
15 eligible to be appointed as an executive director if the individual is
16 currently, or within the last two years has been:

17 (1) registered as a lobbyist in New York state;

18 (2) a member of the New York state legislature or a statewide elected
19 official or a commissioner of an executive agency appointed by the
20 governor; or

21 (3) a political party chairman, as defined in section seventy-three of
22 the public officers law.

23 (ii) Notwithstanding the provisions of this subdivision, the executive
24 director may be a current or former New York state government employee.
25 The executive director shall, prior to the individual's appointment,
26 have had at least ten years of experience in the management of auditing,
27 investigation, and enforcement of governmental operations, or management
28 of complex compliance programs relating to ethics and lobbying.

29 (iii) The appointment and removal of the executive director shall be
30 made solely by a majority vote of the commission.

31 (iv) The term of office of the executive director shall be four years
32 from the date of appointment. The salary of the executive director shall
33 be determined by the members of the commission based on experience.

34 (v) The commission may remove the executive director for neglect of
35 duty, misconduct in office, violation of the confidentiality
36 restrictions in this section, or inability or failure to discharge the
37 powers or duties of office, including the failure to follow the lawful
38 instructions of the commission.

39 (b) Delegate authority to the executive director to act in the name of
40 the commission between meetings of the commission provided such deleg-
41 ation is in writing, the specific powers to be delegated are enumerated,
42 and the commission shall not delegate any decisions specified in this
43 section that require a vote of the commission.

44 (c) Establish units within the commission to carry out its duties,
45 including, but not limited to, (i) an advice and guidance unit, (ii) a
46 training unit, (iii) a financial disclosure unit, (iv) a lobbying unit,
47 and (v) an investigations and enforcement unit.

48 (d) Appoint such other staff as are necessary to carry out its duties
49 under this section, including, but not limited to, a deputy director of
50 an advice and guidance unit to provide timely confidential advice to
51 persons subject to the commission's jurisdiction, a deputy director for
52 training, a deputy director for investigations and enforcement, and a
53 deputy director for lobbying.

54 (e) Review and approve a staffing plan provided and prepared by the
55 executive director which shall contain, at a minimum, a list of the
56 various units and divisions as well as the number of positions in each

1 unit, titles and their duties, and salaries, as well as the various
2 qualifications for each position including, but not limited to, educa-
3 tion and prior experience for each position.

4 7. Advice and guidance. (a) The commission shall establish a unit or
5 units solely for ethics and lobbying guidance, and give such prompt,
6 informal advice to persons whose conduct it oversees.

7 (b) Persons receiving such informal advice may rely on that advice
8 absent misrepresentation or omission of material facts to the commission
9 and such communications with the commission shall be treated as confi-
10 dential, except as disclosure is needed to prevent or rectify a
11 crime or fraud, or prevent a substantial threat to public health or
12 safety or if required by court order.

13 (c) The commission may also render, on written request or on its own
14 initiative, advisory opinions, and may allow for public comment before
15 issuance of an advisory opinion. Such an opinion rendered by the
16 commission shall be relied on by those subject to the commission's
17 jurisdiction and until, or unless, amended, superseded, or revoked.
18 Such opinion may also be relied upon by any such person, and may be
19 introduced and shall be a defense, in any criminal or civil action.

20 8. Training. (a) The commission shall establish a training unit and
21 shall develop and administer an on-going program for the education and
22 training in ethics and lobbying for those subject to the provisions of
23 this section, as follows:

24 (i) The commission shall develop and administer a comprehensive live
25 or live-online ethics training course and shall designate and train
26 instructors to conduct such training. Such live course shall be designed
27 to include practical application of the material covered and a ques-
28 tion-and-answer participatory segment. Unless the commission grants an
29 extension or waiver for good cause shown, statewide elected officials,
30 members of the legislature and employees of the legislature, and state
31 officers and employees as defined in sections seventy-three and seven-
32 ty-three-a of the public officers law, and the political party chairman
33 as is defined in section seventy-three-a of the public officers law,
34 shall complete the live course within ninety days of appointment or
35 employment and shall complete the live course every two years subse-
36 quently.

37 (ii) The commission shall develop and administer an online ethics
38 refresher course for all individuals listed under subparagraph (i) of
39 this paragraph who have previously completed the live course. Such
40 refresher course shall be designed to include any changes in law, regu-
41 lation, or policy or in the interpretation thereof, and practical appli-
42 cation of the material covered. Unless the commission grants an exten-
43 sion or waiver for good cause shown, such individuals shall take such
44 refresher course once every year after having completed the live course
45 under subparagraph (i) of this paragraph.

46 (iii) The commission shall develop and administer an online live ques-
47 tion and answer course for agency ethics officers.

48 (iv) The commission shall develop and administer training courses for
49 lobbyists and clients of lobbyists.

50 (v) The provisions of this subdivision shall be applicable to the
51 legislature except to the extent that an ethics training program is
52 otherwise established by the assembly and/or senate for their respective
53 members and employees and such program meets or exceeds each of the
54 requirements set forth in this subdivision.

55 (vi) On an annual basis, the commission, in coordination with the
56 legislative ethics commission, shall determine the status of compliance

1 with the training requirements under this subdivision by each state
2 agency and by the senate and the assembly. Such determination shall
3 include aggregate statistics regarding participation in such training
4 and shall be reported on a quarterly basis to the governor and the
5 legislature in writing.

6 9. Financial disclosure statements. (a) The commission may delegate
7 all or part of review, inquiry and advice in this section to the staff
8 under the supervision of the executive director.

9 (b) The commission shall make available forms for annual statements of
10 financial disclosure required to be filed pursuant to section seven-
11 ty-three-a of the public officers law; and the commission shall update
12 the financial disclosure form to include the term "domestic partner" on
13 the form.

14 (c) The commission shall review the financial disclosure statements of
15 the statewide elected officials and members of the legislature within
16 sixty days of their filings to determine, among other things, deficien-
17 cies and conflicts.

18 (d) The commission shall review financial disclosure statements filed
19 in accordance with the provisions of this section and (i) inquire
20 into any disclosed conflict to recommend how best to address such
21 conflict; and

22 (ii) ascertain whether any person subject to the reporting require-
23 ments of section seventy-three-a of the public officers law has failed
24 to file such a statement, has filed a deficient statement or has filed a
25 statement which reveals a possible violation of section seventy-three,
26 seventy-three-a or seventy-four of the public officers law.

27 (e) If a person required to file a financial disclosure statement with
28 the commission has failed to file a disclosure statement or has filed a
29 deficient statement, the commission shall notify the reporting person in
30 writing, state the failure to file or detail the deficiency, provide the
31 person with a fifteen-day period to cure the deficiency, and advise the
32 person of the penalties for failure to comply with the reporting
33 requirements. This first notice of deficiency shall be confidential. If
34 the person fails to make such filing or fails to cure the deficiency
35 within the specified time period, the commission shall send a notice of
36 delinquency (i) to the reporting person; (ii) in the case of a statewide
37 elected official, to the chief of staff or counsel to the statewide
38 elected official; (iii) in the case of a member of the legislature or a
39 legislative employee, to the temporary president of the senate and the
40 speaker of the assembly; and (iv) in the case of a state officer,
41 employee or board member, to the appointing authority for such person.
42 Such notice of delinquency may be sent at any time during the reporting
43 person's service as a statewide elected official, state officer or
44 employee, member of the assembly or the senate, or a legislative employ-
45 ee or a political party chair or while a candidate for statewide office,
46 or within one year after termination of such service or candidacy. A
47 copy of any notice of delinquency or report shall be included in the
48 reporting person's file and be available for public inspection and
49 copying pursuant to the provisions of this section. The jurisdiction of
50 the commission, when acting pursuant to this subdivision with respect to
51 financial disclosure, shall continue notwithstanding that the reporting
52 person separates from state service, or ceases to hold public or poli-
53 tical party office, or ceases to be a candidate, provided the commission
54 notifies such person of the alleged failure to file or deficient filing
55 pursuant to this subdivision.

1 (f) The commission shall adopt a procedure whereby a person who is
2 required to file an annual financial disclosure statement with the
3 commission may request an additional period of time within which to
4 file such statement, other than members of the legislature, candidates
5 for members of the legislature and legislative employees, due to justifi-
6 able cause or undue hardship.

7 (g) The commission may permit any person who is required to file a
8 financial disclosure statement with the commission to request that the
9 commission delete from the copy thereof made available for public
10 inspection and copying one or more items of information which may be
11 deleted by the commission upon a finding by the commission that the
12 information which would otherwise be required to be made available
13 for public inspection and copying will have no material bearing on the
14 discharge of the reporting person's official duties. If such request
15 for deletion is denied, the commission, in its notification of denial,
16 shall inform the person of their right to appeal the commission's
17 determination in a proceeding commenced against the commission, pursuant
18 to article seventy-eight of the civil practice law and rules.

19 (h) The commission may permit any person who is required to file a
20 financial disclosure statement with the commission to request an
21 exemption from any requirement to report one or more items of infor-
22 mation which pertain to such person's spouse, domestic partner, or
23 unemancipated children which item or items may be exempted by the
24 commission upon a finding by the commission that the reporting individ-
25 ual's spouse, domestic partner, on their own behalf, or on behalf of an
26 unemancipated child, objects to providing the information necessary to
27 make such disclosure and that the information which would otherwise
28 be required to be reported shall have no material bearing on the
29 discharge of the reporting person's official duties. If such
30 request for exemption is denied, the commission, in its notification of
31 denial, shall inform the person of their right to appeal the commis-
32 sion's determination, pursuant to article seventy-eight of the civil
33 practice law and rules.

34 (i) The commission may permit any person required to file a financial
35 disclosure statement to request an exemption from any requirement to
36 report the identity of a client pursuant to the question under subpara-
37 graph (b) of paragraph eight of subdivision three of section seventy-
38 three-a of the public officers law in such statement based upon an
39 exemption set forth in such question. The reporting individual need not
40 seek an exemption to refrain from disclosing the identity of any
41 client with respect to any matter where they or their firm provided
42 legal representation to the client in connection with an investi-
43 gation or prosecution by law enforcement authorities, bankruptcy, or
44 domestic relations matters. In addition, clients or customers
45 receiving medical or dental services, mental health services, residen-
46 tial real estate brokering services, or insurance brokering
47 services need not be disclosed. Pending any application for deletion or
48 exemption to the commission relating to the filing of a financial
49 disclosure statement, all information which is the subject or part of
50 the application shall remain confidential. Upon an adverse determination
51 by the commission, the reporting individual may request, and upon
52 such request the commission shall provide, that any information that is
53 the subject or part of the application remain confidential for a peri-
54 od of thirty days following notice of such determination. In the event
55 that the reporting individual resigns their office and holds no

1 other office subject to the jurisdiction of the commission, the informa-
2 tion shall not be made public and shall be expunged in its entirety.

3 (j) The commission shall permit any person who has not been determined
4 by the person's appointing authority to hold a policy-making posi-
5 tion, but who is otherwise required to file a financial disclo-
6 sure statement to request an exemption from such requirement in
7 accordance with rules and regulations governing such exemptions. Such
8 rules and regulations shall provide for exemptions to be granted either
9 on the application of an individual or on behalf of persons who share
10 the same job title or employment classification which the commission
11 deems to be comparable for purposes of this section. Such rules
12 and regulations may permit the granting of an exemption where, in the
13 discretion of the commission, the public interest does not require
14 disclosure and the applicant's duties do not involve the negotiation,
15 authorization or approval of:

16 (i) contracts, leases, franchises, revocable consents, concessions,
17 variances, special permits, or licenses as such terms are defined in
18 section seventy-three of the public officers law;

19 (ii) the purchase, sale, rental or lease of real property, goods or
20 services, or a contract therefor;

21 (iii) the obtaining of grants of money or loans; or

22 (iv) the adoption or repeal of any rule or regulation having the force
23 and effect of law.

24 10. Investigation and enforcement. (a) The commission shall receive
25 complaints and referrals alleging violations of section seventy-three,
26 seventy-three-a or seventy-four of the public officers law, article
27 one-A of the legislative law, or section one hundred seven of the civil
28 service law.

29 (b) The commission shall conduct any investigation necessary to carry
30 out the provisions of this section. Pursuant to this power and duty, the
31 commission may administer oaths or affirmations, subpoena witnesses,
32 compel their attendance and testimony, and require the production of any
33 books or records which it may deem relevant or material.

34 (c) The commission staff shall review and investigate, as appropriate,
35 any information in the nature of a complaint or referral received by the
36 commission or initiated by the commission, including through its review
37 of media reports and other information, where there is specific and
38 credible evidence that a violation of section seventy-three, seventy-
39 three-a, or seventy-four of the public officers law, section one hundred
40 seven of the civil service law or article one-A of the legislative law
41 by a person or entity subject to the jurisdiction of the commission
42 including members of the legislature and legislative employees and
43 candidates for members of the legislature.

44 (d) Upon the conclusion of an investigation, if the commission deter-
45 mines there is credible evidence of a violation of the laws under its
46 jurisdiction, it shall provide the respondent timely notice for a due
47 process hearing. The commission shall also inform the respondent of its
48 rules regarding the conduct of adjudicatory proceedings and appeals and
49 the other due process procedural mechanisms available to the respondent.

50 (e) The hearing shall be conducted before an independent arbitrator.
51 Such hearing shall afford the respondent with a reasonable opportunity
52 to appear in person, and by attorney, give sworn testimony, present
53 evidence, and cross-examine witnesses.

54 (f) The commission may, at any time, develop procedures and rules for
55 resolution of de minimus or minor violations that can be resolved

1 outside of the enforcement process, including the sending of a confiden-
2 tial guidance or educational letter.

3 (g) The jurisdiction of the commission when acting pursuant to this
4 section shall continue notwithstanding that a statewide elected official
5 or a state officer or employee or member of the legislature or legisla-
6 tive employee separates from state service, or a political party chair
7 ceases to hold such office, or a candidate ceases to be a candidate, or
8 a lobbyist or client of a lobbyist ceases to act as such, provided that
9 the commission notifies such individual or entity of the alleged
10 violation of law within two years from the individual's separation from
11 state service or termination of party service or candidacy, or from the
12 last report filed pursuant to article one-A of the legislative law.
13 Nothing in this section shall serve to limit the jurisdiction of the
14 commission in enforcement of subdivision eight of section seventy-three
15 of the public officers law.

16 (i) An individual subject to the jurisdiction of the commission who
17 knowingly and intentionally violates the provisions of subdivisions two
18 through five-a, seven, eight, twelve or fourteen through seventeen of
19 section seventy-three of the public officers law, section one hundred
20 seven of the civil service law, or a reporting individual who knowingly
21 and willfully fails to file an annual statement of financial disclosure
22 or who knowingly and willfully with intent to deceive makes a false
23 statement or fraudulent omission or gives information which such indi-
24 vidual knows to be false on such statement of financial disclosure filed
25 pursuant to section seventy-three-a of the public officers law, shall be
26 subject to a civil penalty in an amount not to exceed forty thousand
27 dollars and the value of any gift, compensation or benefit received as a
28 result of such violation.

29 (ii) An individual who knowingly and intentionally violates the
30 provisions of paragraph a, b, c, d, e, g, or i of subdivision three of
31 section seventy-four of the public officers law, shall be subject to a
32 civil penalty in an amount not to exceed ten thousand dollars and the
33 value of any gift, compensation or benefit received as a result of such
34 violation.

35 (iii) An individual subject to the jurisdiction of the commission who
36 knowingly and willfully violates article one-A of the legislative law
37 shall be subject to civil penalty as provided for in that article.

38 (iv) With respect to a potential violation of any criminal law where
39 the commission finds sufficient cause by a majority vote, it shall refer
40 such matter to the appropriate law enforcement authority for further
41 investigation.

42 (v) In assessing the amount of the civil penalties to be imposed, the
43 commission shall consider the seriousness of the violation, the amount
44 of gain to the individual and whether the individual previously had any
45 civil or criminal penalties imposed pursuant to this section, and any
46 other factors the commission deems appropriate.

47 (vi) A civil penalty for false filing shall not be imposed under this
48 subdivision in the event a category of "value" or "amount" reported
49 hereunder is incorrect unless such reported information is falsely
50 understated.

51 (vii) Notwithstanding any other provision of law to the contrary, no
52 other penalty, civil or criminal may be imposed for a failure to file,
53 or for a false filing, of such statement, or a violation of subdivision
54 six of section seventy-three of the public officers law, except that the
55 commission may recommend that the individual in violation of such subdi-
56 vision or section be disciplined.

1 (viii) The commission shall be deemed to be an agency within the mean-
2 ing of article three of the state administrative procedure act and shall
3 adopt rules governing the conduct of adjudicatory proceedings and
4 appeals taken pursuant to a proceeding commenced under article seventy-
5 eight of the civil practice law and rules relating to the assessment of
6 the civil penalties or the recommendation of employee discipline herein
7 authorized. Such rule shall provide for due process procedural mech-
8 anisms substantially similar to those set forth in article three of the

11 (h) (i) The commission shall have jurisdiction to investigate, but
12 shall have no jurisdiction to impose penalties or discipline upon
13 members of or candidates for member of the legislature or legislative
14 employees for any violation of the public officers law. If, after inves-
15 tigation and a due process hearing, the commission has found, by a
16 majority vote, a substantial basis to conclude that a member of the
17 legislature or a legislative employee or candidate for member of the
18 legislature has violated any provisions of such laws, it shall prepare a
19 written report of its findings and provide a copy of that report to the
20 legislative ethics commission, and to such individual in violation of
21 such law. The commission shall provide to the legislative ethics
22 commission copies of the full investigative file and hearing record.

23 (ii) With respect to the investigation of any individual who is not a
24 member of the legislature or a legislative employee or candidate for
25 member of the legislature, if after its investigation and due process
26 hearing, the commission has found a substantial basis to conclude that
27 the individual has violated the public officers law or the legislative
28 law, the commission shall determine whether, in addition to or in lieu
29 of any fine authorized by this article, the respondent should be
30 referred to their employer for discipline with a warning, admonition,
31 censure, suspension or termination or other appropriate discipline. With
32 regard to statewide elected officials, the commission may not order
33 suspension or termination but may recommend impeachment. The commission
34 shall then issue a report containing its determinations including its
35 findings of fact and conclusions of law to the respondent. The commis-
36 sion shall publish such report on its website within twenty days of its
37 delivery to the respondent.

38 11. Confidentiality. (a) When an individual becomes a commissioner or
39 staff of the commission, such individual shall be required to sign a
40 non-disclosure statement.

41 (b) Except as otherwise required or provided by law, testimony
42 received, or any other information obtained by a commissioner or staff
43 of the commission, shall not be disclosed by any such individual to any
44 person or entity outside of the commission during the pendency of any
45 matter. Any confidential communication to any person or entity outside
46 the commission related to the matters before the commission shall occur
47 only as authorized by the commission. For the purposes of this para-
48 graph, "matter" shall mean any complaint, review, inquiry, or investi-
49 gation into alleged violations of this chapter.

50 (c) The commission shall establish procedures necessary to prevent the
51 unauthorized disclosure of any information received by any member of the
52 commission or staff of the commission. Any breaches of confidentiality
53 may be investigated by the New York state office of the inspector gener-
54 al, attorney general, or other appropriate law enforcement authority
55 upon a majority vote of the commission to refer, and appropriate action
56 shall be taken.

1 (d) Any commission member or person employed by the commission who
2 intentionally and without authorization releases confidential informa-
3 tion received or generated by the commission shall be guilty of a class
4 A misdemeanor.

5 12. Annual report. (a) The commission shall make an annual public
6 report prioritizing transparency and summarizing the activities of the
7 commission during the previous year and recommending any changes in the
8 laws governing the conduct of persons subject to the jurisdiction of the
9 commission, or the rules, regulations and procedures governing the
10 commission's conduct. Such report shall include, but is not limited to:

11 (i) information on the number and type of complaints received by the
12 commission and the status of such complaints;

13 (ii) information relating to the investigation or investigations
14 opened by the commission, including the current status of each such
15 investigation;

16 (iii) where a matter has been resolved, the date and nature of the
17 disposition and any sanction imposed; provided, however, that such annu-
18 al report shall not contain any information for which disclosure is not
19 permitted pursuant to this section or other laws;

20 (iv) information regarding financial disclosure compliance for the
21 preceding year; and

22 (v) information regarding lobbying law filing compliance for the
23 preceding year.

24 (b) Such a report shall be filed in the office of the governor and
25 with the legislature on or before the first day of February for the
26 preceding year.

27 13. Website. (a) Within one hundred twenty days of the effective date
28 of this section, the commission shall create and thereafter maintain a
29 publicly accessible website which shall set forth the procedure for
30 filing a complaint with the commission, the filing of financial disclo-
31 sure statements filed by state officers or employees or legislative
32 employees, the filing of statements required by article one-A of the
33 legislative law, and any other records or information which the commis-
34 sion determines to be appropriate.

35 (b) The commission shall post on its website the following documents:

36 (i) the information set forth in an annual statement of financial
37 disclosure filed pursuant to section seventy-three-a of the public offi-
38 cers law except information deleted pursuant to paragraph (g) of subdivi-

40 (ii) notices of delinquency sent under subdivision nine of this
41 section;

42 (iii) notices of civil assessments imposed under this section which
43 shall include a description of the nature of the alleged wrongdoing, the
44 procedural history of the complaint, the findings and determinations
45 made by the commission, and any sanction imposed;

46 (iv) the terms of any settlement or compromise of a complaint or
47 referral which includes a fine, penalty or other remedy;

48 (v) those required to be held or maintained publicly available pursu-
49 ant to article one-A of the legislative law; and

50 (vi) reports issued by the commission pursuant to this section.

51 14. Additional powers. In addition to any other powers and duties
52 specified by law, the commission shall have the power and duty to admin-
53 ister and enforce all the provisions of this section.

54 15. Severability. If any part or provision of this section or the
55 application thereof to any person or organization is adjudged by a court
56 of competent jurisdiction to be unconstitutional or otherwise invalid,

1 such judgment shall not affect or impair any other part or provision or
2 the application thereof to any other person or organization, but shall
3 be confined in its operation to such part or provision.

4 § 3. Subdivision (f) of section 1-c of the legislative law, as amended
5 by chapter 14 of the laws of 2007, is amended to read as follows:

6 (f) The term "commission" shall mean the independent commission on
7 ~~[public integrity]~~ ethics and lobbying in government created by section

9 § 4. Subdivisions 7, 9, 10, 12 and 13 of section 80 of the legislative
10 law, as amended by section 9 of part A of chapter 399 of the laws of
11 2011, are amended to read as follows:

13 a. Appoint an executive director who shall act in accordance with the
14 policies of the commission, provided that the commission may remove the

55 h. Review financial disclosure statements in accordance with the
56 provisions of this section, provided however, that the commission may

1 delegate all or part of the review function relating to financial
2 disclosure statements filed by legislative employees pursuant to
3 sections seventy-three and seventy-three-a of the public officers law to
4 the executive director who shall be responsible for completing staff
5 review of such statements in a manner consistent with the terms of the
6 commission's delegation;

7 i. Upon written request from any person who is subject to the juris-
8 diction of the commission and the requirements of sections seventy-

3 9. (a) An individual subject to the jurisdiction of the commission
4 with respect to the imposition of penalties who knowingly and inten-
5 tionally violates the provisions of subdivisions two through five-a,
6 seven, eight, twelve, fourteen or fifteen of section seventy-three of
7 the public officers law or a reporting individual who knowingly and
8 wilfully fails to file an annual statement of financial disclosure or
9 who knowingly and wilfully with intent to deceive makes a false state-
10 ment or gives information which such individual knows to be false on
11 such statement of financial disclosure filed pursuant to section seven-
12 ty-three-a of the public officers law shall be subject to a civil penal-
13 ty in an amount not to exceed forty thousand dollars and the value of
14 any gift, compensation or benefit received as a result of such
15 violation. Any such individual who knowingly and intentionally violates
16 the provisions of paragraph a, b, c, d, e, g, or i of subdivision three
17 of section seventy-four of the public officers law shall be subject to a

20 violation. Assessment of a civil penalty hereunder shall be made by the
21 commission with respect to persons subject to its jurisdiction. In
22 assessing the amount of the civil penalties to be imposed, the commis-

5 (d-1) A financial disclosure statement required pursuant to section

9 legislative ethics commission for all purposes including, but not limit-

In making its determination, the ~~joint~~ independent commission on ethics and lobbying in government or the office of court administration shall conduct its own inquiry and shall consider factors including, but not limited to: (i) the nature and the size of the client; (ii) whether the client has any business before the state; and if so, how significant the business is; and whether the client has any particularized interest in pending legislation and if so how significant the interest is; (iii) whether disclosure may reveal trade secrets; (iv) whether disclosure could reasonably result in retaliation against the client; (v) whether disclosure may cause undue harm to the client; (vi) whether disclosure may result in undue harm to the attorney-client relationship; and (vii) whether disclosure may result in an unnecessary invasion of privacy to the client.

The ~~joint~~ independent commission on ethics and lobbying in government or, as the case may be, the office of court administration shall promptly make a final determination in response to such request, which shall include an explanation for its determination. The office of court administration shall issue its final determination within three days of receiving the request. Notwithstanding any other provision of law or any professional disciplinary rule to the contrary, the disclosure of the identity of any client or customer in response to this question shall not constitute professional misconduct or a ground for disciplinary action of any kind, or form the basis for any civil or criminal cause of action or proceeding. A reporting individual who first enters public office after December thirty-first, two thousand fifteen, need not report clients or customers with respect to matters for which the reporting individual or his or her firm was retained prior to entering public office.

40 (ii) any court or prosecutor for the purposes of a pending criminal

(c) In any civil action, an official record of a conviction that has been sealed pursuant to this section may not be introduced as evidence of negligence against a person or entity that provided employment, contract labor or services, volunteer work, licensing, tenancy, a home purchase, a mortgage, an education, a loan, or insurance if such record was sealed and was not provided to the person or entity by or on behalf of a governmental entity in accordance with this section in response to such person's or entity's authorized and timely request for conviction history information.

(d) A person or entity described in this subdivision, acting reasonably and in good faith, may not have a duty to investigate the fact of a prior conviction that has been sealed pursuant to this section.

5. No defendant shall be required or permitted to waive eligibility for sealing pursuant to this section as part of a plea of guilty, sentence or any agreement related to a conviction for a violation of the laws of this state. Any such waiver is void and unenforceable.

6. Sealing as set forth in subdivision three of this section is without prejudice to a defendant or their attorney seeking further relief pursuant to section 440.10 of this chapter. Nothing in this section shall diminish or abrogate any rights or remedies otherwise available to the defendant.

7. All records for a conviction subject to sealing under this section where the conviction was entered on or before the effective date of this section shall receive the appropriate relief promptly and, in any event, no later than two years after such effective date.

8. A conviction which is sealed pursuant to this section is included within the definition of a conviction for the purposes of any criminal proceeding in which the fact of a prior conviction would enhance a penalty or is an element of the offense charged.

§ 2. Section 9 of the correction law, as added by section 2 of part 00 of chapter 56 of the laws of 2010, the section heading as amended by chapter 322 of the laws of 2021, is amended to read as follows:

33 state correctional facilities [~~and such penitentiaries~~] who are phys-
34 ically capable thereof to be employed for not to exceed eight hours of
35 each day other than Sundays and public holidays. Notwithstanding any
36 other provision of this section, however, the commissioner and super-
37 intendents [~~of state correctional facilities~~] may employ incarcerated
38 individuals on a volunteer basis on Sundays and public holidays in
39 specialized areas of the facility, including kitchen areas, vehicular
40 garages, rubbish pickup and grounds maintenance, providing, however,
41 that incarcerated individuals so employed shall be allowed an alterna-
42 tive free day within the normal work week.

43 2. Such labor shall be either for the purpose of the production of
44 supplies for said institutions, or for the state, or any political
45 subdivision thereof, or for any public institution owned or managed and
46 controlled by the state, or any political subdivision thereof; or for
47 the purpose of industrial training and instruction, or partly for one,
48 and partly for the other of such purposes. It shall also be lawful for
49 incarcerated individuals to be employed by and be paid fair and just
50 compensation by a private sector entity, or be paid as part of a prison
51 industries certification program authorized by section one hundred
52 seventy-two of this article and certified by the United States depart-
53 ment of justice in accordance with 18 U.S.C. § 1761.

§ 3. The correction law is amended by adding a new section 172 to read as follows:

§ 172. Employment by private sector entities; prison industries certification program. 1. The commissioner may enter into contracts with private sector individuals, partnerships, corporations, or other business entities whereby an area within a correctional facility may be made available to such entity for use as a work site at which incarcerated individuals who volunteer may be employed by such entities. Except for the permissible offsets against wages, the laws of the state with respect to employment conditions shall apply to incarcerated individuals participating in employment through private sector entities or through a prison industries certification program.

2. The commissioner is hereby authorized and empowered to establish and implement a prison industries certification program in one or more correctional facilities of the department as provided for in 18 U.S.C. § 1761. The commissioner shall promulgate rules and regulations consistent with such federal and state laws which shall include, but not be limited to, provisions defining incarcerated individual eligibility and ensuring incarcerated individuals are compensated at wages which are comparable to the wages paid for work of similar nature in the locality in which the work is performed, and provisions providing for the gross wages of incarcerated individuals to be offset in an aggregate amount not to exceed fifty percent for taxes, support of family, restitution for crime victims, and other lawful obligations.

§ 4. Section 177 of the correction law is amended by adding a new subdivision 8 to read as follows:

8. Notwithstanding any other provision of law to the contrary, the commissioner may enter into a contract or contracts with private sector individuals, partnerships, corporations or other business entities whereby an area within a correctional facility may be made available to such entity for use as a work site at which incarcerated individuals who volunteer may be employed by such entity or employed as part of a prison industries certification program established pursuant to section one hundred seventy-two of this article.

§ 5. Section 178 of the correction law, as amended by chapter 322 of the laws of 2021, is amended to read as follows:

§ 178. Participation in work release and other community activities; employment by private entities or participation in a prison industries certification program. Nothing contained in this article shall be construed or applied so as to prohibit private employment of incarcerated individuals in the community under a work release program, or a residential treatment facility program formulated pursuant to any provision of this chapter, or the employment of incarcerated individuals by a private sector entity or participation in a prison industries program pursuant to section one hundred seventy-two of this article.

§ 6. Section 187 of the correction law is amended by adding a new subdivision 5 to read as follows:

5. The compensation paid to incarcerated individuals employed by private entities under section one hundred seventy-two of this article shall be set in accordance with rules and regulations adopted by the commissioner. The compensation paid to incarcerated individuals participating in a prison industries program shall be set in accordance with 18 U.S.C. § 1761.

§ 7. This act shall take effect on the first of January next succeeding the date upon which the people shall approve and ratify amendments to section 24 of article 3 of the constitution by a majority of the

1 electors voting thereon relating to authorizing incarcerated individuals
2 to be employed by and be paid compensation by a private sector entity as
3 part of a prison industries certification program authorized by the laws
4 of the United States.

5 § 2. Severability clause. If any clause, sentence, paragraph, subdivi-
6 sion, section or part of this act shall be adjudged by any court of
7 competent jurisdiction to be invalid, such judgment shall not affect,
8 impair, or invalidate the remainder thereof, but shall be confined in
9 its operation to the clause, sentence, paragraph, subdivision, section
10 or part thereof directly involved in the controversy in which such judg-
11 ment shall have been rendered. It is hereby declared to be the intent of
12 the legislature that this act would have been enacted even if such
13 invalid provisions had not been included herein.

14 § 3. This act shall take effect immediately provided, however, that
15 the applicable effective date of Parts A through BB of this act shall be
16 as specifically set forth in the last section of such Parts.
