AN ACT to amend the social services law, in relation to establishing crime victim and trauma survivor recovery centers throughout the state

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1	Section 1. Article 5 of the social services law is amended by adding a
2	new title 12-B to read as follows:

4	CRIME VICTIM AND TRAUMA SURVIVOR RECOVERY CENTERS
5	Section 370-e. Crime victim and trauma survivor recovery centers.
б	<u>§ 370-e. Crime victim and trauma survivor recovery centers. 1. The</u>
7	department shall facilitate the development and establishment of, and
8	designate, five regional crime victim and trauma survivor recovery
9	centers across the state. The department shall establish procedures and
10	criteria for the designation of such centers ensuring geographic cover-
11	age across the state consistent with this section.
12	2. Such crime victim and trauma survivor recovery centers shall focus
13	<u>on helping individuals who have:</u>
14	(a) been a victim of a violent crime, including individuals who have
15	suffered gunshot wounds;
16	(b) been a victim of sexual assault;
17	(c) been a victim of domestic violence;
18	(d) been a victim of human trafficking;
19	(e) been a victim of a hate crime; or
20	(f) had a family member assaulted or killed.
21	3. The following services to be offered at the crime victim and trauma
22	survivor recovery centers established pursuant to this title shall
23	include, but not be limited to:
24	(a) trauma-informed clinical case management;
25	(b) evidence-based individual, group and family psychotherapy;
26	(c) crisis intervention;

2	<u>(e) legal advocacy;</u>
3	(f) assistance with filing police reports and accessing victim compen-
4	sation funds;
5	(g) mental health services;
6	(h) help with relocation of an individual when safety is threatened;

8	(i) transportation aid to and from medical appointments, court dates,
9	and other related events.
10	4. The services provided by crime victim and trauma survivor recovery
11	centers pursuant to subdivision three of this section shall be provided
12	free of charge and no individual receiving treatment shall be liable for
13	the cost of any such services.
14	5. Each crime victim and trauma survivor recovery center shall work
15	with community partners to educate the local community in order to be
16	more trauma informed. "Community partners" shall include, but not be
17	limited to, criminal justice organizations, social services organiza-
18	tions and health care organizations.
19	§ 2. This act shall take effect immediately.
