AN ACT authorizing the county of Suffolk and the town of Smithtown, located in the county of Suffolk, to exchange certain parklands

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Subject to the provisions of this act:

(a) the county of Suffolk acting by and through its governing body is 2 3 hereby authorized and empowered to convey the property described in 4 section two of this act, which was heretofore used by such county for 5 park and/or recreational purposes, upon terms agreed upon between the parties, to the town of Smithtown, located in the county of Suffolk, for б 7 use by such town for park and/or recreational purposes, provided, howev-8 er, that the town of Smithtown shall continue to provide access to such 9 parkland and/or recreational facilities to all residents of the county 10 of Suffolk and that such town shall not enact any fees or charges which 11 are higher for such access for county residents who are not town resi-12 dents; and

13 (b) the town of Smithtown acting by and through its governing body is 14 hereby authorized and empowered to convey the property described in 15 section three of this act, which was heretofore used by such town for park and/or recreational purposes, upon terms agreed upon between the 16 parties, to the county of Suffolk for use by such county for park and/or 17 recreational purposes, provided, however, that the county of Suffolk 18 shall continue to provide access to such parkland and/or recreational 19 20 facilities to all residents of the town of Smithtown and that such coun-21 ty shall not enact any fees or charges for such access which are higher 22 for town residents.

23 § 2. The parklands authorized by subdivision (a) of section one of 24 this act to be conveyed to the town of Smithtown, located in the county 25 of Suffolk, are described as follows:

The land to be transferred pursuant to this act and all struc-§ 46 tures and facilities situated on such land shall be maintained, owned 47 and operated for park purposes by the county of Suffolk for lands 48 acquired pursuant to subdivision (b) of section one of this act, and the 49 town of Smithtown, located in the county of Suffolk for lands acquired pursuant to subdivision (a) of section one of this act. The use of such 50 parkland and facilities shall continue to be made available to the 51 general public of the state of New York, including all residents of the 52 53 county of Suffolk and the town of Smithtown, located in the county of 54 Where the availability of such facilities is limited, use of Suffolk.

55 such facilities shall be determined by an equitable method.

56 § 5. This act shall take effect immediately.
