AN ACT to amend the public health law and the education law, in relation to directing the commissioners of education and health to establish rules and regulations for the treatment and monitoring of students of school districts, boards of cooperative educational services and nonpublic schools who exhibit signs or symptoms of sudden cardiac arrest

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Short title. This act shall be known and may be cited as
2 the "Dominic Murray sudden cardiac arrest prevention act".

3 § 2. Section 206 of the public health law is amended by adding a new
4 subdivision 31 to read as follows:

5 31. The commissioner shall develop information, in conjunction with
6 the commissioner of education related to students who exhibit signs or
7 symptoms of pending or increased risk of sudden cardiac arrest. Such
8 information shall include, but not be limited to, the definition of
9 sudden cardiac arrest, signs and symptoms of sudden cardiac arrest.
10 Such information shall be posted on the department's website.

11 § 3. The education law is amended by adding a new section 923 to read
12 as follows:

13 § 923. Sudden cardiac arrest. a. The commissioner shall review the
14 information developed by the commissioner of health required by subdivi-
15 sion thirty-one of section two hundred six of the public health law to

1 assist in the education and awareness of the signs and symptoms of pend-
2 ing or increased risk of sudden cardiac arrest. Such information shall
3 be posted on the department's website. In addition, each school shall be
4 required to include such information developed by the department of
5 health, in conjunction with the department, in any permission form or
6 parent or person in parental relation consent form or similar document
7 that may be required for a student's participation in interscholastic
8 athletics and shall also include such information, or reference how to
9 obtain such information from the department and the department of
10 health's websites, on the school's website, if one exists.

11 b. The commissioner shall promulgate rules and regulations requiring
12 that any student displaying signs or symptoms of pending or increased
13 risk of sudden cardiac arrest shall be immediately removed from athletic
14 activities and shall not resume athletic activity until he or she has
15 been evaluated by and received written and signed authorization from a
16 licensed physician. Such authorization shall be kept on file in the
17 pupil's permanent health record.

18 § 4. Subdivision 1 of section 3001-b of the education law, as added by
19 chapter 498 of the laws of 1991, is amended to read as follows:

20 1. On and after the effective date of this section, in addition to any
21 provision of law or rule or regulation of the department related to the
22 requirements necessary for teachers within the public school systems,
23 whether certified in physical education or not, to coach any extra-class
24 athletic activity, it shall be required of such teachers, except as
25 provided in subdivision two of this section, to hold a valid certificate
26 of completion of a course of study in first aid knowledge and skills
27 offered by [~~the American National Red Cross~~] a nationally recognized
28 organization, as defined in paragraph (d) of subdivision one of section
29 three thousand-b of the public health law and approved by the commis-
30 sioner, or to meet equivalent requirements as certified by the commis-
31 sioner. Any such course of study or equivalent requirements must include
32 instruction in recognizing signs and symptoms of cardiac arrest and
33 sudden cardiac arrest and the administration of adult cardiopulmonary
34 resuscitation. Prior to the start of each sports season, coaches must
35 provide valid evidence to their chief school officer that their first
36 aid and adult cardiopulmonary resuscitation knowledge and skills are
37 current pursuant to the requirements established by [~~the American~~
38 ~~National Red Cross~~] a nationally recognized organization, as defined in
39 paragraph (d) of subdivision one of section three thousand-b of the

42 § 5. Subdivision 1 of section 3001-c of the education law, as added by
43 chapter 39 of the laws of 1994, is amended to read as follows:

44 1. On and after the effective date of this section, it shall be
45 required of coaches of high school extra-class athletic activities in a
46 nonpublic school system, except as provided in subdivision two of this
47 section, to hold a valid certificate of completion of a course of study
48 in first aid knowledge and skills offered by [~~the American National Red~~
49 ~~Cross~~] a nationally recognized organization, as defined in paragraph (d)
50 of subdivision one of section three thousand-b of the public health law
51 and approved by the commissioner, or to meet equivalent requirements as
52 certified by the commissioner. Any such course of study or equivalent
53 requirements must include instruction in recognizing signs and symptoms
54 of cardiac arrest and sudden cardiac arrest and the administration of
55 adult cardiopulmonary resuscitation. Prior to the start of each sports
56 season, coaches must provide valid evidence to their chief school offi-

1 cer that their first aid and adult cardiopulmonary resuscitation know-
2 ledge and skills are current pursuant to the requirements established by
3 [~~the American National Red Cross~~] a nationally recognized organization,
4 as defined in paragraph (d) of subdivision one of section three thou-
5 sand-b of the public health law and approved by the commissioner, or
6 that they meet equivalent requirements as certified by the commissioner.
7 § 6. This act shall take effect on the first of July next succeeding
8 the date on which it shall have become a law. Effective immediately, the
9 addition, amendment and/or repeal of any rule or regulation necessary
10 for the implementation of this act on its effective date are authorized
11 to be made and completed on or before such effective date.
