AN ACT relating to creating the commission on affordable college education to study the participation of community colleges in the educational opportunity program; and providing for the repeal of such provisions upon expiration thereof

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Legislative findings. The legislature hereby acknowledges
2 the need for a college education to compete in today's market. Further-
3 more, residents throughout New York state are in need of more affordable
4 higher education options. Currently, ten out of the thirty SUNY communi-
5 ty colleges do not participate in the Educational Opportunity Programs
6 (EOP), which provide vital financial and academic support for thousands
7 of academic and economically disadvantaged New Yorkers throughout the
8 state. Subsequently, community college students from those ten two-year
9 colleges, who seek to transfer into a four-year school as Higher Educa-
10 tion Opportunity Program (HEOP) or EOP applicants risk potentially
11 disqualifying themselves for such financial and academic support
12 programs.

13 § 2. A temporary state commission, to be known as the "commission on
14 affordable college education", is hereby established to examine, evalu-
15 ate and make recommendations concerning the need for the ten SUNY commu-
16 nity colleges to participate in EOP. The commission shall consider the
17 need for additional legislation to amend current eligibility criteria
18 for transfer students.

19 § 3. The commission shall consist of thirteen members, to be appointed
20 as follows: three members to be appointed by the governor; three members
21 to be appointed by the temporary president of the senate; three members
22 to be appointed by the speaker of the assembly; two members to be
23 appointed by the minority leader of the senate; and two members to be

1 appointed by the minority leader of the assembly. The members shall have
2 demonstrated expertise in and experience in the field of higher educa-
3 tion, HEOP, or EOP. A chairperson and vice-chairperson of such commis-
4 sion shall be elected by the majority of its members, all members being
5 present.

6 § 4. The members of the commission shall receive no compensation for
7 their services, but shall be allowed their actual and necessary expenses
8 incurred in the performance of their duties hereunder.

9 § 5. The commission may employ and at pleasure remove such personnel
10 as it may deem necessary for the performance of its functions. Such
11 commission may meet and hold public and/or private hearings within or
12 without the state, and shall have all the powers of a legislative
13 committee pursuant to the legislative law.

14 § 6. For the accomplishment of its purposes, the commission shall be
15 authorized and empowered to undertake any studies, inquiries, surveys or
16 analyses it may deem relevant in cooperation with or by agreement with
17 any other public or private agency.

18 § 7. The commission shall make a report of its findings, including any
19 recommendations for legislative action as it may deem necessary and
20 appropriate, to the governor, the temporary president of the senate and
21 the speaker of the assembly no later than one year after the effective
22 date of this act.

23 § 8. This act shall take effect on the ninetieth day after it shall
24 become a law and shall expire and be deemed repealed two years after
25 such date.
