AN ACT to amend the energy law, in relation to the use of general purpose lights in public buildings

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Section 8-103 of the energy law, as amended by chapter 744 of the laws of 1979, is amended to read as follows:

3 § 8-103. Application. 1. On or before April first, nineteen hundred eighty, the commissioner shall promulgate, and thereafter may amend from 4 5 time to time, standards relating to the lighting of all existing buildб ings, or classes of such buildings, for purposes of minimizing the 7 consumption of energy and providing for the efficient utilization of the energy expended for lighting in the use and occupancy of such buildings. 8 Such standards shall be cost effective and shall not impair the health 9 and safety of the occupants of the property. The standards shall be 10 deemed cost effective if the cost of implementing them would be equal to 11 12 or less than the present value of energy and maintenance savings that 13 would be expected over a seven-year period in a building to which the standards are applicable. Provided however, on and after the effective 14 date of the chapter of the laws of two thousand twenty-one which amended 15 this section, all general purpose lights used in public buildings in 16 this state shall meet the energy efficiency standards established in 17 18 subdivision two of this section.

19 <u>2. The minimum energy efficiency standards for a general service lamp</u> 20 <u>used in a public building in the state shall be as follows:</u>

21 (a) By January first, two thousand twenty-four, for a lamp with a 22 lumen output of between twenty-six hundred ninety and fourteen hundred

23 <u>ninety, the lamp shall achieve fifty lumens per watt.</u>

1	(b) By January first, two thousand twenty-five, for a lamp with a
2	lumen output of between fourteen hundred eighty-nine and one thousand
3	ten, the lamp shall achieve fifty lumens per watt.
4	(c) By January first, two thousand twenty-six, for a lamp with a lumen
5	output of between one thousand nine and seven hundred thirty, the lamp
б	<u>shall achieve fifty lumens per watt.</u>
7	(d) By January first, two thousand thirty, for a lamp with a lumen
8	output of between seven hundred twenty-nine and three hundred forty, the
9	<u>lamp shall achieve forty lumens per watt.</u>
10	3. For the purposes of this section:
11	(a) "General service lamp" means a standard type lamp that is intended
12	for general service applications and has all of the following:
13	<u>(i) a medium screw base;</u>
14	(ii) a wattage rating of no less than twenty-five watts and no greater
15	than one hundred fifty watts;
16	<u>(iii) a A-15, A-19, A-21, A-23, A-25, PS-25, PS-30, BT-14.5, BT-15,</u>
17	CP-19, TB-19, CA-22, or equivalent shape as defined in the American
18	National Standards Institute C78.20-2003; and
19	(iv) a bulb finish of frosted, clear, or soft white type.
20	A general service lamp does not include an appliance lamp, black light
21	lamp, bug lamp, colored lamp, enhanced spectrum lamp, infrared lamp,
22	left-hand tread lamp, marine lamp, marine signal service lamp, mine
23	service lamp, plant light, reflector lamp, rough service lamp, shatter
24	resistant lamp, sign service lamp, silver bowl lamp, showcase lamp,
25	three-way lamp, traffic signal lamp or vibration service or vibration
26	<u>resistant lamp.</u>
27	(b) "Public building" shall mean all buildings including grounds and
28	premises adjacent or appurtenant thereto or connected thereto belonging
29	to the state, county, town, village, school district or any other poli-
30	tical or civil subdivision of state or local government.

31 § 2. This act shall take effect on the first of January next succeed-32 ing the date on which it shall have become a law.
