AN ACT to amend the criminal procedure law, in relation to eligibility for conviction sealing for eligible youth

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Section 720.20 of the criminal procedure law is amended by 1 adding a new subdivision 5 to read as follows:

5. (a) Notwithstanding any other law, where an eligible youth was not determined to be a youthful offender by the court pursuant to subdivision one of this section, but was otherwise eligible to be determined to be a youthful offender pursuant to this article, such individual shall be eliqible to apply for conviction sealing in accordance with section 160.59 of this chapter. An "eligible offense" for such individual shall include any crime defined in the laws of this state other than (i) a 10 class A-I or class A-II felony, or (ii) an armed felony as defined in subdivision forty-one of section 1.20 of this chapter, except as 12 provided in paragraph (b) of this subdivision, or (iii) an offense for which registration as a sex offender is required pursuant to article six-C of the correction law.

(b) Notwithstanding the provisions of paragraph (a) of this subdivision, an eligible youth who has been convicted of an armed felony offense is eligible for conviction sealing pursuant to section 160.59 of this chapter if the sentencing judge, or county or supreme court determines that one or more of the following factors exist: (i) mitigating 20 circumstances that bear directly upon the manner in which the crime was committed; or (ii) where the defendant was not the sole participant in the crime, the defendant's participation was relatively minor although 23 not so minor as to constitute a defense to the prosecution.

(c) An eligible youth who has previously applied for conviction seal-
