AN ACT to amend the criminal procedure law and the judiciary law, in relation to judicial diversion programs; and to repeal certain provisions of the criminal procedure law relating thereto

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. The article heading of article 216 of the criminal procedure law, as added by section 4 of part AAA of chapter 56 of the laws of 2009, is amended to read as follows:

4 JUDICIAL DIVERSION [~~PROGRAM FOR CERTAIN FELONY OFFENDERS~~]
5 PROGRAMS

6 § 2. The opening paragraph of subdivision 1 of section 216.00 of the criminal procedure law, as amended by chapter 90 of the laws of 2014, is amended to read as follows:

9 "Eligible defendant" means any person who stands charged in an indictment [~~or a~~], superior court information [~~with a class B, C, D or E felony offense defined in article one hundred seventy-nine, two hundred twenty or two hundred twenty one of the penal law or any other specified offense as defined in subdivision four of section 410.91 of this chapter, provided, however, a defendant is not an "eligible defendant" if he or she~~], misdemeanor complaint or felony complaint with any offense and has a functional impairment.

17 § 3. The opening paragraph of subdivision 1 of section 216.00 of the criminal procedure law, as added by section 4 of part AAA of chapter 56 of the laws of 2009, is amended to read as follows:

§ 4. Paragraphs (a) and (b) and the closing paragraph of subdivision 1 of section 216.00 of the criminal procedure law are REPEALED.

§ 5. Subdivision 2 of section 216.00 of the criminal procedure law, as added by section 4 of part AAA of chapter 56 of the laws of 2009, is amended to read as follows:

2. [~~"Alcohol and substance abuse evaluation"~~] "Participant" means an eligible defendant who has been admitted into the treatment court.

3. "Functional impairment" means a condition that impairs the eligible defendant's functioning. A functional impairment may include, but is not limited to, substance abuse or alcohol dependence, mental illness, developmental disability, intellectual disability, traumatic brain injury or other neurological disease, personality disorder, cognitive dysfunction, dementia, emotional disturbance or any other disability. The court shall defer to licensed health care professionals and the broader medical community consensus in determining whether a person is disabled or functionally impaired. A person may have more than one functional impairment.

4. "Clinical evaluation" means a written assessment and report by a [~~court approved entity or~~] licensed [~~health care professional experienced in the treatment of alcohol and substance abuse, or~~] clinician qualified to identify functional impairments as defined in subdivision three of this section or an evaluation conducted by an addiction and substance [~~abuse~~] use disorder counselor credentialed by the office of [~~alcoholism and substance abuse services~~] addiction services and supports pursuant to section 19.07 of the mental hygiene law, which shall include:

(a) an evaluation as to whether the defendant currently has [~~a history of alcohol or substance abuse or alcohol or substance dependence~~] one or more functional impairments that may include but not be limited to a mental disorder, as [~~such terms are~~] defined in the most recent edition of the diagnostic and statistical manual of mental disorders, [~~fourth edition, and a co-occurring mental disorder or mental illness and the relationship between such abuse or dependence and mental disorder or mental illness,~~] if any;

(b) a recommendation as to whether the defendant's [~~alcohol or substance abuse or dependence~~] functional impairments, if any, could be effectively addressed by judicial diversion in accordance with this article;

(c) a recommendation as to the treatment modality, level of care and length of any proposed treatment to effectively address the defendant's [~~alcohol or substance abuse or dependence and any co-occurring mental disorder or illness~~] functional impairments in accordance with federal law requiring the most integrated setting appropriate to the needs of individuals with disabilities; and

(d) any other information, factor, circumstance, or recommendation deemed relevant by the assessing entity or specifically requested by the court.

5. "Treatment" means one or more evidence-based interventions including, but not limited to, counseling, psychotherapy, pharmacotherapy, psychiatric medication, health promotion, and overdose prevention educa-

1 tion. For substance use disorders, treatment includes any clinical
2 service or intervention that assists individuals to achieve recovery in
3 the form of: (a) abstinence from all or certain psychoactive substances;
4 (b) a change or reduction in use; or (c) improved well-being, social
5 stability and the alleviation of associated harms.

6 6. "Treatment provider" means a person or organization qualified to
7 provide interventions responsive to the needs identified by the partic-
8 ipant and clinician during the clinical evaluation.

9 § 6. Section 216.05 of the criminal procedure law, as added by section
10 4 of part AAA of chapter 56 of the laws of 2009, subdivision 5 as
11 amended by chapter 67 of the laws of 2016, subdivision 8 as amended by
12 chapter 315 of the laws of 2016 and paragraph (a) of subdivision 9 as
13 amended by section 21 of part JJJ of chapter 59 of the laws of 2019, is
14 amended to read as follows:

15 § 216.05 Judicial diversion program; court procedures.

16 1. At any time after the local criminal court arraignment of an eligi-
17 ble defendant, but prior to the entry of a plea of guilty or the
18 commencement of trial, the court at the request of the eligible defend-
19 ant, [~~may~~] shall order [~~an alcohol and substance abuse~~] a clinical eval-
20 uation for all known functional impairments. Such evaluations shall take
21 place without undue delay.

22 (a) The possibility of being evaluated shall not be contingent on a
23 waiver of any other sections of this chapter except subdivision one of
24 section 30.30 of this chapter.

25 (b) An eligible defendant may decline to [~~participate in~~] undergo such
26 an evaluation at any time.

27 (c) The defendant shall provide a written authorization, in compliance
28 with the requirements of any applicable state or federal laws, rules or
29 regulations authorizing disclosure of the results of the assessment to
30 the defendant's attorney, the prosecutor, the local probation depart-
31 ment, the court, authorized court personnel and other individuals speci-
32 fied in such authorization for the sole purpose of determining whether
33 the defendant should be offered judicial diversion for treatment for
34 [~~substance abuse or dependence, alcohol abuse or dependence and any~~
35 ~~co-occurring mental disorder or mental illness~~] a functional impairment.

36 (d) No statement or other disclosure, written or otherwise, made by a
37 defendant to a professional completing the clinical evaluation may be
38 used by the prosecution to prove any crime or offense alleged in the
39 pending case. All such statements shall be used only for the purposes of
40 making recommendations as defined in subdivision two of this section and
41 shall otherwise remain confidential.

42 2. Upon receipt of the completed [~~alcohol and substance abuse~~] clin-
43 ical evaluation report, the court shall provide a copy of the report to
44 the eligible defendant and the [~~prosecutor~~] defendant's counsel.

45 3. (a) Upon [~~receipt~~] review of the evaluation report [~~either party~~]
46 the defendant may request a hearing on the issue of whether the [~~eligi-~~
47 ~~ble~~] defendant is an eligible defendant and should be offered [~~alcohol~~
48 ~~or substance abuse~~] treatment pursuant to this article. At the time that
49 the defendant requests a hearing, the defendant shall turn over a
50 complete copy of the evaluation report to the prosecutor and the court.

51 At such a proceeding, which shall be held as soon as practicable so as
52 to facilitate early intervention in the event that the [~~defendant~~]
53 participant is found to need [~~alcohol or substance abuse~~] treatment, the
54 court may consider oral and written arguments, [~~may~~] take testimony from
55 witnesses offered by either party, and [~~may~~] consider any relevant
56 evidence [~~including, but not limited to, evidence that:~~

1 ~~(i) the defendant had within the preceding ten years (excluding any~~
2 ~~time during which the offender was incarcerated for any reason between~~
3 ~~the time of the acts that led to the youthful offender adjudication and~~

15 (b) Upon completion of such a proceeding, the court shall consider and
16 make findings of fact with respect to whether:

17 (i) the defendant is an eligible defendant as defined in subdivision
18 one of section 216.00 of this article;

19 ~~(ii) [the defendant has a history of alcohol or substance abuse or~~
20 ~~dependence;~~

21 ~~(iii) such alcohol or substance abuse or dependence] the defendant's~~
22 ~~functional impairment is likely a contributing factor to [the defend-~~
23 ~~ant's criminal behavior] their current or future involvement in the~~
24 ~~criminal legal system;~~

25 ~~[(iv)] (iii) the defendant's participation in judicial diversion could~~

34 ~~of the diagnostic and statistical manual of mental disorders, or a clin-~~
35 ~~ical diagnosis of another serious functional impairment there shall be a~~
36 ~~presumption that the defendant is an eligible defendant.~~

37 4. ~~(a)~~ When an authorized court determines, pursuant to paragraph (b)
38 of subdivision three of this section, that an eligible defendant should
39 be offered [~~alcohol or substance abuse~~] treatment, or when the parties
40 and the court agree to [~~an eligible defendant's participation in alcohol~~
41 ~~or substance abuse~~] treatment, an eligible defendant [~~may~~] shall be
42 allowed to participate in the judicial diversion program offered by this
43 article. [~~Prior to the court's issuing an order granting judicial~~
44 ~~diversion, the eligible defendant shall be required to enter a plea of~~
45 ~~guilty to the charge or charges; provided, however, that no such guilty~~
46 ~~plea shall be required when:~~

47 ~~(a) the people and the court consent to the entry of such an order~~
48 ~~without a plea of guilty; or~~

49 ~~(b) based on a finding of exceptional circumstances, the court deter-~~
50 ~~mines that a plea of guilty shall not be required. For purposes of this~~

54 ~~(b) Eligible defendants shall not be required to submit a plea of~~
55 ~~guilty to participate in judicial diversion.~~

1 (c) Prior participation in treatment or court-mandated treatment shall
2 not preclude future treatment participation.

3 (d) Eligible defendants shall not be precluded from diversion because
4 of a lack of resources in the community.

5 (e) An eligible defendant shall not be precluded from diversion
6 because of their gender identity.

7 (f) There shall be a presumption that participants shall be afforded
8 the opportunity to remain at liberty while awaiting clinical evaluation
9 or treatment placement.

10 5. The [~~defendant~~] participant shall agree on the record or in writing
11 to abide by the [~~release~~] judicial diversion program conditions set by
12 the court, which[~~7~~] shall include[+] participation in a specified period
13 of [~~alcohol or substance abuse~~] treatment at a specified program or
14 programs [~~identified by the court, which may include periods of detoxi-~~
15 ~~fication~~]. In setting the program conditions, the court shall consider
16 the participant's assessment and treatment plan, as agreed upon by the
17 participant and treatment provider, in addition to the clinical evalu-
18 ation. The court shall not consider the nature of a participant's charg-
19 es. Judicial diversion program conditions may include:

20 (a) limited or intensive outpatient treatment in which the partic-
21 ipant, regardless of whether they have permanent housing or not, may
22 reside in the community;

23 (b) limited periods of detoxification or inpatient rehabilitation for
24 participants with substance use disorders, except that detoxification
25 shall not be used as a sanction and detoxification shall only be
26 required as preparation for a treatment admission or medication
27 induction;

28 (c) residential [~~or outpatient~~] treatment[~~, or both~~]. If ordering
29 residential treatment, placement shall be in the most integrated setting
30 appropriate for the participant's needs to avoid discrimination on the
31 basis of disability, in accordance with federal law, as determined after
32 taking into account the views of the health care professional who
33 conducted the mental health assessment or alcohol and substance abuse
34 evaluation and any health care professionals responsible for providing
35 such treatment or monitoring the defendant's progress in such treatment;

36 [~~and may include:~~

37 (i)] (d) periodic court appearances, which may [~~include periodic~~
38 urinalysis; (ii)] be an electronic appearance pursuant to section 182.20
39 of this chapter upon consent of the participant. The court shall consid-
40 er the participant's service engagement and treatment needs when sched-
41 uling periodic court appearances and shall attempt to minimize treatment
42 disruption;

43 (e) periodic drug screening as needed, when recommended by the treat-
44 ment provider as part of a participant's treatment plan. Drug screening
45 methods shall only include oral swabs, sweat patches, or non-observed
46 urinalysis;

47 (f) other treatment as recommended by the treatment provider; and

48 (g) a requirement that the [~~defendant~~] participant refrain from engag-
49 ing in criminal behaviors[+;

50 (iii) ~~if the defendant needs treatment for opioid abuse or~~
51 ~~dependence~~].

52 5-a. The court shall not require a participant to consent to share, or
53 authorize the treatment provider to share, protected health information
54 in accordance with the Health Insurance Portability and Accountability
55 Act Privacy Rule (45 CFR Parts 160 and 164), with the court. Exceptions
56 include:

1 (a) record of attendance and relevant barriers to attendance;
2 (b) treatment plan and any recommended changes to the plan during
3 participation in judicial diversion; and

4 (c) drug toxicology results, when part of the treatment plan.

5 5-b. If the participant has a condition requiring prescription medica-
6 tion, or has another condition requiring prescription medication, [~~that~~
7 ~~he or she~~] they may participate in and receive medically prescribed drug
8 treatments under the care of a health care professional licensed or
9 certified under title eight of the education law, acting within his or
10 her lawful scope of practice[~~, provided that no~~].

11 (a) No court shall require the use of any specified type or brand of
12 drug during the course of medically prescribed [~~drug~~] treatments.

13 (b) No court shall penalize or sanction a participant for periods of
14 voluntary hospitalization, respite care, or other forms of supportive
15 care.

16 5-c. Treatment providers shall collaborate with the participant and
17 clinical court staff to create a discharge plan prior to completion of
18 diversion to incorporate peer support, housing and employment support,
19 and how to access other community-based health services. If a partic-
20 ipant finishes their inpatient or outpatient treatment course, they
21 shall be considered to have successfully completed their obligation to
22 the court, regardless of their ability to secure permanent housing,
23 employment, or other personal goals identified by the participant.

24 6. Upon [~~an eligible defendant's~~] a participant's agreement to abide
25 by the conditions set by the court, the court shall issue a securing
26 order providing for bail or release on the [~~defendant's~~] participant's
27 own recognizance and conditioning any release upon the agreed upon
28 conditions pursuant to article five hundred ten of this chapter. The
29 period of [~~alcohol or substance abuse~~] treatment shall begin as speci-
30 fied by the court and as soon as practicable after the [~~defendant's~~]
31 participant's release, taking into account the availability of treat-
32 ment, so as to facilitate early intervention with respect to the
33 [~~defendant's abuse or condition~~] participant's functional impairment and
34 the effectiveness of the treatment program. In the event that a treat-
35 ment program is not immediately available or becomes unavailable during
36 the course of the [~~defendant's participation~~] participant's involvement
37 in the judicial diversion program, the court may release the [~~defendant~~]
38 participant pursuant to the securing order.

39 7. When participating in judicial diversion treatment pursuant to this
40 article, any resident of this state who is covered under a private
41 health insurance policy or contract issued for delivery in this state
42 pursuant to article thirty-two, forty-three or forty-seven of the insur-
43 ance law or article forty-four of the public health law, or who is
44 covered by a self-funded plan which provides coverage for the diagnosis
45 and treatment of [~~chemical abuse and chemical dependence~~] functional
46 impairment however defined in such policy; shall first seek reimburse-
47 ment for such treatment in accordance with the provisions of such policy
48 or contract. The court in its discretion may order the participant to
49 obtain public insurance such as Medicaid or Medicare if they so qualify.
50 However, the participant shall not be required to pay for any part of
51 the cost of treatment required by the court that is not covered by
52 private or public health insurance.

53 8. (a) During the period of a [~~defendant's participation~~] partic-
54 ipant's involvement in the judicial diversion program, the treatment
55 court shall retain jurisdiction of the [~~defendant~~] participant,
56 provided, however, that the court [~~may~~] shall allow such [~~defendant~~]

1 participant to (i) reside in another jurisdiction, [~~or~~] and/or (ii)
2 participate in [~~alcohol and substance abuse~~] treatment and other
3 programs in the jurisdiction where the defendant resides or in any other
4 jurisdiction, while participating in a judicial diversion program under
5 conditions set by the court and agreed to by the defendant pursuant to
6 subdivisions five and six of this section. The court may transfer the
7 participant's case to the judicial diversion court in the county in
8 which the participant resides pursuant to subdivision five of section
9 170.15 of this chapter, subdivision four of section 180.20 of this chap-
10 ter, or section 230.21 of this chapter to ensure continuity of treat-
11 ment.

12 (b) The court may require the [~~defendant~~] participant to appear in
13 court or remotely at any time to enable the court to monitor the
14 [~~defendant's~~] progress in [~~alcohol or substance abuse~~] treatment. The
15 court shall provide notice, reasonable under the circumstances, to the
16 people, the treatment provider, the [~~defendant~~] participant and the
17 [~~defendant's~~] participant's counsel whenever it orders or otherwise
18 requires the appearance of the [~~defendant~~] participant in court. Failure
19 to appear as required without reasonable cause therefor shall constitute
20 a violation of the conditions of the court's agreement with the [~~defend-~~
21 ~~ant~~] participant.

22 9. (a) If at any time during the [~~defendant's participation~~] partic-
23 ipant's engagement in the judicial diversion program, the court has
24 reasonable grounds to believe that the [~~defendant~~] participant has
25 violated a [~~release~~] program condition in an important respect or has
26 willfully failed to appear before the court as requested, the court
27 except as provided in subdivision two of section 510.50 of this chapter
28 regarding a failure to appear, shall direct the [~~defendant~~] participant
29 to appear [~~or issue a bench warrant to a police officer or an appropri-~~
30 ~~ate peace officer directing him or her to take the defendant into custo-~~
31 ~~dy and bring the defendant before the court without unnecessary delay,~~
32 ~~provided, however, that under no circumstances shall a defendant who~~
33 ~~requires treatment for opioid abuse or dependence be deemed to have~~
34 ~~violated a release condition on the basis of his or her participation in~~
35 ~~medically prescribed drug treatments under the care of a health care~~
36 ~~professional licensed or certified under title eight of the education~~
37 ~~law, acting within his or her lawful scope of practice] for a hearing on
38 the violation pursuant to paragraph (b) of this subdivision with at
39 least forty-eight hours notice to the participant or the participant's
40 counsel, unless notice is waived by the participant. The court may not
41 modify the participant's securing order until such time as the hearing's
42 conclusion. The relevant provisions of section 530.60 of this chapter
43 relating to issuance of securing orders shall apply to such proceedings
44 under this subdivision. There is a presumption that a bench warrant
45 shall not be issued for participants in judicial diversion.~~

46 (b) In determining whether a [~~defendant~~] participant violated a condi-
47 tion of [~~his or her release under~~] the judicial diversion program or
48 willfully failed to appear in court, the court [~~may~~] shall conduct a
49 [~~summary~~] hearing consistent with due process [~~and sufficient~~] to satis-
50 fy the court that the [~~defendant~~] participant has, in fact, violated the
51 condition or willfully failed to appear.

52 (i) The court shall provide reasonable notice to the participant and
53 the participant's counsel, but in no circumstance less than forty-eight
54 hours notice, unless notice is waived by the participant.

55 (ii) The people shall bear the burden of proving by clear and convinc-
56 ing evidence that the participant has violated a condition of the judi-

1 cial diversion program in an important respect. The participant may
2 cross-examine witnesses and may present relevant, admissible evidence on
3 their own behalf. The court shall consider all factors relating to the
4 participant's current mental health or cognitive status, their engage-
5 ment with judicial diversion prior to this time, as well as any other
6 factors that may have impacted their participation or alleged violation.

7 (iii) A bench warrant shall not be issued absent a finding by the
8 court that the alleged violation or failure to appear was willful. In
9 determining willfulness, the court shall consider: the nexus between the
10 participant's violation or failure to appear and their functional
11 impairment; whether an appropriate treatment plan is currently in place;
12 the participant's history of making court appearances in the instant
13 matter; and a history of positive engagement with treatment staff or the
14 court.

15 (iv) Under no circumstances shall a participant who requires treatment
16 for a functional impairment be deemed to have violated a program
17 condition on the participation in medically prescribed drug treat-
18 ments under the care of a health care professional licensed or certified
19 under title eight of the education law, acting within his or her lawful
20 scope of practice.

21 (v) If the court finds a reasonable explanation or mitigation for any
22 alleged violation or alleged willful failure to appear, the securing
23 order shall not be modified.

24 (vi) The court may seal portions of the proceeding related to collat-
25 eral consequences at the request of the participant and participant's
26 counsel.

27 (c) If the court determines by clear and convincing evidence that the
28 [~~defendant~~ participant] has violated a condition of his or her release
29 under the judicial diversion program, the court may permit the partic-
30 ipant to continue their treatment mandate as previously ordered; modify
31 the [~~conditions thereof, reconsider the order of recognizance or bail~~
32 ~~pursuant to subdivision two of section 510.30 of this chapter,~~] treat-
33 ment plan per the recommendation of the treatment provider; hold treat-
34 ment in abeyance until the underlying matter that caused the violation
35 is resolved; or terminate the [~~defendant's~~ participant's] participation
36 in the judicial diversion program[, ~~and when applicable proceed with the~~
37 ~~defendant's sentencing in accordance with the agreement. Notwithstanding~~
38 ~~any provision of law to the contrary, the court may impose any sentence~~
39 ~~authorized for the crime of conviction in accordance with the plea~~
40 ~~agreement, or any lesser sentence authorized to be imposed on a felony~~
41 ~~drug offender pursuant to paragraph (b) or (c) of subdivision two of~~
42 ~~section 70.70 of the penal law taking into account] if no other treat-
43 ment option is available. The court shall consider:~~

44 (i) the length of time the [~~defendant~~ participant] spent in residen-
45 tial treatment and how best to continue treatment [~~while the defendant~~
46 ~~is serving that sentence. In determining what action to take for a~~
47 ~~violation of a release condition, the court shall consider];~~

48 (ii) all relevant circumstances, including the views of the prosecu-
49 tor, the defense and the [~~alcohol or substance abuse~~ participant's
50 interest in continuing treatment [~~provider, and the extent to which~~
51 ~~persons who ultimately successfully complete a drug treatment regimen~~
52 ~~sometimes] or the program; and~~

53 (iii) the role of relapse [~~by not abstaining from alcohol or substance~~
54 ~~abuse or by failing to comply fully with all requirements imposed by a~~
55 ~~treatment program] in recovery and treatment.~~

1 (d) The court shall [~~also consider using~~] use a system of graduated
2 and appropriate responses [~~or sanctions~~] designed to address such inap-
3 propriate behaviors[, ~~protect public safety~~] and facilitate, where
4 possible, successful completion of the [~~alcohol or substance abuse~~]
5 treatment program.

6 [~~(d)~~] (e) Nothing in this subdivision shall be construed [~~as prevent-~~
7 ~~ing a court from terminating a defendant's participation in the judicial~~

7 in their work, such judges and diversion court personnel shall receive

§ 11. Paragraph (r) of subdivision 2 of section 212 of the judiciary law, as added by section 15 of part AAA of chapter 56 of the laws of 2009, is amended to read as follows:

(r) Ensure that cases eligible for judicial diversion pursuant to article two hundred sixteen of the criminal procedure law shall be assigned to court parts in the manner provided by the chief administrator and that, to the extent practicable, such cases are presided over by judges who, by virtue of the structure, caseload and resources of the parts and the judges' training, are in the best position to provide effective supervision over such cases, such as the [~~drug~~] treatment courts.
