AN ACT to amend the public service law, the general business law and the public authorities law, in relation to third party notification

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

- Section 1. Section 40 of the public service law, as amended by chapter 631 of the laws of 1992, is amended to read as follows:
- § 40. Voluntary third-party [notice prior to termination of service] 4 notification. 1. Every utility corporation or municipality shall permit 5 a residential customer to designate a third-party to receive notice of 6 the total amount due or past due on all bills, the amounts of any payments paid by or on behalf of such residential customer, and copies 8 of all notices relating to termination of service [ex] and notices 9 relating to collection of amounts due sent to such residential customer, 10 provided that the designated third-party indicates in writing a willing-11 ness to receive such notices.
- 2. Every utility corporation or municipality shall permit a landlord, 12 13 upon written request of both the landlord and tenant, to designate a third-party to be notified of all requests for discontinuance of service 14 to units owned by such landlord.
- § 2. The general business law is amended by adding a new section 393-f 16 17 to read as follows:
- § 393-f. Voluntary third-party notification. 1. Every telegraph or 18 19 telephone corporation, cable television corporation, cellular phone 20 company, or municipality shall permit a residential customer to desig-

nate a third-party to receive notice of the total amount due or past due on all bills, the amounts of any payments paid by or on behalf of such residential customer, and copies of all notices relating to termination of service and notices relating to collection of amounts due sent to such residential customer, provided that the designated third-party indicates in writing a willingness to receive such notices.

- 2. Every telegraph or telephone corporation, cable television corporation, cellular phone company, or municipality shall permit a landlord, upon written request of both the landlord and tenant, to designate a third-party to be notified of all requests for discontinuance of service to units owned by such landlord.
- 12 § 3. Section 1020-f of the public authorities law, as added by chapter 13 517 of the laws of 1986, is amended by adding a new subdivision (jj) to 14 read as follows:
- 15 (jj) The authority and its service provider shall permit a residential 16 customer to designate a third-party to receive notice of the total 17 amount due or past due on all bills, the amounts of any payments paid by or on behalf of such residential customers, and copies of all notices 18 relating to termination of service and notices relating to collection of 19 20 amounts due sent to such residential customer, provided that the desig-21 nated third-party indicates in writing a willingness to receive such 22 notices.
- \S 4. This act shall take effect on the ninetieth day after it shall 24 have become a law.
