AN ACT to amend the banking law, in relation to requiring all banks and credit unions to have a notary public available during business hours

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. The banking law is amended by adding a new section 6-o to
2 read as follows:

3 § 6-o. Notary publics; required. Every banking institution and every
4 credit union shall have a person qualified as a notary public in this
5 state on staff and available on the premises of each facility of such
6 bank or credit union during regular business hours. Such banking organ-
7 ization and credit union shall have the option to charge a nominal fee,
8 not to exceed any fee established in law, for any notary services
9 provided.

10 § 2. This act shall take effect on the ninetieth day after it shall
11 have become a law.
