AN ACT to amend the vehicle and traffic law, in relation to designating human organ delivery vehicles as authorized emergency vehicles

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

- 12 § 114-b. Emergency operation. The operation, or parking, of an author-13 ized emergency vehicle, when such vehicle is engaged in transporting a
- .3 ized emergency vehicle, when such vehicle is engaged in transporting a .4 sick or injured person, transporting prisoners, delivering blood or
- 14 sick of injured person, transporting prisoners, delivering brood of 15 blood products in a situation involving an imminent health risk, <u>trans-</u>
- 16 porting human organs, human tissue or medical personnel for the purpose
- 17 of organ recovery or transplantation in a situation involving an immi-
- 18 nent health risk, pursuing an actual or suspected violator of the law,
- 19 or responding to, or working or assisting at the scene of an accident,

1 § 117-e. Human organ delivery vehicle. Any vehicle which is operated by or on behalf of an organ procurement organization, as defined in subdivision five of section four thousand three hundred sixty of the public health law, for the sole purpose of transporting human organs, human tissue, or medical personnel for the purpose of organ recovery or transplantation on an emergency basis. No human organ delivery vehicle shall be operated as an authorized emergency vehicle engaged in an emergency operation unless the driver of such vehicle has undergone appropriate training for the operation of authorized emergency vehicles during emergency operations.

§ 4. This act shall take effect immediately.
