AN ACT to amend the penal law, in relation to assault in the second degree upon a supervisory member of a transit system

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Subdivision 11 of section 120.05 of the penal law, as separately amended by chapters 268 and 281 of the laws of 2016, is amended to read as follows:

2 11. With intent to cause physical injury to a train operator, ticket
3 inspector, conductor, signalperson, bus operator, station agent, station
4 cleaner ~~[or]~~, terminal cleaner or supervisory personnel employed by any
5 transit agency, authority or company, public or private, whose operation
6 is authorized by New York state or any of its political subdivisions, a
7 city marshal, a school crossing guard appointed pursuant to section two
8 hundred eight-a of the general municipal law, a traffic enforcement
9 officer, traffic enforcement agent, prosecutor as defined in subdivision
10 thirty-one of section 1.20 of the criminal procedure law, sanitation
11 enforcement agent, New York city sanitation worker, public health sani-
12 tarian, New York city public health sanitarian, registered nurse,
13 licensed practical nurse, emergency medical service paramedic, or emer-
14 gency medical service technician, he or she causes physical injury to
15 such train operator, ticket inspector, conductor, signalperson, bus
16 operator, station agent, station cleaner ~~[or]~~, terminal cleaner, or
17 supervisory personnel, city marshal, school crossing guard appointed
18 pursuant to section two hundred eight-a of the general municipal law,
19 traffic enforcement officer, traffic enforcement agent, prosecutor as
