Introduced by Sens. SALAZAR, BENJAMIN, BRISPORT, HOYLMAN, JACKSON, MYRIE, PARKER, SEPULVEDA -- read twice and ordered printed, and when printed to be committed to the Committee on Codes

AN ACT to amend the civil practice law and rules, the executive law, the vehicle and traffic law, the village law and the state finance law, in relation to eliminating court surcharges and fees; and to repeal certain provisions of the penal law, the vehicle and traffic law, the parks, recreation and historic preservation law, the executive law and the environmental conservation law relating thereto (Part A); to amend the penal law and the vehicle and traffic law, in relation to prohibiting mandatory minimum fines for penal law and vehicle and traffic offenses (Part B); to amend the penal law and the vehicle and traffic law, in relation to mandating that courts engage in an individualized assessment of a person's financial ability to pay a fine prior to imposing a fine (Part C); to amend the criminal procedure law, in relation to eliminating the availability of incarceration as a remedy for a failure to pay a fine, surcharge or fee, lifting and vacating all existing warrants issued solely based on a person's failure to timely pay a fine, surcharge or fee and ending all existing sentences of incarceration based on such failure; and to repeal certain provisions of the criminal procedure law relating thereto (Part D); in relation to vacating all existing unsatisfied civil judgments entered solely based on a person's failure to timely pay a surcharge or fee and to repeal certain provisions of the criminal procedure law relating thereto (Part E); to amend the criminal procedure law, in relation to prohibiting the collection of a fine, restitution or reparation from the funds of an incarcerated person; and to amend the correction law, in relation to prohibiting the payment of court fines, mandatory surcharges, certain fees, restitution, reparation or forfeitures from the earnings of prisoners (Part F); to amend the correction law, in relation to eliminating the requirement that a parolee or releasee receiving a merit termination of sentence be financially able to comply with an order of restitution; and to amend the executive law, in relation to eliminating the requirement that a person receiving a

discharge of sentence be financially able to comply with an order of restitution and the payment of certain surcharges or fees (Part G); and in relation to vacating all existing unpaid surcharges, DNA data-bank fees, crime victim assistance fees, sexual offender registration fees, or supplemental sex offender victim fees; and to repeal subdivision 3 of section 420.30 of the criminal procedure law relating to restrictions on remitting such fees (Part H)

**The People of the State of New York, represented in Senate and Assembly, do enact as follows:**

1 Section 1. This act enacts into law major components of legislation  
2 relating to ending the unfair financial burdens imposed on defendants in  
3 criminal, vehicle and traffic, or other types of criminal or quasi-crim-  
4 inal matters by the existence of mandatory court surcharges and fees  
5 and mandatory minimum fines. This act further enacts into law procedures  
6 by which courts would be required to engage in an individualized assess-  
7 ment of a person's financial ability to pay a fine prior to imposing a  
8 fine, eliminates the availability of incarceration as a remedy for a  
9 failure to pay a fine, and vacates all existing warrants or unsatisfied  
10 civil judgments issued solely based on a person's failure to timely pay  
11 a fine, surcharge, or fee. Each component is wholly contained within a  
12 Part identified as Parts A through H. The effective date for each  
13 particular provision contained within such Part is set forth in the last  
14 section of such Part. Any provision in any section contained within a  
15 Part, including the effective date of the Part, which makes reference to  
16 a section "of this act", when used in connection with that particular  
17 component, shall be deemed to mean and refer to the corresponding  
18 section of the Part in which it is found. Section four of this act sets  
19 forth the general effective date of this act.

20 § 2. Legislative intent. The legislative intent of this act is to end  
21 the inequitable financial burdens placed on defendants by the previously  
22 enacted statutory provisions which have authorized or mandated the impo-  
23 sition of surcharges, fees, and/or mandatory minimum fines, which have  
24 had a disparate impact on poor defendants, people of color, and those  
25 who lack access to the significant financial resources necessary in  
26 order to satisfy the imposition of surcharges, fees, and fines, and  
27 which have also contributed to mass incarceration in New York state. The  
28 legislative intent is also to end New York's regressive reliance on  
29 generating governmental revenue by imposing surcharges, fees, and fines  
30 on those least able to pay.

1 § 10. Subdivision (f) of section 1101 of the civil practice law and  
2 rules, as added by section 1 of part D of chapter 412 of the laws of  
3 1999, subparagraph (i) of paragraph 1 and paragraph 3 as amended by  
4 section 51 of subpart B of part C of chapter 62 of the laws of 2011, is  
5 amended to read as follows:

6 (f) Fees for inmates. 1. Notwithstanding any other provision of law to  
7 the contrary, a federal, state or local inmate under sentence for  
8 conviction of a crime may seek to commence his or her action or proceed-  
9 ing by paying a reduced filing fee as provided in paragraph two of this  
10 subdivision. Such inmate shall file the form affidavit referred to in  
11 subdivision (d) of this section along with the summons and complaint or  
12 summons with notice or third-party summons and complaint or petition or  
13 notice of petition or order to show cause. As part of such application,  
14 the inmate shall indicate the name and mailing address of the facility  
15 at which he or she is confined along with the name and mailing address  
16 of any other federal, state or local facility at which he or she was  
17 confined during the preceding six month period. The case will be given  
18 an index number if applicable, or, in courts other than the supreme or  
19 county courts, any necessary filing number and the application will be  
20 submitted to a judge of the court. Upon receipt of the application, the  
21 court shall obtain from the appropriate official of the facility at  
22 which the inmate is confined a certified copy of the inmate's trust fund  
23 account statement (or institutional equivalent) for the six month period  
24 preceding filing of the inmate's application. If the inmate has been  
25 confined for less than six months at such facility, the court shall  
26 obtain additional information as follows:

27 (i) in the case of a state inmate who has been transferred from another  
28 state correctional facility, the court shall obtain a trust fund  
29 account statement for the six month period from the central office of  
30 the department of corrections and community supervision in Albany; or

31 (ii) in the case of a state inmate who is newly transferred from a  
32 federal or local correctional facility, the court shall obtain any trust  
33 fund account statement currently available from such facility. The court  
34 may, in its discretion, seek further information from the prior or  
35 current facility.

36 2. If the court determines that the inmate has insufficient means to  
37 pay the full filing fee, the court may permit the inmate to pay a  
38 reduced filing fee, the minimum of which shall not be less than fifteen  
39 dollars and the maximum of which shall not be more than fifty dollars.  
40 The court shall require an initial payment of such portion of the  
41 reduced filing fee as the inmate can reasonably afford or shall author-  
42 ize no initial payment of the fee if exceptional circumstances render  
43 the inmate unable to pay any fee; provided however, that the difference  
44 between the amount of the reduced filing fee and the amount paid by the  
45 inmate in the initial partial payment shall be assessed against the  
46 inmate as an outstanding obligation to be collected either by the super-  
47 intendent or the municipal official of the facility at which the inmate  
48 is confined, as the case may be, ~~in the same manner that mandatory~~  
49 ~~surcharges are collected as provided for in subdivision five of section~~  
50 ~~60.35 of the penal law].~~ The court shall notify the superintendent or  
51 the municipal official of the facility where the inmate is housed of the  
52 amount of the reduced filing fee that was not directed to be paid by the  
53 inmate. Thereafter, the superintendent or the municipal official shall  
54 forward to the court any fee obligations that have been collected,  
55 provided however, that:

1 (i) in no event shall the filing fee collected exceed the amount of  
2 fees required for the commencement of an action or proceeding; and

3 (ii) in no event shall an inmate be prohibited from proceeding for the  
4 reason that the inmate has no assets and no means by which to pay the  
5 initial partial filing fee.

6 3. The institution at which an inmate is confined, or the central  
7 office for the department of corrections and community supervision,  
8 whichever is applicable, shall promptly provide the trust fund account  
9 statement to the inmate as required by this subdivision.

10 4. Whenever any federal, state or local inmate obtains a judgment in  
11 connection with any action or proceeding which exceeds the amount of the  
12 filing fee, paid in accordance with the provisions of this subdivision  
13 for commencing such action or proceeding, the court shall award to the  
14 prevailing inmate, as a taxable disbursement, the actual amount of any  
15 fee paid to commence the action or proceeding.

16 5. The provisions of this subdivision shall not apply to a proceeding  
17 commenced pursuant to article seventy-eight of this chapter which  
18 alleges a failure to correctly award or certify jail time credit due an  
19 inmate, in violation of section six hundred-a of the correction law and  
20 section 70.30 of the penal law.

21 § 11. Paragraph (a) of subdivision 2 of section 259-i of the executive  
22 law, as amended by section 38-f-1 of subpart A of part C of chapter 62  
23 of the laws of 2011, is amended to read as follows:

24 (a) (i) Except as provided in subparagraph (ii) of this paragraph, at  
25 least one month prior to the date on which an inmate may be paroled  
26 pursuant to subdivision one of section 70.40 of the penal law, a member  
27 or members as determined by the rules of the board shall personally  
28 interview such inmate and determine whether he should be paroled in  
29 accordance with the guidelines adopted pursuant to subdivision four of  
30 section two hundred fifty-nine-c of this article. If parole is not  
31 granted upon such review, the inmate shall be informed in writing within  
32 two weeks of such appearance of the factors and reasons for such denial  
33 of parole. Such reasons shall be given in detail and not in conclusory  
34 terms. The board shall specify a date not more than twenty-four months  
35 from such determination for reconsideration, and the procedures to be  
36 followed upon reconsideration shall be the same. If the inmate is  
37 released, he shall be given a copy of the conditions of parole. Such  
38 conditions shall where appropriate, include a requirement that the paro-  
39 lee comply with any restitution order, mandatory surcharge, sex offender  
40 registration fee and DNA databank fee previously imposed by a court of  
41 competent jurisdiction that applies to the parolee. The conditions shall  
42 indicate which restitution collection agency established under subdivi-  
43 sion eight of section 420.10 of the criminal procedure law, shall be  
44 responsible for collection of restitution[, ~~mandatory surcharge, sex  
45 offender registration fees and DNA databank fees as provided for in  
46 section 60.35 of the penal law and section eighteen hundred nine of the  
47 vehicle and traffic law~~].

48 (ii) Any inmate who is scheduled for presumptive release pursuant to  
49 section eight hundred six of the correction law shall not appear before  
50 the board as provided in subparagraph (i) of this paragraph unless such  
51 inmate's scheduled presumptive release is forfeited, canceled, or  
52 rescinded subsequently as provided in such law. In such event, the  
53 inmate shall appear before the board for release consideration as  
54 provided in subparagraph (i) of this paragraph as soon thereafter as is  
55 practicable.

1 § 12. Paragraph (a) of subdivision 2 of section 259-i of the executive  
2 law, as amended by section 38-f-2 of subpart A of part C of chapter 62  
3 of the laws of 2011, is amended to read as follows:

4 (a) At least one month prior to the expiration of the minimum period  
5 or periods of imprisonment fixed by the court or board, a member or  
6 members as determined by the rules of the board shall personally inter-  
7 view an inmate serving an indeterminate sentence and determine whether  
8 he should be paroled at the expiration of the minimum period or periods  
9 in accordance with the procedures adopted pursuant to subdivision four  
10 of section two hundred fifty-nine-c of this article. If parole is not  
11 granted upon such review, the inmate shall be informed in writing within  
12 two weeks of such appearance of the factors and reasons for such denial  
13 of parole. Such reasons shall be given in detail and not in conclusory  
14 terms. The board shall specify a date not more than twenty-four months  
15 from such determination for reconsideration, and the procedures to be  
16 followed upon reconsideration shall be the same. If the inmate is  
17 released, he shall be given a copy of the conditions of parole. Such  
18 conditions shall where appropriate, include a requirement that the paro-  
19 lee comply with any restitution order and mandatory surcharge previously  
20 imposed by a court of competent jurisdiction that applies to the paro-  
21 lee. The conditions shall indicate which restitution collection agency  
22 established under subdivision eight of section 420.10 of the criminal  
23 procedure law, shall be responsible for collection of restitution [~~and~~  
24 ~~mandatory surcharge as provided for in section 60.35 of the penal law~~  
25 ~~and section eighteen hundred nine of the vehicle and traffic law~~].

26 § 13. Subdivision 5 of section 27.12 of the parks, recreation and  
27 historic preservation law is REPEALED and subdivision 6 is renumbered  
28 subdivision 5.

29 § 14. Subdivision 4 of section 60.02 of the penal law is renumbered  
30 subdivision 3.

31 § 15. Subparagraph (i) of paragraph (j-1) of subdivision 2 of section  
32 503 of the vehicle and traffic law, as amended by section 3 of part PP  
33 of chapter 59 of the laws of 2009, is amended to read as follows:

34 (i) When a license issued pursuant to this article, or a privilege of  
35 operating a motor vehicle or of obtaining such a license, has been  
36 suspended based upon a failure to answer an appearance ticket or a  
37 summons or failure to pay a fine, penalty or mandatory surcharge, pursu-  
38 ant to subdivision three of section two hundred twenty-six, subdivision  
39 four of section two hundred twenty-seven, or subdivision four-a of  
40 section five hundred ten [~~or subdivision five a of section eighteen~~  
41 ~~hundred nine~~] of this chapter, such suspension shall remain in effect  
42 until a termination of a suspension fee of seventy dollars is paid to  
43 the court or tribunal that initiated the suspension of such license or  
44 privilege. In no event may the aggregate of the fees imposed by an indi-  
45 vidual court pursuant to this paragraph for the termination of all  
46 suspensions that may be terminated as a result of a person's answers,  
47 appearances or payments made in such cases pending before such individ-  
48 ual court exceed four hundred dollars. For the purposes of this para-  
49 graph, the various locations of the administrative tribunal established  
50 under article two-A of this chapter shall be considered an individual  
51 court.

52 § 16. Section 4-411 of the village law, as amended by section 12 of  
53 part F of chapter 62 of the laws of 2003, is amended to read as follows:

54 § 4-411 Disposition of fines and penalties. Except as otherwise  
55 provided by law, all fines and penalties imposed for the violation of a  
56 village local law, ordinance or regulation shall be the property of the

1 village, whether or not the village has established the office of  
2 village justice. [~~Nothing in this section shall be deemed to affect the~~  
3 ~~disposition of mandatory surcharges, sex offender registration fees, DNA~~  
4 ~~databank fees or crime victim assistance fees as provided by section~~  
5 ~~60.35 of the penal law, or of mandatory surcharges as provided by~~  
6 ~~section eighteen hundred nine of the vehicle and traffic law, or of~~  
7 ~~finest, penalties and forfeitures as provided by section eighteen hundred~~  
8 ~~three of the vehicle and traffic law relating to traffic offenses.]~~

9 § 17. Subdivision 2 of section 837-i of the executive law, as added by  
10 chapter 166 of the laws of 1991, is amended to read as follows:

11 2. The commissioner in consultation with the chief executive officers  
12 of cities with a population in excess of one hundred thousand persons  
13 according to the nineteen hundred eighty United States census shall  
14 establish a system to record and monitor the issuance and disposition of  
15 parking tickets[~~, to monitor the collection of the mandatory surcharge~~  
16 ~~required by section eighteen hundred nine-a of the vehicle and traffic~~  
17 ~~law]~~ and to receive information from cities for this purpose. Each such  
18 city shall report on such parking violations on a monthly basis in the

28 1. The commissioner, in cooperation with the commissioner of the  
29 department of motor vehicles, and in consultation with the chief execu-  
30 tive officers of cities with a population in excess of one hundred thou-  
31 sand persons according to the nineteen hundred eighty United States  
32 census shall prescribe the form and content of uniform parking tickets  
33 for such cities in all cases involving a parking, standing or stopping  
34 violation as defined in accordance with the vehicle and traffic law,  
35 hereinafter referred to as parking violations, or of any local law,  
36 ordinance, rule or regulation adopted pursuant to the vehicle and traf-  
37 fic law relating to parking violations. [~~Upon written application of the~~  
38 ~~chief executive officer of any such city, the commissioner, after~~  
39 ~~consultation with the commissioner of the department of motor vehicles,~~  
40 ~~may authorize the use of a parking ticket other than the uniform parking~~  
41 ~~ticket prescribed pursuant to this section if he or she determines that~~  
42 ~~use of such other parking ticket is not inconsistent with, and will not~~  
43 ~~diminish the effectiveness of, the parking violations enforcement and~~  
44 ~~disposition program established pursuant to section eight hundred thir-~~  
45 ~~ty-seven-j of this chapter, and may also authorize for a specified time~~  
46 ~~period the use of a parking ticket which was used by such city on or~~  
47 ~~before the effective date of this section.]~~

48 § 20. Clause (E) of subparagraph 2 of paragraph a of subdivision 2 of  
49 section 235 of the vehicle and traffic law, as amended by section 18 of  
50 part J of chapter 62 of the laws of 2003, is amended to read as follows:

51 (E) that submission of a plea of guilty to the parking violation makes  
52 the owner liable for payment of the stated fine and additional penalties  
53 imposed pursuant to paragraph b of this subdivision [~~and the mandatory~~  
54 ~~surcharge of fifteen dollars imposed upon parking violations pursuant to~~  
55 ~~section eighteen hundred nine-a of this chapter].~~

1 § 21. Subdivision 4 of section 1203-g of the vehicle and traffic law,  
2 as added by chapter 497 of the laws of 1999, is amended to read as  
3 follows:

4 4. Every county and the city of New York that establishes a hand-  
5 icapped parking education program shall establish a separate handicapped  
6 parking education fund in the custody of the chief fiscal officer of  
7 each such county or city, by April first, two thousand~~[, which shall~~  
8 ~~consist of moneys granted to such county or city pursuant to section~~  
9 ~~eighteen hundred nine-b of this chapter]~~. No provision of law shall be  
10 deemed to preclude a county or the city of New York from receiving funds  
11 ~~[from other sources]~~ to be deposited in the handicapped parking educa-  
12 tion fund, provided such funds are used in a manner and for purposes  
13 consistent with this section. The moneys of such fund shall be disbursed  
14 to provide education, advocacy and increased awareness of handicapped  
15 parking laws and may be used to execute contracts with private organiza-  
16 tions for such purposes. Such contracts shall be awarded upon compet-  
17 itive bids after the issuance of requests for proposal.

18 § 22. Subdivision 2 of section 99-n of the state finance law, as added  
19 by chapter 223 of the laws of 2005, is amended to read as follows:

20 2. The fund shall consist of all monies appropriated for its  
21 purpose~~[,]~~ and all monies required by this section or any other  
22 provision of law to be paid into or credited to such fund~~[, collected by~~  
23 ~~the mandatory surcharges imposed pursuant to subdivision one of section~~  
24 ~~eighteen hundred nine-d of the vehicle and traffic law]~~. Nothing  
25 contained in this section shall prevent the department of motor vehicles  
26 from receiving grants or other appropriations for the purposes of the  
27 fund as defined in this section and depositing them into the fund  
28 according to law.

29 § 23. This act shall take effect immediately; provided however that  
30 the amendments to subdivision (f) of section 1101 of the civil practice  
31 law and rules made by section ten of this act shall not affect the expi-  
32 ration of such section and shall be deemed to expire therewith; provided  
33 further, however, that the amendments to paragraph (a) of subdivision 2  
34 of section 259-i of the executive law made by section eleven of this act  
35 shall be subject to the expiration and reversion of such paragraph  
36 pursuant to subdivision d of section 74 of chapter 3 of the laws of  
37 1995, as amended, when upon such date the provisions of section twelve  
38 of this act shall take effect; and provided further however that the  
39 amendments to clause (E) of subparagraph 2 of paragraph a of subdivision  
40 2 of section 235 of the vehicle and traffic law made by section twenty  
41 of this act shall not affect the expiration of such section and shall  
42 expire therewith.

43 PART B

44 Section 1. The penal law is amended by adding a new section 80.20 to  
45 read as follows:

46 § 80.20 Mandatory minimum fines prohibited.  
47 Notwithstanding any other provision of law, no offense shall carry a  
48 mandatory minimum fine.

49 § 2. Section 1800 of the vehicle and traffic law is amended by adding  
50 a new subdivision (j) to read as follows:

51 (j) Notwithstanding any other provision of law, no offense described  
52 in this chapter shall carry a mandatory minimum fine.

53 § 3. This act shall take effect immediately.

## PART C

2 Section 1. Section 80.05 of the penal law is amended by adding a new  
3 subdivision 7 to to read as follows:

4 7. Individualized assessment. When imposing a fine pursuant to the  
5 provisions of this section, the court shall consider the profit gained  
6 by the defendant's conduct, whether the amount of the fine is dispropor-  
7 tionate to the conduct in which the defendant engaged, the impact on any  
8 victims, and the defendant's economic circumstances, including the  
9 defendant's ability to pay, the effect of the fine upon his or her imme-  
10 diate family or any other persons to whom the defendant owes an obli-  
11 gation of support. In addition, when imposing a fine the court shall  
12 establish such payment schedules as are fair and reasonable taking into  
13 consideration the defendant's economic circumstances.

14 § 2. The vehicle and traffic law is amended by adding a new section  
15 1811 to read as follows:

16 § 1811. Fines; individualized assessment. When imposing a fine pursu-  
17 ant to the provisions of this section, the court shall consider the  
18 profit gained by the defendant's conduct, whether the amount of the fine  
19 is disproportionate to the conduct in which the defendant engaged, the  
20 impact on any victims, and the defendant's economic circumstances,  
21 including the defendant's ability to pay, the effect of the fine upon  
22 his or her immediate family or any other persons to whom the defendant  
23 owes an obligation of support. In addition, when imposing a fine the  
24 court shall establish such payment schedules as are fair and reasonable  
25 taking into consideration the defendant's economic circumstances.

26 § 3. This act shall take effect immediately.

## PART D

28 Section 1. Subdivisions 3 and 4 of section 420.10 of the criminal  
29 procedure law are REPEALED.

30 § 2. Section 420.35 of the criminal procedure law is REPEALED.

31 § 3. Subdivision 5 of section 420.10 of the criminal procedure law, as  
32 separately amended by chapters 233 and 506 of the laws of 1985, the  
33 second undesignated paragraph as amended by chapter 618 of the laws of  
34 1992, is amended to read as follows:

35 5. Application for resentence. In any case where the defendant is  
36 unable to pay a fine, restitution or reparation imposed by the court, he  
37 may at any time apply to the court for resentence. In such case, if the  
38 court is satisfied that the defendant is unable to pay the fine, resti-  
39 tution or reparation it must:

40 (a) Adjust the terms of payment; or

41 (b) Lower the amount of the fine, restitution or reparation to an  
42 amount the defendant is able to pay, or revoke it entirely from the  
43 sentence if the defendant has no ability to pay; or

44 (c) [~~Where the sentence consists of probation or imprisonment and a~~  
45 ~~fine, restitution or reparation, revoke the portion of the sentence~~  
46 ~~imposing the fine, restitution or reparation; or~~

47 ~~(d)]~~ Revoke the entire sentence imposed and resentence the defendant.  
48 Upon such resentence the court may impose any sentence it originally  
49 could have imposed, except that the amount of any fine, restitution or  
50 reparation imposed may not be in excess of the amount the defendant is  
51 able to pay and that the court may not sentence the defendant to any  
52 term of imprisonment, probation, or post-release supervision in excess  
53 of any such term imposed by the original sentence.



1 In any case where the defendant applies for resentencing with respect

47 court date set for the sole purpose of payment of a surcharge, DNA data-

50 and, for all legal purposes, vacated and discharged.

12 1. Except where a determinate sentence was imposed for a felony other  
13 than a felony defined in article two hundred twenty or article two  
14 hundred twenty-one of the penal law, if the board of parole is satisfied  
15 that an absolute discharge from presumptive release, parole, conditional  
16 release or release to a period of post-release supervision is in the  
17 best interests of society, the board may grant such a discharge prior to  
18 the expiration of the full term or maximum term to any person who has  
19 been on unrevoked community supervision for at least three consecutive  
20 years. A discharge granted under this section shall constitute a termi-

1 Section 1. All orders issued prior to the effective date of this act  
2 directing payment by a defendant of a surcharge, DNA databank fee, crime  
3 victim assistance fee, sexual offender registration fee, or supplemental  
4 sex offender victim fee are deemed to be null and void and, such orders  
5 are for all legal purposes, vacated and discharged. Pursuant to this  
6 section, any existing encumbrances on commissary accounts or similar  
7 accounts held by a correctional facility, jail, or detention facility  
8 shall be lifted and deemed null and void.

9 § 2. This act shall take effect immediately.

10 § 3. Severability clause. If any clause, sentence, paragraph, subdivi-  
11 sion, section or part of this act shall be adjudged by any court of  
12 competent jurisdiction to be invalid, such judgment shall not affect,  
13 impair, or invalidate the remainder thereof, but shall be confined in  
14 its operation to the clause, sentence, paragraph, subdivision, section  
15 or part thereof directly involved in the controversy in which such judg-  
16 ment shall have been rendered. It is hereby declared to be the intent of  
17 the legislature that this act would have been enacted even if such
