AN ACT in relation to establishing the New York state aid and incentives for municipalities redesign task force; and providing for the repeal of such provisions upon expiration thereof

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. 1. New York state aid and incentives for municipalities  
2 redesign task force. There is hereby created the aid and incentives for  
3 municipalities redesign task force whose membership shall consist of 21  
4 members: the director of the division of the budget or his or her design-  
5 nee as chair; the comptroller or his or her designee; ten members  
6 appointed by the governor; the president of the New York State Confer-  
7 ence of Mayors or his or her designee; the executive director of the New  
8 York State Association of Counties or his or her designee; the executive  
9 director of the New York State Association of Towns or his or her design-  
10 nee; two members appointed by the temporary president of the senate; two  
11 members appointed by the speaker of the assembly; one member appointed  
12 by the minority leader of the senate; and one member appointed by the  
13 minority leader of the assembly. The task force shall report to the  
14 governor, the speaker of the assembly and the temporary president of the  
15 senate no later than one year after the effective date of this act.  
16 Such report shall include, but not be limited to:  
17 (a) A review and analysis of the current aid and incentives for muni-  
18 cipalities formula and allocations;  
19 (b) An analysis of available alternatives to the current aid and  
20 incentives for municipalities formula and allocations, including models  
21 from other states;  
22 (c) Recommendations concerning such alternatives to the formula used  
23 to determine future aid and incentives to municipalities funding allo-  
24 cations; and

1 (d) Any other information the task force deems necessary or relevant.  
2 2. All appointments to the task force shall be made no later than  
3 sixty days after the effective date of this act. Any vacancy shall be  
4 filled by the appointing authority. The task force shall meet as  
5 frequently as deemed necessary prior to issuing its findings and recom-  
6 mendations. The members of the task force shall serve without compen-  
7 sation, except that members shall be allowed their necessary and actual  
8 expenses incurred in the performance of their duties under this section.  
9 The division of budget shall provide the task force with such facili-  
10 ties, assistance, and data as will enable such task force to carry out  
11 its powers and duties within reason.  
12 § 2. This act shall take effect immediately and shall expire and be  
13 deemed repealed December 31, 2022.
