AN ACT to amend the vehicle and traffic law and the transportation law, in relation to establishing a commercial driver's license (CDL) class A young adult licensing pilot program

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Paragraphs (a) and (b) of subdivision 2 of section 502 of 1 2 the vehicle and traffic law, as amended by chapter 520 of the laws of 3 1991, are amended to read as follows: 4 (a) An applicant for a [class A license or for a] commercial driver's 5 license which contains an H or an X endorsement or which is valid for б operation in interstate commerce shall be at least twenty-one years of 7 age. 8 (b) Except as provided in paragraph (a) of this subdivision an appli-9 cant for a class A, B, C or E license shall be at least eighteen years 10 of age. § 2. Section 14 of the transportation law is amended by adding a new 11 12 subdivision 36 to read as follows: 13 36. (a) To promulgate, in consultation with the department of motor 14 vehicles, rules and regulations to establish and implement a commercial 15 driver's license (CDL) class A young adult licensing program. (i) Such rules and regulations shall be no less protective of public 16 safety than the rules and regulations promulgated by the federal govern-17 18 ment with respect to the training of entry-level commercial motor vehi-19 cle operators. The regulations shall set forth the criteria to be 20 included in the training program and shall be no less than the entry-21 level driver training requirements prescribed by the United States secretary of transportation under Appendices A, C, D and E to section 22 23 380 of title 49 of the United States code as amended from time to time.

12	moving violations for at least a one-year period, and (D) has a minimum
13	of one year of experience driving a commercial vehicle in commerce.
14	(c) Such pilot program shall provide qualified young adult drivers
15	<u>with a CDL class A driver's license.</u>
16	§ 3. This act shall be deemed repealed if any federal agency or any
17	court of competent jurisdiction determines that this act would render
18	New York state ineligible for the receipt of federal funds.
19	§ 4. Severability. If any clause, sentence, subdivision, paragraph,
20	section or part of this act be adjudged by any court of competent juris-
21	diction to be invalid, such judgment shall not affect, impair or invali-
22	date the remainder thereof, but shall be confined in its operation to
23	the clause, sentence, subdivision, paragraph, section or part thereof
24	directly involved in the controversy in which such judgment shall have
25	been rendered.
26	§ 5. This act shall take effect immediately; provided that the commis-
27	sioner of transportation shall notify the legislative bill drafting
28	commission upon the occurrence of the repeal of this act provided for in
29	section three of this act in order that the commission may maintain an
30	accurate and timely effective data base of the official text of the laws
31	of the state of New York in furtherance of effectuating the provisions
32	of section 44 of the legislative law and section 70-b of the public
33	officers law.
